THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 88R. (1) THE FUND MAY MAKE LOANS AND ENTER INTO
- 2 AGREEMENTS WITH EMPLOYERS OR ISSUE BONDS UNDER SECTION 23 WITH
- 3 RESPECT TO AN EMPLOYER THAT HAS ENTERED INTO AN AGREEMENT WITH THE
- 4 MICHIGAN ECONOMIC GROWTH AUTHORITY UNDER THE MICHIGAN ECONOMIC
- 5 GROWTH AUTHORITY ACT, 1995 PA 24, MCL 207.801 TO 207.810, FOR ANY
- 6 OF THE FOLLOWING PURPOSES:
- 7 (A) TRAINING OR RETRAINING FOR NEW JOBS.
- 8 (B) ADULT BASIC EDUCATION AND JOB-RELATED INSTRUCTION.
- 9 (C) DEVELOPMENTAL, READINESS, AND REMEDIAL EDUCATION.
- 10 (D) VOCATIONAL AND SKILL-ASSESSMENT SERVICES AND TESTING.
- 11 (E) TRAINING FACILITIES, EQUIPMENT, MATERIALS, AND SUPPLIES.

- 1 (F) ADMINISTRATIVE EXPENSES FOR THE NEW JOBS TRAINING PROGRAM.
- 2 (G) SUBCONTRACTED SERVICES WITH PUBLIC UNIVERSITIES AND
- 3 COLLEGES IN THIS STATE, PRIVATE COLLEGES OR UNIVERSITIES, OR ANY
- 4 FEDERAL, STATE, OR LOCAL DEPARTMENTS OR AGENCIES.

- 11 206.351, 206.355, 206.365, AND 206.366, SHALL BE PLEDGED TO FINANCE
- 12 THE COST OF PROVIDING SERVICES UNDER SUBSECTION (1).
- 13 (4) THE AGGREGATE OUTSTANDING OBLIGATION OF ALL AGREEMENTS
- 14 ENTERED INTO BY THE FUND WITH EMPLOYERS UNDER THIS SECTION SHALL
- 15 NOT EXCEED \$10,000,000.00 IN ANY CALENDAR YEAR.
 - [(5) THE LEGISLATURE SHALL APPROPRIATE SUFFICIENT FUNDS FROM THE GENERAL FUND TO THE STATE SCHOOL AID FUND TO FULLY COMPENSATE FOR ANY LOSS OF REVENUE TO THE STATE SCHOOL AID FUND RESULTING FROM THE ENACTMENT OF THIS LEGISLATION.

Enacting section 1. This amendatory act does not take effect unless both House Bill No. 6185 and Senate Bill No. 1342 of the 94th Legislature are enacted into law.]
