HOUSE BILL No. 6172

May 22, 2008, Introduced by Reps. Hopgood, Alma Smith, Kathleen Law, Byrnes, Huizenga, Meisner, LaJoy, Vagnozzi, Condino, Bieda, Donigan, Tobocman, Dean and Meadows and referred to the Committee on New Economy and Quality of Life.

A bill to create an Asian Pacific American affairs commission, an office of Asian Pacific American affairs, and an interagency council on Asian Pacific American affairs; to prescribe their powers and duties; and to prescribe the powers and duties of certain agencies, departments, and officials.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. This act shall be known and may be cited as the "Asian Pacific American affairs commission act".

Sec. 3. As used in this act:

(a) "Asian Pacific American" means a person who has origins in any of the original peoples of the far east, southeast Asia, the Indian subcontinent, or the Pacific islands; is identified by an employer in an EEO-1 report as Asian or Pacific islander; or is

- 4 (b) "Commission" means the Asian Pacific American affairs
- 5 commission created in section 5.
- 6 (c) "Department" means the department of <<civil rights energy, labor, and economic growth>>.
- 7 (d) "Director" means the director of the office of Asian
- 8 Pacific American affairs.
- 9 (e) "Office" means the office of Asian Pacific American
- 10 affairs created in section 13.
- 11 Sec. 5. (1) The Asian Pacific American affairs commission is
- created within the department of <<<u>civil rights</u> energy, labor, and economic growth>>. The commission shall
- 13 exercise its powers and duties independently of the department
- 14 except for budget, procurement, and housekeeping functions. The
- 15 commission shall consist of 15 members to be appointed by the
- 16 governor with the advice and consent of the senate. The commission
- 17 shall elect a chairperson and vice-chairperson annually and shall
- 18 elect other officers from its members as the commission considers
- **19** appropriate.
- 20 (2) Members of the commission shall be individuals who have a
- 21 particular interest or expertise in Asian or Pacific American
- 22 concerns.
- 23 (3) Members of the commission shall serve for a term of 3
- 24 years or until a successor is appointed, whichever is later, except
- 25 that of the members first appointed, 5 shall serve for 3 years, 5
- 26 shall serve for 2 years, and 5 shall serve for 1 year.
- 27 (4) If a vacancy occurs on the commission, the governor shall

- 1 make an appointment for the balance of the unexpired term in the
- 2 same manner as the original appointment.
- 3 (5) The governor shall appoint the commission within 90 days
- 4 after the effective date of this act.
- 5 Sec. 7. (1) Within 90 days after appointment and confirmation
- 6 of all members, the commission shall adopt bylaws for the operation
- 7 of the commission. The bylaws shall include, at a minimum, voting
- 8 procedures and minimum requirements for attendance at meetings.
- 9 (2) The commission shall hold regular quarterly meetings at
- 10 places and on dates as determined by the commission. Special
- 11 meetings may be called by the chairperson or by not fewer than 8
- 12 commission members on 3 business days' actual notice.
- 13 (3) A majority of the commission members appointed and serving
- 14 constitute a quorum for the transaction of business at a meeting of
- 15 the commission. Official action by the commission shall be only by
- 16 affirmative vote of a majority of the commission members appointed
- 17 and serving. A commission member shall not vote by proxy.
- 18 (4) The legislature annually shall fix the per diem
- 19 compensation of members of the commission. Expenses of members
- 20 incurred in the performance of official duties shall be reimbursed
- 21 as provided by law for state employees.
- 22 (5) The department shall furnish administrative services to
- 23 the commission and shall provide secretarial and other staff
- 24 necessary to allow the proper exercise of the powers and duties of
- 25 the commission. The department shall provide adequate office space
- 26 to the commission. The department shall make available the times
- 27 and places of commission meetings and keep minutes of the meetings

- 1 and a record of the actions of the commission.
- 2 (6) The department shall assign professional employees to
- 3 staff the commission to assist the commission in the performance of
- 4 its substantive responsibilities under this act.
- 5 Sec. 9. (1) A meeting of the commission shall be held pursuant
- 6 to the open meetings act, 1976 PA 267, MCL 15.261 to 15.275.
- 7 (2) A writing prepared, owned, used, in the possession of, or
- 8 retained by the commission or office in the performance of an
- 9 official function shall be made available to the public pursuant to
- 10 the freedom of information act, 1976 PA 442, MCL 15.231 to 15.246.
- 11 Sec. 11. The commission shall do all of the following:
- 12 (a) Stimulate and encourage the study and review of the status
- 13 of Asian Pacific Americans in this state.
- 14 (b) Develop a unified policy and plan of action to serve the
- 15 needs of Asian Pacific Americans in this state.
- 16 (c) Advise the governor, the legislature, and the office
- 17 concerning the coordination and administration of state programs
- 18 serving Asian Pacific Americans.
- 19 (d) Make recommendations to the governor and legislature
- 20 regarding changes in state programs, statutes, and policies.
- 21 (e) Advise the governor and legislature of the nature,
- 22 magnitude, and priorities of the problems of Asian Pacific
- 23 Americans in this state.
- 24 (f) Review and advise the governor and the legislature on this
- 25 state's policies concerning Asian Pacific American affairs.
- 26 (g) Secure appropriate recognition of Asian Pacific American
- 27 accomplishments and contributions to this state.

- 1 (h) Review and approve the annual report by the office of
- 2 Asian Pacific American affairs as described in section 15(j).
- 3 (i) Make recommendations to the governor and legislature

- 7 (j) Work to ensure equal access to all levels of education for

- 16 programs for the betterment of Asian Pacific Americans in this

- 18 (n) Serve as a reporting agency for incidents of anti-Asian
- 19 and anti-Pacific islander American harassment in this state.
- 20 (o) Promote public awareness of Asian and Pacific islander
- 21 cultures.

- created in the department of <<civil rights energy, labor, and economic growth>>.
- 24 (2) The commission shall select the director of the office
- 25 with the concurrence of the director of << the department of civil
- 26 rights energy, labor, and economic growth>> in accordance with state civil service procedures.

- 11 (j) Submit a full written report of its activities and

- 16 (2) The council shall consist of:

- 8 (j) The secretary of state or his or her authorized
- 9 representative.
- 10 (k) The director of the department of corrections or his or
- 11 her authorized representative.
- 12 (1) The executive director of the women's commission or his or
- 13 her authorized representative.
- 14 (m) The director of management and budget or his or her
- 15 authorized representative.
- (n) The director of the department of <<labor energy, labor,>> and economic
- 17 growth or his or her authorized representative.
- (o) The chair of the state housing development authority or
- 19 his or her authorized representative.
- 20 (3) The purpose of the interagency council is to coordinate
- 21 and provide for the exchange of information on all programs
- 22 relating to services for Asian Pacific American people. The
- 23 interagency council shall also assist the office and commission in
- 24 the development of an annual report which is to be submitted to the
- 25 governor, the legislature, and Asian Pacific American communities
- 26 throughout the state.
