## HOUSE SUBSTITUTE FOR SENATE BILL NO. 53

A bill to amend 1964 PA 284, entitled "City income tax act,"

(MCL 141.501 to 141.787) by adding section 36 to chapter 2.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 CHAPTER 2
- 2 SEC. 36. (1) A TAXPAYER MAY DESIGNATE ON THE ANNUAL RETURN
- 3 REQUIRED UNDER THIS ACT THAT A CONTRIBUTION OF A SPECIFIED AMOUNT
- 4 OF A REFUND DUE THE TAXPAYER BE CREDITED TO THE CHECKOFF FUND WHICH
- 5 SHALL BE A RESTRICTED FUND WITHIN THE GENERAL FUND OF THE CITY TO
- 6 BE USED, EXCEPT AS OTHERWISE PERMITTED UNDER SUBSECTION (4), FOR
- 7 THE PURPOSES SPECIFIED PURSUANT TO SECTION 10 OF CHAPTER 1.
- 8 (2) THE PURPOSES FOR WHICH THE MONEY WILL BE USED SHALL BE
- 9 CLEARLY PRINTED ON THE ANNUAL RETURN OR IN THE INSTRUCTION BOOK
- 10 THAT ACCOMPANIES THE ANNUAL RETURN.

- 1 (3) IF A TAXPAYER'S REFUND IS NOT SUFFICIENT TO MAKE A
- 2 CONTRIBUTION UNDER THIS SECTION, THE TAXPAYER MAY DESIGNATE A
- 3 CONTRIBUTION AMOUNT AND THAT CONTRIBUTION AMOUNT SHALL BE ADDED TO
- 4 THE TAXPAYER'S TAX LIABILITY FOR THE TAX YEAR.
- 5 (4) NOTWITHSTANDING ANY OTHER ALLOCATIONS OR DISBURSEMENTS
- 6 REQUIRED BY THIS ORDINANCE, EACH YEAR THAT THE CONTRIBUTION
- 7 DESIGNATION UNDER THIS SECTION IS IN EFFECT, AN AMOUNT EQUAL TO THE
- 8 CUMULATIVE CONTRIBUTIONS MADE UNDER THIS SECTION, LESS THE AMOUNT
- 9 APPROPRIATED TO THE CITY TO IMPLEMENT THIS SECTION, SHALL BE
- 10 DEPOSITED INTO THE CHECKOFF FUND OF THE CITY. THE AMOUNT
- 11 APPROPRIATED TO THE CITY UNDER THIS SUBSECTION SHALL NOT EXCEED 10%
- 12 OF THE CUMULATIVE CONTRIBUTIONS MADE THAT YEAR.
- 13 (5) THE CHECKOFF FUND SHALL CONSIST OF THE MONEY CREDITED TO
- 14 THE FUND UNDER THIS SECTION, ANY INTEREST AND EARNINGS ACCRUING
- 15 FROM THE SAVING AND INVESTMENT OF THAT MONEY, AND OTHER
- 16 APPROPRIATIONS, MONEY, OR THINGS OF VALUE RECEIVED BY THE CHECKOFF
- 17 FUND.
- 18 (6) THE CITY TREASURER SHALL DIRECT THE INVESTMENT OF THE
- 19 CHECKOFF FUND.
- 20 (7) MONEY IN THE CHECKOFF FUND AT THE CLOSE OF THE YEAR SHALL
- 21 REMAIN IN THE CHECKOFF FUND AND SHALL NOT LAPSE TO THE GENERAL FUND
- 22 OF THE CITY OR TO ANY OTHER FUND OF THE CITY.
- 23 (8) THE MONEY, INTEREST, AND EARNINGS OF THE CHECKOFF FUND
- 24 SHALL BE EXPENDED, EXCEPT AS OTHERWISE PERMITTED UNDER SUBSECTION
- 25 (4), FOR THE PURPOSES SPECIFIED IN THE AMENDMENT ADOPTED AS
- 26 REQUIRED BY SECTION 10 OF CHAPTER 1.
- 27 Enacting section 1. This amendatory act does not take effect
