Sec. 203. As used in this appropriation act:	
(a) "Department" means the department of history, arts, and	
	Library services and technology act

- 2 (b) "Director" means the director of the department of

- 4 (c) "DOI-NPS" means the United States department of interior,
- 5 national park service.
- 6 (d) "Fiscal agencies" means the house fiscal agency and the
- 7 senate fiscal agency.
- 8 (e) "FTE" means full-time equated.
- 9 (f) "IDG" means interdepartmental grant.
- 10 (g) "MCACA" means the Michigan council for arts and cultural
- 11 affairs.
- 12 (h) "MDOT" means the Michigan department of transportation.
- 13 (i) "NEA" means the national endowment for the arts.
- 14 (j) "NFAH" means the national foundation of the arts and the
- 15 humanities.
- 16 (k) "Subcommittees" means all members of the appropriate
- 17 subcommittees of the senate and house of representatives
- 18 appropriations committees.
- 19 Sec. 204. The department of civil service shall bill the
- 20 departments and agencies at the end of the first fiscal quarter for
- 21 the 1% charge authorized by section 5 of article XI of the state
- 22 constitution of 1963. Payments shall be made for the total amount
- 23 of the billing by the end of the second fiscal quarter.
- Sec. 205. (1) A hiring freeze is imposed on the state
- 25 classified civil service. State departments and agencies are
- 26 prohibited from hiring any new full-time state classified civil
- 27 service employees and prohibited from filling any vacant state

- 1 classified civil service positions. This hiring freeze does not
- 2 apply to internal transfers of classified employees from 1 position
- 3 to another within a department.
- 4 (2) The state budget director may grant exceptions to this
- 5 hiring freeze when the state budget director believes that the
- 6 hiring freeze will result in rendering a state department or agency
- 7 unable to deliver basic services, cause a loss of revenue to the
- 8 state, result in the inability of the state to receive federal
- 9 funds, or would necessitate additional expenditures that exceed any
- 10 savings from maintaining a vacancy. The state budget director shall
- 11 report quarterly to the chairpersons of the senate and house of
- 12 representatives standing committees on appropriations the number of
- 13 exceptions to the hiring freeze approved during the previous
- 14 quarter and the reasons to justify the exception.
- 15 Sec. 208. Unless otherwise specified, the department shall use
- 16 the Internet to fulfill the reporting requirements of this act.
- 17 This requirement may include transmission of reports via electronic
- 18 mail to the recipients identified for each reporting requirement,
- 19 or it may include placement of reports on an Internet or Intranet
- 20 site.
- Sec. 209. Funds appropriated in part 1 shall not be used for
- 22 the purchase of foreign goods or services, or both, if
- 23 competitively priced and of comparable quality American goods or
- 24 services, or both, are available. Preference should be given to
- 25 goods or services, or both, manufactured or provided by Michigan
- 26 businesses if they are competitively priced and of comparable
- 27 quality.

- 1 Sec. 211. The department shall establish and maintain
- 2 affirmative action programs based on guidelines developed by the
- 3 state equal opportunity workforce planning council which was
- 4 created by Executive Order No. 1996-13 in order to receive general
- 5 fund/general purpose dollars.
- 6 Sec. 213. From the funds appropriated in part 1 for
- 7 information technology, departments and agencies shall pay user
- 8 fees to the department of information technology for technology-
- 9 related services and projects. The user fees shall be subject to
- 10 provisions of an interagency agreement between the departments and
- 11 agencies and the department of information technology.
- Sec. 214. Amounts appropriated in part 1 for information
- 13 technology may be designated as work projects and carried forward
- 14 to support technology projects under the direction of the
- 15 department of information technology. Funds designated in this
- 16 manner are not available for expenditure until approved as work
- 17 projects under section 451a of the management and budget act, 1984
- **18** PA 431, MCL 18.1451a.
- 19 Sec. 215. (1) The department may provide and enter into
- 20 agreements to provide general services, training, meetings,
- 21 information, special equipment, software, and facility use, and
- 22 technical consulting services to other principal executive
- 23 departments, state agencies, local units of government, the
- 24 judicial branch of government, other organizations, and patrons of
- 25 department facilities. Fees for services shall be reasonably
- 26 related to the cost of providing the services and shall be used to
- 27 offset the costs of the services. The department may receive and

- 1 expend funds in addition to those authorized in part 1 for the
- 2 following:
- 3 (a) Supplying census-related information and technical
- 4 services, publications, statistical studies, population projections
- 5 and estimates, and other demographic products.

- 17 (g) Application fees.
- 18 (h) Grants, gifts, and bequests, including those for capital
- 19 projects.
- 20 (2) The funds received under this section shall be deposited
- 21 in and expended from the history, arts, and libraries fund
- 22 established in section 216 of this article.
- Sec. 216. (1) A fund known as the history, arts, and libraries
- 24 fund is created in the department. The fund shall be used to
- 25 receive and expend funds in addition to those authorized in part 1.
- 26 The fund balance may be carried forward for expenditure in
- 27 subsequent fiscal years.

- 1 (2) The department shall provide a report to the senate and
- 2 house of representatives appropriations subcommittees on history,
- 3 arts, and libraries of all revenues to and expenditures from the
- 4 history, arts, and libraries fund. The report shall include an
- 5 estimated fund balance for the fiscal year ending September 30,
- 6 2008. The report is due November 1, 2008.
- 7 Sec. 217. (1) Due to the current budgetary problems in this
- 8 state, out-of-state travel for the fiscal year ending September 30,
- 9 2008 shall be limited to situations in which 1 or more of the
- 10 following conditions apply:
- 11 (a) The travel is required by legal mandate or court order or
- 12 for law enforcement purposes.
- 13 (b) The travel is necessary to protect the health or safety of
- 14 Michigan citizens or visitors or to assist other states in similar
- 15 circumstances.
- 16 (c) The travel is necessary to produce budgetary savings or to
- 17 increase state revenues, including protecting existing federal
- 18 funds or securing additional federal funds.
- 19 (d) The travel is necessary to comply with federal
- 20 requirements.
- (e) The travel is necessary to secure specialized training for
- 22 staff that is not available within this state.
- 23 (f) The travel is financed entirely by federal or nonstate
- 24 funds.
- 25 (2) If out-of-state travel is necessary but does not meet 1 or
- 26 more of the conditions in subsection (1), the state budget director
- 27 may grant an exception to allow the travel. Any exceptions granted

- 1 by the state budget director shall be reported on a monthly basis
- 2 to the senate and house of representatives appropriations
- 3 committees.
- 4 (3) Not later than January 1 of each year, each department
- 5 shall prepare a travel report listing all travel by classified and
- 6 unclassified employees outside this state in the immediately
- 7 preceding fiscal year that was funded in whole or in part with
- 8 funds appropriated in the department's budget. The report shall be
- 9 submitted to the chairs and members of the senate and house of
- 10 representatives appropriations committees, the fiscal agencies, and

- 20 occurrence, including the proportion funded with state general
- 21 fund/general purpose revenues, the proportion funded with state
- 22 restricted revenues, the proportion funded with federal revenues,
- 23 and the proportion funded with other revenues.
- 24 (f) A total of all out-of-state travel funded for the
- 25 immediately preceding fiscal year.
- 26 Sec. 218. It is the intent of the legislature to explore
- 27 supplemental fund sourcing options for the department of history,

- 1 arts, and libraries.
- 2 Sec. 219. The department shall not take disciplinary action
- 3 against an employee for communicating with a member of the
- 4 legislature or his or her staff.
- 5 Sec. 222. The director shall take all reasonable steps to
- 6 ensure businesses in deprived and depressed communities compete for
- 7 and perform contracts to provide services or supplies, or both. The
- 8 director shall strongly encourage firms with which the department
- 9 contracts to subcontract with certified businesses in depressed and
- 10 deprived communities for services, supplies, or both.
- 11 Sec. 223. (1) In addition to the funds appropriated in part 1,
- 12 there is appropriated an amount not to exceed \$2,000,000.00 for

- 8 Sec. 224. There is appropriated \$200,000.00 from the Mackinac
- 9 Island state park operation fund to the Mackinac Island state park

- infrastructure improvements. These funds shall be used for the 11
- 12 following:
- 13 (a) To match state grants for road repair.
- 14 (b) To match federal grants to acquire 2 snowplow trucks for
- 15 Mackinac Island state park.
- 16 (c) To make major repairs at the historic mill creek sawmill.
- 17 (d) To make repairs and improvements at the Michilimackinac

- 1 (a) Use published criteria to evaluate program quality,

- 18 (a) Artistic excellence and artistic merit are the criteria by

- 3 (5) The MCACA shall continue and expand its efforts to
- 4 encourage and support nonprofit arts and cultural organizations to

- 7 Sec. 403. (1) From the state funds appropriated in part 1 for
- 8 arts and cultural grants, no one organization may receive more than

- 12 70% of the total amount appropriated for arts and cultural grants.

- 22 Sec. 405. Each grant recipient shall provide the MCACA with
- 23 the following:
- 24 (a) Proof of the entire amount of the matching funds,
- 25 services, materials, or equipment by the end of the award period.
- 26 (b) Within 30 days following the end of the grant period, a
- 27 final report that includes the following:

- 1 (i) Project revenues and expenditures including grant matching
- 2 fund amounts.
- 3 (ii) Number of patrons attracted or benefiting during the grant
- 4 period.
- 5 (iii) A narrative summary of each project and its outcome,
- 6 including all of the following:
- 7 (A) How the project supported achieving the department's
- 8 intended goals and outcomes for each program.
- 9 (B) How the project met the quantifiable measures of success
- 10 in meeting the goals and outcomes.
- 11 (c) By April 7 of the grant year, each recipient of a grant
- 12 greater than \$100,000.00 shall submit an interim report that
- includes the items identified in subdivision (b).
- 14 Sec. 406. (1) The department shall make the following reports:
- 15 (a) A report identifying the website location that contains a
- 16 list of all grant recipients, sorted by county. This report shall
- 17 be provided to each legislator within 1 business day of the
- 18 announcement of annual awards by the MCACA.
- 19 (b) A report to the senate and house of representatives
- 20 appropriations subcommittees, the state budget office, and the
- 21 fiscal agencies, within 30 days after the MCACA announces the
- 22 annual grant awards, that includes all of the following:
- 23 (i) A listing of each applicant.
- 24 (ii) The county of residence of the applicant.
- 25 (iii) The amount requested.
- 26 (iv) The amount awarded.
- **27** (v) The grant category under which an applicant applied.

- 1 (vi) A summary of projects funded for each recipient.
- 2 (vii) The expected number of patrons for an applicant during
- 3 the grant period.
- 4 (viii) The amount of matching funds proposed by each applicant.
- 5 (ix) A listing containing the applicant, county of residence of
- 6 the applicant, and amount awarded for any regranted funds in the
- 7 preceding fiscal year.
- 8 (c) An annual report to the appropriations subcommittees, the
- 9 state budget office, and the fiscal agencies is due when materials
- 10 are first distributed by the MCACA seeking grant applications for
- 11 the subsequent fiscal year. The report shall contain the following:
- 12 (i) The MCACA guidelines for awarding grants, including the
- 13 intended program goals and outcomes and quantifiable measures of
- 14 success in meeting the goals and outcomes.
- 15 (ii) A summary of any changes in the program guidelines from
- 16 the previous fiscal year.
- 17 (d) An annual report to the appropriations subcommittees, the
- 18 state budget office, and the fiscal agencies on the success in
- 19 meeting program goals and outcomes for the preceding fiscal year.
- 20 The report is due by February 1 and shall contain all of the
- 21 following:
- (i) The MCACA intended program goals and outcomes.
- 23 (ii) A summary by program of performance according to the
- 24 established quantifiable measures of success for meeting intended
- 25 goals and outcomes.
- 26 (iii) The reasons why outcomes or goals were not met.
- (iv) The plans for better achieving the outcomes and goals in

- 2 (2) The council shall report to the chairpersons of the senate
- 3 and house of representatives appropriations subcommittees on
- 4 history, arts, and libraries by August 1 all unexpended or
- 5 unencumbered discretionary grant funding that is available. The
- 6 council shall not redistribute any unexpended or unencumbered grant
- 7 funds during the fiscal year without a 10-day notice to the
- 8 chairpersons of the senate and house of representatives
- 9 appropriations subcommittees on history, arts, and libraries.

MICHIGAN HISTORICAL PROGRAM

- 11 Sec. 501. The federal funds appropriated in part 1 for the
- 12 historic site preservation grants are for work projects and shall
- 13 not lapse at the end of the fiscal year but shall continue to be
- 14 available for expenditure until the projects for which the funds
- 15 were reserved have been completed or are terminated. The purpose of
- 16 these work projects is the identification, designation, and
- 17 preservation of historic resources. The method used will be to
- 18 solicit applications, score applications based upon established
- 19 criteria, and award subgrants. The department shall execute a grant
- 20 agreement with each recipient. The total cost is \$85,000.00, and
- 21 the tentative completion date is September 30, 2008.
- 22 Sec. 502. Funds collected by the department under sections 6,
- 23 7, and 7a of 1913 PA 271, MCL 399.6, 399.7, and 399.7a, are
- 24 appropriated to the department for the purposes for which they were
- 25 received, are allocated for expenditure upon receipt and may be
- 26 carried forward for expenditure in subsequent fiscal years.

- 1 Sec. 503. For the purposes of administering the museum store
- 2 as provided in section 7a of 1913 PA 271, MCL 399.7a, the
- 3 department is exempt from section 261 of the management and budget
- 4 act, 1984 PA 431, MCL 18.1261.
- 5 Sec. 505. From the funds appropriated in part 1 for historical
- 6 administration and services, \$25,000.00 shall be allocated to
- 7 support the operations of the Michigan freedom trail commission as
- 8 specified in section 4 of the Michigan freedom trail commission
- 9 act, 1998 PA 409, MCL 399.84. These funds shall be used to
- 10 reimburse commission members, to pay for necessary contractual
- 11 services of the commission, and to hire not more than 1.0 FTE
- 12 position in the department's Michigan historical center to support
- 13 commission operations.
- 14 Sec. 506. Proceeds in excess of costs incurred in the conduct
- 15 of auctions, sales, or transfers of artifacts no longer considered
- 16 suitable for the collections of the state historical museum are
- 17 appropriated to the department and may be expended upon receipt for
- 18 additional material for the collection.

19 LIBRARY OF MICHIGAN

- Sec. 601. In order to receive subregional state aid as
- 21 appropriated in part 1 to the library of Michigan, a subregional
- 22 library's fiscal agency must agree to maintain local funding
- 23 support at the same level in the current fiscal year as in the
- 24 fiscal agency's preceding fiscal year. If a reduction in
- 25 expenditures equally affects all agencies in a local unit of
- 26 government that is the subregional library's fiscal agency, that

- 1 reduction shall not be interpreted as a reduction in local support
- 2 and shall not disqualify a subregional library from receiving state
- 3 aid under part 1. If a reduction in income affects a library
- 4 cooperative or district library that is a subregional library's
- 5 fiscal agency or a reduction in expenditures for the subregional
- 6 library's fiscal agency, a reduction in expenditures for the
- 7 subregional library shall not be interpreted as a reduction in
- 8 local support and shall not disqualify a subregional library from
- 9 receiving state aid under part 1.
- 10 Sec. 602. The funds appropriated in part 1 for a subregional
- 11 library shall not be released until a budget for that subregional
- 12 library has been approved by the department for expenditures for
- 13 library services directly serving the blind and persons with
- 14 disabilities.
- 15 Sec. 607. The funds appropriated in part 1 for book
- 16 distribution centers shall be equally distributed to the public
- 17 enrichment foundation and the Michigan friends of education.
