- 26 of the billing by the end of the second fiscal quarter.
- Sec. 205. (1) Beginning October 1, a hiring freeze is imposed

- 16 appropriations the number of exceptions to the hiring freeze
- 17 approved during the previous month and the justification for the
- 18 exception.
- 19 Sec. 207. Sixty days before beginning any effort to privatize,
- 20 the department shall submit a complete project plan to the
- 21 appropriate senate and house of representatives appropriations
- 22 subcommittees and the senate and house fiscal agencies. The plan
- 23 shall include the criteria under which the privatization initiative
- 24 will be evaluated. The evaluation shall be completed and submitted
- 25 to the appropriate senate and house of representatives
- 26 appropriations subcommittees and the senate and house fiscal
- 27 agencies within 30 months.

- 1 Sec. 208. Unless otherwise specified, the department shall use
- 2 the Internet to fulfill the reporting requirements of this act.
- 3 This requirement may include transmission of reports via electronic
- 4 mail to the recipients identified for each reporting requirement or
- 5 it may include placement of reports on an Internet or Intranet
- 6 site.
- 7 Sec. 209. Funds appropriated in part 1 shall not be used for
- 8 the purchase of foreign goods or services, or both, if
- 9 competitively priced and of comparable quality American goods or
- 10 services, or both, are available. Preference should be given to
- 11 goods or services, or both, manufactured or provided by Michigan
- 12 businesses, if they are competitively priced and of comparable
- 13 quality.
- 14 Sec. 210. The director of each department receiving
- 15 appropriations in part 1 shall take all reasonable steps to ensure
- 16 businesses in deprived and depressed communities compete for and
- 17 perform contracts to provide services or supplies, or both. Each
- 18 director shall strongly encourage firms with which the department
- 19 contracts to subcontract with certified businesses in depressed and
- 20 deprived communities for services, supplies, or both.
- 21 Sec. 211. The departments and agencies receiving
- 22 appropriations in part 1 shall receive and retain copies of all
- 23 reports funded from appropriations in part 1. The department shall
- 24 follow all federal guidelines and state laws regarding short-term
- 25 and long-term retention of records.
- 26 Sec. 212. (1) Of the funds appropriated in part 1 for military
- 27 training sites and support facilities, there shall be established a

- 1 Michigan national quard education assistance program. Disbursements
- 2 to the educational assistance program shall not exceed
- 3 \$1,100,000.00 without legislative approval. Under the program, a
- 4 member of the national quard who is in active service and who

- 14 leave or who is under charges as described in the Michigan code of
- 15 military justice of 1980, 1980 PA 523, MCL 32.1001 to 32.1148.
- 16 (3) The department of military and veterans affairs, office of
- 17 the adjutant general shall administer the education assistance
- 18 program and prescribe forms and procedures to effectively carry out
- 19 the education assistance program.
- 20 (4) An eligible person shall apply to the department of
- 21 military and veterans affairs, office of the adjutant general for
- 22 education assistance and shall provide evidence of attendance and
- 23 completion of the course of study with a grade of at least 2.0 on a
- 24 4.0 scale, or its equivalent. The adjutant general shall approve
- 25 the application for reimbursement if the applicant meets the
- 26 definition of an eligible person under subsection (2) and other
- 27 criteria as established by the adjutant general.

1 (5) The education assistance program applies to any course of

- 2 instruction that is included in an associate, undergraduate, or
- 3 postgraduate degree program offered by a college or university of
- 4 this state.
- 5 (6) The education assistance program applies to an eligible
- 6 person notwithstanding any other educational incentive or benefit
- 7 received by the eligible person under any other educational
- 8 assistance program provided by any other state.
- 9 (7) An eligible person who successfully completes the course
- 10 of study with a grade of at least 2.0 on a 4.0 scale, or its
- 11 equivalent, shall be eligible for reimbursement.
- 12 (8) The department of military and veterans affairs may use
- 13 funds from the appropriated funds to administer the education
- 14 assistance program.
- 15 (9) Reimbursed members who do not complete their national
- 16 guard obligation shall pay the state for money received from the
- 17 state for tuition. Members who fail to repay the state within the
- 18 time limits established by the adjutant general shall be indebted
- 19 to the state. The department shall work in conjunction with the
- 20 department of treasury for inclusion in the tax intercept program
- 21 for amounts due the state.
- 22 (10) A portion of the funds for the Michigan national guard
- 23 education assistance program may be used by the department for the
- 24 purpose of promoting the program and for encouraging those persons
- 25 the department wishes to have enlist or reenlist in the Michigan
- 26 national quard.
- 27 Sec. 213. The department shall consult with the house and

- 1 senate appropriations subcommittees on military and veterans
- 2 affairs regarding the projected closing or consolidation of any
- 3 national guard armories.
- 4 Sec. 214. It is the intent of the legislature that, should the
- 5 necessary legislation be enacted and funding become available,
- 6 funds be appropriated for state military cemeteries in Crawford and
- 7 Dickinson counties.
- 8 Sec. 221. From the funds appropriated in part 1 for
- 9 information technology, departments and agencies shall pay user
- 10 fees to the department of information technology for technology-
- 11 related services and projects. These user fees shall be subject to
- 12 provisions of an interagency agreement between the departments and
- 13 agencies and the department of information technology.
- 14 Sec. 223. Amounts appropriated in part 1 for information
- 15 technology may be designated as work projects and carried forward
- 16 to support technology projects under the direction of the
- 17 department of information technology. Funds designated in this
- 18 manner are not available for expenditure until approved as work
- 19 projects under section 451a of the management and budget act, 1984
- 20 PA 431, MCL 18.1451a.
- 21 Sec. 225. (1) Due to the current budgetary problems in this
- 22 state, out-of-state travel for the fiscal year ending September 30,
- 23 2008 shall be limited to situations in which 1 or more of the
- 24 following conditions apply:
- 25 (a) The travel is required by legal mandate or court order or
- 26 for law enforcement purposes.
- 27 (b) The travel is necessary to protect the health or safety of

- 1 Michigan citizens or visitors or to assist other states in similar
- 2 circumstances.
- 3 (c) The travel is necessary to produce budgetary savings or to
- 4 increase state revenues, including protecting existing federal
- 5 funds or securing additional federal funds.
- 6 (d) The travel is necessary to comply with federal
- 7 requirements.
- 8 (e) The travel is necessary to secure specialized training for
- 9 staff that is not available within this state.
- 10 (f) The travel is financed entirely by federal or nonstate
- 11 funds.
- 12 (2) If out-of-state travel is necessary but does not meet 1 or
- more of the conditions in subsection (1), the state budget director
- 14 may grant an exception to allow the travel. Any exceptions granted
- 15 by the state budget director shall be reported on a monthly basis
- 16 to the senate and house of representatives standing committees on
- 17 appropriations.
- 18 (3) Not later than January 1 of each year, each department
- 19 shall prepare a travel report listing all travel by classified and
- 20 unclassified employees outside this state in the immediately
- 21 preceding fiscal year that was funded in whole or in part with
- 22 funds appropriated in the department's budget. The report shall be
- 23 submitted to the chairs and members of the senate and house of
- 24 representatives standing committees on appropriations, the senate
- 25 and house fiscal agencies, and the state budget director. The
- 26 report shall include the following information:
- 27 (a) The name of each person receiving reimbursement for travel

- 1 outside this state or whose travel costs were paid by this state.
- 2 (b) The destination of each travel occurrence.
- 3 (c) The dates of each travel occurrence.
- 4 (d) A brief statement of the reason for each travel
- 5 occurrence.
- **6** (e) The transportation and related costs of each travel

- 9 restricted revenues, the proportion funded with federal revenues,
- 10 and the proportion funded with other revenues.
- 11 (f) A total of all out-of-state travel funded for the

- Sec. 226. The department shall not take disciplinary action
- 14 against an employee for communicating with a member of the
- 15 legislature or his or her staff.
- 16 Sec. 227. Sixty days prior to the public announcement of the
- 17 intention to sell any department property, the department shall
- 18 submit notification of that intent to the appropriate senate and
- 19 house appropriations subcommittees and the senate and house fiscal
- 20 agencies.
- 21 Sec. 228. (1) In addition to the funds appropriated in part 1,
- there is appropriated an amount not to exceed \$5,000,000.00 for
- 23 federal contingency funds. These funds are not available for
- 24 expenditure until they have been transferred to another line item
- 25 in this act under section 393(2) of the management and budget act,

- 18 Sec. 229. There is hereby created and established under the
- 19 jurisdiction and control of the department a revolving account to

- 21 account. All of the fees and other revenues generated from the
- 22 operation of the regional training institute conference center
- 23 shall be deposited in the regional training institute conference
- 24 center account. Appropriations shall be made from the account for
- 25 the support of program operations and the maintenance and
- 26 operations of the regional training institute, the construction and
- 27 maintenance of morale, welfare and recreation facilities on Fort

- 17 (e) Community service clubs.
- 18 (f) Groups of persons with disabilities.
- 19 (g) Members of the legislature for the purposes related to the
- 20 business of the legislature.
- 21 (h) Entities and organizations that wish to use the conference
- 22 center to host an event that have a military or public safety
- related agenda.

[Sec. 231. From the funds appropriated in part 1, the department shall implement continuous improvement efficiency mechanisms in the programs administered by the department. The continuous improvement efficiency mechanisms shall identify changes made in programs to increase efficiency and reduce expenditures in the programs. On March 31, 2008 and September 30, 2008, the department shall report to the state budget director, the senate and house appropriation subcommittees, and the senate and house fiscal agencies on the progress made toward increased efficiencies in departmental programs. At a minimum, each report shall include information on the program review process, the type of improvement mechanisms implemented, and actual and projected expenditure savings as a result of the increased program efficiencies.]

- 20 services programs. These eligible youth shall be given priority for
- 21 enrollment in the program.

VETERANS SERVICE ORGANIZATIONS

- 23 Sec. 501. (1) Money appropriated in part 1 for grants to
- 24 veterans service organizations shall be used only for salaries,
- 25 wages, related personnel costs, training, and equipment for
- 26 accredited veteran service advocacy officers and necessary support

- 1 and managerial staff. Training shall be provided for service

- 10 organizations' rehabilitation and veterans service committee and
- 11 abide by its rules, guidelines, and programs.
- 12 (c) Demonstrate the receipt of monetary or service support
- 13 from its own organization.
- (d) Comply with the department's and the legislature's
- 15 requirements of accounting audits, service work activity,
- 16 accounting of recoveries, listing of volunteer hours, budget
- 17 requests, and other requirements specified in subsection (3).
- 18 (e) For a veterans service organization founded after
- 19 September 30, 1989, be in operation and providing service to
- 20 Michigan veterans for not less than 2 years before receiving an
- 21 initial state grant. During this 2-year period of time, the
- 22 organization shall file a listing of service work activity and an
- 23 accounting of recoveries with the department, the senate and house
- 24 fiscal agencies, the senate and house of representatives
- 25 appropriations subcommittees on military affairs, and the state
- 26 budget office on forms as prescribed by the department.
- 27 (3) A veterans service organization receiving a grant from the

- 1 money appropriated in part 1 shall file with the department an
- 2 accounting of its expenditures, audited and certified by a
- 3 certified public accountant, within 120 days after the
- 4 organization's fiscal year end. Each organization shall provide a
- 5 detailed budget request for the fiscal year ending September 30,
- 6 2009 to the department by November 15, 2007. Each veterans service
- 7 organization shall provide 5 copies of a listing of all service
- 8 activity, an accounting of recoveries, and a listing of volunteer
- 9 hours for the fiscal year ending September 30, 2007 to the
- 10 department by January 31, 2008. The listing of volunteer hours
- 11 shall include the hours, services, and donations provided to
- 12 residents of the Grand Rapids veterans' home and the D.J. Jacobetti
- 13 veterans' home. Each veterans service organization shall provide a
- 14 copy of the most recent and completed internal revenue service form
- 15 990 to the department at the end of the fiscal year ending
- 16 September 30, 2007. A veterans service organization receiving a
- 17 grant from the money appropriated in part 1 shall use the forms
- 18 recommended by the Michigan veterans organizations rehabilitation
- 19 and veterans service committee for filing reports required by this
- 20 act. The department shall forward information required under this
- 21 section to the senate and house fiscal agencies, the senate and
- 22 house of representatives appropriations subcommittees on military
- 23 affairs, and the state budget office.
- 24 (4) The veterans service directors committee and the
- 25 department shall take steps to improve the coordination of veterans
- 26 benefits counseling in the state to maximize the effective and
- 27 efficient use of taxpayer dollars in this goal and to ensure that

- 1 every veteran is served.
- 2 (5) To accomplish the goal of subsection (4), the veterans
- 3 service directors committee and the department shall take steps to

- 4 increase their responsibility in the administration, management,
- 5 oversight, and outreach of the delivery of services to veterans.
- 6 The veterans service directors committee and the department shall
- 7 involve county veterans counselors and representatives from the
- 8 Michigan veterans trust fund to work in concert to identify,
- 9 implement, and evaluate steps to do all of the following:
- 10 (a) Increase the veterans service directors committee and the
- 11 department's role in working directly with the United States
- 12 department of veterans' affairs to enhance the delivery of services
- 13 to Michigan veterans.
- 14 (b) Increase the number of initial claims filed with the
- 15 United States department of veterans' affairs on behalf of veterans
- 16 for service-connected disability or pension benefits. The veterans
- 17 service directors committee and the department may work toward
- 18 either an absolute increase of approved claims or an increase in
- 19 the percentage of Michigan veterans with approved claims.
- (c) Develop methods to increase rates of recovery paid by the
- 21 United States department of veterans' affairs to Michigan veterans
- 22 either by an increase in compensation paid per approved claim or
- 23 increase in compensation paid on a per capita basis.
- 24 (d) Expand training opportunities for veterans service
- 25 organization service officers.
- (e) Increase either the number or percentage of Michigan
- 27 veterans enrolled in the veterans administration health care

- 1 system.
- 2 (f) Publicize the availability, benefit, and value of burial
- 3 in the Fort Custer and Great Lakes national cemeteries.
- 4 (q) Review each grant recipient's performance under the
- 5 program and require that performance be a major consideration in
- 6 the future funding of each grant recipient.
- 7 (h) Identify areas of redundancy which may exist among
- 8 services provided by veterans service organizations grantees,
- 9 Michigan veterans trust fund county committees, and county veterans
- 10 counselors and provide a proposal on how any redundancies may be
- 11 minimized and identify specific cost savings which could result.
- 12 (6) The veterans service directors committee and the
- 13 department shall create a report of the efforts to complete the
- 14 goals outlined in this section and shall provide suggestions on how
- 15 a more effective and efficient veterans' benefits counseling
- 16 program may best be designed for implementation for fiscal year
- 17 2008-2009. This report shall be delivered to the house and senate
- 18 appropriations subcommittees no later than March 1, 2008.

19 <u>VETERANS' HOMES</u>

- Sec. 601. Appropriations in this act for the Grand Rapids
- 21 veterans' home and the D.J. Jacobetti veterans' home shall not be
- 22 used for any purpose other than for veterans and veterans'
- 23 families.
- 24 Sec. 602. The Grand Rapids veterans' home and the D.J.
- 25 Jacobetti veterans' home, together with the department and the
- 26 department of management and budget, shall produce and deliver to

- 1 the senate and house of representatives appropriations
- 2 subcommittees on state police and military affairs an annual
- 3 written report. The report shall include an accounting of member
- 4 populations and bed space available; a description and accounting
- 5 of services and activities provided to members; financial
- 6 information; current state nursing home licensure status; the steps
- 7 required for Medicaid certification, including a listing of any
- 8 personnel, equipment, supplies, or budgetary increases required;
- 9 and whether or not steps are being taken toward Medicaid
- 10 certification. The annual report shall be submitted to the senate
- 11 and house of representatives appropriations subcommittees on
- 12 military affairs no later than February 1, 2008.
- Sec. 603. The money appropriated in this act for the boards of
- 14 managers may be expended for facility improvements, the purchase
- 15 and repair of equipment and furnishings, member services, and other
- 16 purposes that benefit the Grand Rapids veterans' home and the D.J.
- 17 Jacobetti veterans' home.

VETERANS' TRUST FUND

- 19 Sec. 703. By April 1, 2008, the department shall submit to the
- 20 senate and house of representatives appropriations subcommittees on
- 21 military affairs and the state budget office a detailed annual
- 22 report of the Michigan veterans' trust fund for fiscal year 2006-
- 23 2007. The report shall include information on grants provided from
- 24 the emergency grant program, including details concerning the
- 25 methodology of allocations, the selection of emergency grant
- 26 program authorized agents, and a detailed breakdown of trust fund

- 1 expenditures for that year. The report shall also provide an update
- 2 on the department's efforts to reduce program administrative costs
- 3 and restore the Michigan veterans trust fund corpus to its original
- 4 amount of \$50,000,000.00.
- 5 Sec. 704. The Michigan veterans affairs directorate
- 6 administration and the Michigan veterans' trust fund administration
- 7 shall take steps to assist the county veterans counselors of the
- 8 state to obtain training necessary for the execution of their
- 9 duties.
