- 11 Sec. 204. The department of civil service shall bill
- 12 departments and agencies at the end of the first fiscal quarter for
- 13 the 1% charge authorized by section 5 of article XI of the state
- 14 constitution of 1963. Payments shall be made for the total amount
- 15 of the billing by the end of the second fiscal quarter.
- Sec. 205. (1) Beginning October 1, a hiring freeze is imposed
- 17 on the state classified civil service. State departments and
- 18 agencies are prohibited from hiring any new full-time state
- 19 classified civil service employees and prohibited from filling any
- 20 vacant state classified civil service positions. This hiring freeze
- 21 does not apply to internal transfers of classified employees from 1
- 22 position to another within a department.
- 23 (2) The state budget director shall grant exceptions to this
- 24 hiring freeze when the state budget director believes that the
- 25 hiring freeze will result in rendering a state department or agency
- 26 unable to deliver basic services, cause loss of revenue to the
- 27 state, result in the inability of the state to receive federal

- 1 funds, or necessitate additional expenditures that exceed any
- 2 savings from maintaining a vacancy. The state budget director shall
- 3 report by the last business day of each month to the chairpersons
- 4 of the senate and house of representatives standing committees on
- 5 appropriations the number of exceptions to the hiring freeze
- 6 approved during the previous month and the justification for the
- 7 exception.
- 8 Sec. 207. At least 60 days before beginning any effort to
- 9 privatize, the department shall submit a complete project plan to
- 10 the appropriate senate and house of representatives appropriations
- 11 subcommittees and the senate and house fiscal agencies. The plan
- 12 shall include the criteria under which the privatization initiative
- 13 will be evaluated. The evaluation shall be completed and submitted
- 14 to the appropriate senate and house of representatives
- 15 appropriations subcommittees and the senate and house fiscal
- 16 agencies within 30 months.
- Sec. 208. Unless otherwise specified, the department shall use
- 18 the Internet to fulfill the reporting requirements of this act.
- 19 This requirement may include transmission of reports via electronic
- 20 mail to the recipients identified for each reporting requirement or
- 21 it may include placement of reports on an Internet or Intranet
- 22 site.
- 23 Sec. 209. Funds appropriated in part 1 shall not be used for
- 24 the purchase of foreign goods or services, or both, if
- 25 competitively priced and of comparable quality American goods or
- 26 services, or both, are available. Preference should be given to
- 27 goods or services, or both, manufactured or provided by Michigan

- 1 businesses, if they are competitively priced and of comparable
- 2 quality.
- 3 Sec. 210. The director of each department receiving
- 4 appropriations in part 1 shall take all reasonable steps to ensure
- 5 businesses in deprived and depressed communities compete for and
- 6 perform contracts to provide services or supplies, or both, for the
- 7 department. The director shall strongly encourage firms with which
- 8 the department contracts to subcontract with certified businesses
- 9 in depressed and deprived communities for services or supplies, or
- **10** both.
- 11 Sec. 211. It is the intent of the legislature that personnel
- 12 of the department who request and are eligible for reimbursement of
- 13 expenses related to the operation of the department be reimbursed
- 14 from the appropriations provided in this act within 30 days after
- 15 submitting a request, or the eligible personnel shall be paid an
- 16 additional amount equal to 0.75% of the payment due. The department
- 17 shall pay an additional amount equal to 0.75% of the payment due
- 18 for the first month and each succeeding month or portion of a month
- 19 the payment remains past due.
- 20 Sec. 213. (1) It is the intent of the legislature that the
- 21 department shall not provide any subsidy for contractual services
- 22 it provides.
- 23 (2) When the department provides contractual services to a
- 24 local unit of government, the department shall be reimbursed for
- 25 all costs incurred in providing the services, including, but not
- 26 limited to, retirement and overtime costs.
- 27 (3) Contractual services provided to an entity other than a

- 1 local unit of government may be provided by department personnel,
- 2 but only on an overtime basis outside the normal work schedule of
- 3 the personnel.
- 4 (4) This section does not apply to state agencies.
- 5 Sec. 214. The departments and agencies receiving
- 6 appropriations in part 1 shall receive and retain copies of all
- 7 reports funded from appropriations in part 1. The department shall
- 8 follow all federal guidelines and state laws regarding short-term
- 9 and long-term retention of records.
- 10 Sec. 215. Not later than January 1, 2008, the department shall
- 11 report to the state police appropriations subcommittees of the
- 12 house and senate and the house and senate fiscal agencies. The
- 13 report shall contain the following information regarding the
- 14 department's activities related to casino gaming oversight during
- 15 fiscal year 2006-2007:
- 16 (a) The amount of money received and expended.
- 17 (b) The nature and structure of the casino gaming oversight
- **18** unit.
- 19 (c) The positions and classifications of employees assigned.
- 20 (d) The number of full-time and part-time employees and the
- 21 aggregate number of FTEs.
- (e) The number of enlisted and civilian positions.
- 23 (f) The duties and responsibilities of the assigned employees.
- 24 (g) The immediate past position of the enlisted employees
- 25 assigned.
- Sec. 216. The department shall collect and computerize the
- 27 vehicle identification number (VIN) of all vehicles that are

- 1 entered into the state accident data collection system and make
- 2 this and other vehicle information available to the public at cost.
- 3 For bulk access to the accident records in which the VIN has been
- 4 collected and computerized, the department shall make those records
- 5 available to the public at cost, provided that the name and address
- 6 have been excluded.
- 7 Sec. 217. From the funds appropriated in part 1, the
- 8 department shall maintain a toll-free hotline in collaboration with
- 9 the department of education. The toll-free hotline shall be
- 10 operated 24 hours per day, 7 days per week, and shall provide
- 11 students, school officials, and other individuals an opportunity to
- 12 report specific threats of imminent school violence or other
- 13 suspicious or criminal conduct by juveniles to the appropriate
- 14 local law enforcement entities for investigation. The department
- 15 may expend funds for the promotion of the hotline.
- 16 Sec. 218. (1) Funds appropriated in part 1 for at-post
- 17 troopers shall only be expended for trooper salaries, wages,
- 18 benefits, retirement, equipment, supplies, and other expenses
- 19 directly related to state troopers assigned to general law
- 20 enforcement duties at a department post, detachment, satellite
- 21 office, or a resident trooper function.
- 22 (2) From the funds appropriated in part 1 for at-post
- 23 troopers, 1 or more trooper recruit schools of a size, length, and
- 24 date to be determined by the department or the legislature shall be
- 25 conducted during fiscal year 2007-2008 with the goal of maintaining
- 26 at-post trooper strength of at least 1,075 on September 30, 2008.
- 27 (3) The department shall submit quarterly written reports to

- 1 the senate and house appropriations subcommittees on state police
- 2 and military and veterans affairs no later than December 1, 2007,
- 3 March 1, 2008, June 1, 2008, and September 1, 2008 which shall
- 4 include a trooper strength report and the status of the
- 5 department's plan for accomplishing the goal of subsection (2). If
- 6 the department determines that insufficient appropriations exist
- 7 under part 1 to accomplish the goal of subsection (2), the
- 8 department shall submit a proposal outlining a plan to accomplish
- 9 the goal including an accounting of any additional funding
- 10 necessary to that end.
- 11 Sec. 219. The department of state police shall notify the
- 12 house and senate appropriations subcommittees on state police and
- 13 military and veterans affairs and the house and senate fiscal
- 14 agencies not less than 180 days before recommending to close or
- 15 consolidate any state police posts. The notification shall include
- 16 a local and state impact study of the proposed post closure or
- 17 consolidation.
- 18 Sec. 220. The department of state police, in keeping with its
- 19 role as the general law enforcement agency of the state and as the
- 20 law enforcement agency of last resort for communities that are
- 21 either without local law enforcement resources or are seriously
- 22 underserved by local law enforcement resources, shall provide
- 23 general law enforcement assistance to those communities until
- 24 adequate law enforcement services can be provided to those
- 25 communities by other means.
- 26 Sec. 221. The department of state police may pursue entering
- 27 into an agreement with Calhoun County to build a new facility in

- 1 Marshall which would serve as a new state police post to replace
- 2 the current state police post in Battle Creek.
- 3 Sec. 223. (1) Due to the current budgetary problems in this
- 4 state, out-of-state travel for the fiscal year ending September 30,
- 5 2008 shall be limited to situations in which 1 or more of the
- 6 following conditions apply:
- 7 (a) The travel is required by legal mandate or court order or
- 8 for law enforcement purposes.
- 9 (b) The travel is necessary to protect the health or safety of
- 10 Michigan citizens or visitors or to assist other states in similar
- 11 circumstances.
- 12 (c) The travel is necessary to produce budgetary savings or to
- 13 increase state revenues, including protecting existing federal
- 14 funds or securing additional federal funds.
- 15 (d) The travel is necessary to comply with federal
- 16 requirements.
- 17 (e) The travel is necessary to secure specialized training for
- 18 staff that is not available within this state.
- 19 (f) The travel is financed entirely by federal or nonstate
- 20 funds.
- 21 (2) If out-of-state travel is necessary but does not meet 1 or
- 22 more of the conditions in subsection (1), the state budget director
- 23 may grant an exception to allow the travel. Any exceptions granted
- 24 by the state budget director shall be reported on a monthly basis
- 25 to the senate and house of representatives standing committees on
- 26 appropriations.
- 27 (3) Not later than January 1 of each year, each department

- 1 shall prepare a travel report listing all travel by classified and
- 2 unclassified employees outside this state in the immediately
- 3 preceding fiscal year that was funded in whole or in part with
- 4 funds appropriated in the department's budget. The report shall be

- 17 fund/general purpose revenues, the proportion funded with state
- 18 restricted revenues, the proportion funded with federal revenues,
- 19 and the proportion funded with other revenues.
- 20 (f) A total of all out-of-state travel funded for the
- 21 immediately preceding fiscal year.
- Sec. 224. The department shall not take disciplinary action
- 23 against an employee for communicating with a member of the
- 24 legislature or his or her staff.
- 25 Sec. 225. It is the intent of the legislature that the
- 26 administration, working with the MCOLES, continue the long-held
- 27 practice that all revenue made available to the department from the

- 1 Michigan justice training fund be used solely for costs directly
- 2 related to the delivery of Michigan justice training fund grants,
- 3 so that in the future, eligible entities as provided under 1982 PA
- 4 302, MCL 18.421 to 18.429, will have a stable and accurate source
- 5 of training funds.
- 6 Sec. 226. The department of state police, in cooperation with
- 7 the department of information technology and others, shall take
- 8 steps to encourage the development of state, local, and regional
- 9 tactical interoperable communication plans with the ultimate goal
- 10 being to ensure that effective and efficient communication
- 11 interoperability between radio communication systems of local,
- 12 regional, state, and federal agencies is established in every area
- 13 of the state. The department shall provide a written report to the
- 14 senate and house appropriations subcommittees on state police and
- 15 military and veterans affairs no later than April 1, 2008 on the

- 20 and which areas of the state have not yet achieved such status. The

- 22 be employed to ensure that the remaining areas of the state, and
- 23 the state as a whole, will have a communication system with
- 24 efficient and effective interoperability, particularly on occasions
- 25 when a multijurisdictional response to an emergency is warranted.
- 26 Sec. 227. (1) From the funds appropriated in part 1, the
- 27 department of state police is prohibited from transporting

- 1 employees of institutions of higher education on state-owned
- 2 aircraft.
- 3 (2) From the funds appropriated in part 1, the department is
- 4 prohibited from transporting legislators or legislative staff on
- 5 state-owned aircraft without prior approval from the senate
- 6 majority leader or the speaker of the house of representatives, or
- 7 both.
- 8 (3) From the funds appropriated in part 1, the department is
- 9 prohibited from transporting local government employees on state-
- 10 owned aircraft.
- 11 (4) It is the intent of the legislature that state elected
- 12 officials use commercial or other private air service, unless air
- 13 travel on state-owned aircraft is part of official state business.
- 14 (5) This section shall not apply to transportation that is
- 15 related to law enforcement or homeland security activities.
- Sec. 228. (1) In addition to the funds appropriated in part 1,
- 17 there is appropriated an amount not to exceed \$5,000,000.00 for
- 18 federal contingency funds. These funds are not available for
- 19 expenditure until they have been transferred to another line item
- 20 in this act under section 393(2) of the management and budget act,
- 21 1984 PA 431, MCL 18.1393.
- 22 (2) In addition to the funds appropriated in part 1, there is
- 23 appropriated an amount not to exceed \$2,000,000.00 for state
- 24 restricted contingency funds. These funds are not available for
- 25 expenditure until they have been transferred to another line item
- 26 in this act under section 393(2) of the management and budget act,
- 27 1984 PA 431, MCL 18.1393.

- 1 (3) In addition to the funds appropriated in part 1, there is
- 2 appropriated an amount not to exceed \$100,000.00 for local
- 3 contingency funds. These funds are not available for expenditure
- 4 until they have been transferred to another line item in this act
- 5 under section 393(2) of the management and budget act, 1984 PA 431,
- 6 MCL 18.1393.
- 7 (4) In addition to the funds appropriated in part 1, there is
- 8 appropriated an amount not to exceed \$100,000.00 for private
- 9 contingency funds. These funds are not available for expenditure
- 10 until they have been transferred to another line item in this act
- 11 under section 393(2) of the management and budget act, 1984 PA 431,

- Sec. 232. The department shall place emphasis on recruiting
- 14 MCOLES certified police officers for any trooper recruit schools
- 15 conducted during fiscal year 2007-2008. Emphasis shall be given in
- 16 the hiring process to those officers who are on layoff and possess
- 17 valid MCOLES certification. Any emphasis given in the recruiting
- 18 and selection process shall be consistent with the department's
- 19 hiring standards and in accordance with civil service rules. The

The continuous improvement efficiency mechanisms shall identify changes made in programs to increase efficiency and reduce expenditures in the programs. At a minimum, each report shall include information on the program review process, the type of improvement mechanisms implemented, and actual and projected expenditure savings as a result of the increased program efficiencies.]

# INFORMATION TECHNOLOGY

- 8 Sec. 301. The money appropriated in part 1 for computer
- 9 services shall be funded by LEIN user fees sufficient to pay 1/3 of
- 10 the service and contract maintenance costs of the LEIN system.
- 11 Sec. 302. From the funds appropriated in part 1 for
- 12 information technology, departments and agencies shall pay user
- 13 fees to the department of information technology for technology-
- 14 related services and projects. These user fees shall be subject to
- 15 provisions of an interagency agreement between the department and
- 16 the department of information technology.
- 17 Sec. 303. Amounts appropriated in part 1 for information
- 18 technology may be designated as work projects and carried forward
- 19 to support technology projects under the direction of the
- 20 department of information technology. Funds designated in this
- 21 manner are not available for expenditure until approved as work
- 22 projects under section 451a of the management and budget act, 1984
- 23 PA 431, MCL 18.1451a.
- 24 Sec. 304. A portion of the funds appropriated in part 1 shall

- Senate Bill No. 238 (H-6) as amended September 6, 2007 (2 of 2) be used by the department to produce a written report detailing
- 25
- departmental policies regarding access to and use of information 26

- 1 from the LEIN system. The report shall include a description of
- 2 departmental measures to protect the security of information in the
- 3 LEIN system including safeguards that would prevent unauthorized
- 4 persons from obtaining information from the LEIN system. The

- 17 of their own communications system. The department of state police
- 18 shall deliver a written report to the senate and house
- 19 appropriations subcommittees on state police and military and
- 20 veterans affairs by April 1, 2008, which shall include an
- 21 assessment of the progress toward establishing local public safety
- 22 agency use of the Michigan public safety communications system
- 23 towers, an accounting of problems that may be preventing local use
- 24 of the towers, and any recommendations the department has that may

- Sec. 308. The department of state police shall report any LEIN
- 27 fee increase to the senate and house appropriations subcommittees

- 1 on state police and military and veterans affairs 60 days prior to

- 3 following information: the current fee structure and the total
- 4 revenue earned each year; the new fee structure and the total
- 5 revenue it is expected to earn annually; the total annual cost of
- 6 the LEIN system; and the total amount of LEIN fees paid by the

- 9 Sec. 401. On a quarterly basis, the department shall report to
- 10 the senate and house appropriations subcommittees on state police
- 11 and military affairs on the status of assessments collected and
- 12 authorized under section 629e of the Michigan vehicle code, 1949 PA
- 13 300, MCL 257.629e, for the purposes of supporting the secondary
- 14 road patrol grant program. Each quarterly report shall contain
- 15 updated information on collection levels, revised projected grant
- 16 allotments to counties for the year, a comparison of projected
- 17 collections and grant distribution levels with the funds
- 18 appropriated in part 1 for the secondary road patrol program, and
- 19 the extent collection levels have exceeded or failed to meet
- 20 appropriated levels for the current fiscal year or expenditure
- 21 levels from the previous fiscal year.

# 22 FORENSIC SCIENCES

- 23 Sec. 501. (1) The department shall distribute a copy of the
- 24 department's protocol for retaining and purging DNA analysis
- 25 samples and records to each police agency in this state.

- 1 (2) The department shall report to the house and senate
- 2 appropriations subcommittees on state police and military and
- 3 veterans affairs and the house and senate fiscal agencies when any
- 4 changes to the department's DNA protocol are made.
- 5 Sec. 502. The department shall work with the department of
- 6 community health, the Michigan health and hospital association, the
- 7 Michigan state medical society, and the Michigan nurses association
- 8 to ensure that the recommendations included in the "Standard
- 9 Recommended Procedures for the Emergency Treatment of Sexual
- 10 Assault Victims" are followed in the collection of evidence.

## 11 MICHIGAN COMMISSION ON LAW ENFORCEMENT STANDARDS

- Sec. 601. The money appropriated to the MCOLES for maintenance
- 13 and delivery of training to locals is provided in accordance with a
- 14 state reimbursement policy in which 100% of the determined state
- 15 reimbursement rate shall be distributed upon certification by the
- 16 MCOLES.
- 17 Sec. 602. From the appropriations in part 1 for the training
- 18 of new state troopers and other new police officers in the state
- 19 and for the continuing education of all law enforcement officers in
- 20 the state, sufficient funds shall be used to include curricula on
- 21 the content and application of federal firearms laws, including the
- 22 procedures necessary for law enforcement to turn appropriate cases
- 23 over to the federal bureau of alcohol, tobacco, and firearms or any
- 24 other applicable federal criminal justice agency.
- 25 Sec. 603. From the funds appropriated in part 1 to the
- 26 Michigan commission on law enforcement standards, up to \$500,000

- 1 may be used to provide training for motor carrier officers and
- 2 capitol security officers for the purpose of qualifying them for
- 3 MCOLES certification.

## 4 EMERGENCY MANAGEMENT

- 5 Sec. 801. (1) The state director of emergency management may
- 6 expend money appropriated under this act to call upon any agency or
- 7 department of the state or any resource of the state to protect
- 8 life or property or to provide for the health or safety of the
- 9 population in any area of the state in which the governor proclaims
- 10 a state of emergency or state of disaster under 1945 PA 302, MCL
- 11 10.31 to 10.33, or under the emergency management act, 1976 PA 390,
- 12 MCL 30.401 to 30.421. The state director of emergency management
- 13 may expend the amounts the director considers necessary to
- 14 accomplish these purposes. The director shall submit to the state
- 15 budget director as soon as possible a complete report of all
- 16 actions taken under the authority of this section. The report shall
- 17 contain, as a separate item, a statement of all money expended that
- 18 is not reimbursable from federal money. The state budget director
- 19 shall review the expenditures and submit recommendations to the
- 20 legislature in regard to any possible need for a supplemental
- 21 appropriation.
- 22 (2) In addition to the money appropriated in this act, the
- 23 department may receive and expend money from local, private,
- 24 federal, or state sources for the purpose of providing emergency
- 25 management training to local or private interests and for the
- 26 purpose of supporting emergency preparedness, response, recovery,

- 1 and mitigation activity. If additional expenditure authorization in
- 2 the Michigan administrative information network is approved by the
- 3 state budget office under this section, the department and the
- 4 state budget office shall notify the house and senate
- 5 appropriations subcommittees on state police and military and
- 6 veterans affairs and the house and senate fiscal agencies within 10
- 7 days after the approval. The notification shall include the amount
- 8 and source of the additional authorization, the date of its
- 9 approval, and the projected use of funds to be expended under the
- 10 authorization.
- 11 Sec. 802. The department shall not make any purchases related
- 12 to a statewide emergency management computer network unless
- 13 authorized to do so by the director of the department of
- 14 information technology.
- 15 Sec. 803. The department's emergency management division shall
- 16 make every effort to ensure both of the following:
- 17 (a) That homeland security grants offered by the federal
- 18 government and channeled through the department are allocated to
- 19 first responder entities in the highest percentage possible.
- 20 (b) That homeland security grants awarded to the city of
- 21 Detroit shall not be used to supplant city general funds designated
- 22 to support first responder operations.

# POST UNIFORM SERVICES

- 24 Sec. 901. State police enlisted personnel who are employed to
- 25 enforce traffic laws as provided in section 629e of the Michigan
- 26 vehicle code, 1949 PA 300, MCL 257.629e, shall not be prohibited

- 1 from responding to crimes in progress or other emergency
- 2 situations, and are responsible for protecting every citizen of
- 3 this state from harm.

## 4 STATEWIDE FIELD OPERATIONS

- 5 Sec. 1001. In addition to the appropriations in part 1 to the
- 6 department of state police for the aviation program, the department
- 7 is authorized to sell its aircraft and the proceeds from the sale
- 8 are appropriated and may be applied to the renovation cost of
- 9 replacement aircraft, cost of enhancing and maintaining existing
- 10 aircraft, pilot training cost, and reimbursement for use of other
- 11 state agency aircraft. If additional expenditure authorization in
- 12 the Michigan administrative information network is approved by the
- 13 state budget office under this section, the department and the
- 14 state budget office shall notify the house and senate
- 15 appropriations subcommittees on state police and military and
- 16 veterans affairs and the house and senate fiscal agencies within 10
- 17 days after the approval. The notification shall include the amount
- 18 and source of the additional authorization, the date of its
- 19 approval, and the projected use of funds to be expended under the
- 20 authorization.
- 21 Sec. 1002. Money privately donated to the department is
- 22 appropriated under part 1 to be used for the purposes designated by
- 23 the donor of the money. Money privately donated to the department's
- 24 canine unit shall be used to purchase equipment and other items to
- 25 enhance the operation of the canine unit. It is the intent of the
- 26 legislature that money from private donations not supplant general

1 fund appropriations.

#### 2 SPECIAL INVESTIGATIONS

- 3 Sec. 1101. (1) There is sufficient money appropriated in part
- 4 1 to special investigations to ensure that the citizens in a
- 5 service area of any state police post in the vicinity of a state
- 6 prison do not experience a downgrading of state police services in
- 7 their area. Special investigations shall be available by temporary
- 8 or permanent assignment of a detective when either a temporary or
- 9 permanent prison facility is opened.
- 10 (2) If the department is unable to comply with subsection (1)
- 11 and there is a prison scheduled to open, the department shall
- 12 provide troopers to serve as investigators on an interim basis.
- Sec. 1102. From the funds appropriated in part 1 for special
- 14 investigations, the department shall provide a report to the
- 15 chairpersons of the senate and house of representatives standing
- 16 committees on appropriations no later than April 1, 2008 concerning
- 17 methamphetamine-related criminal activities.

#### 18 MOTOR CARRIER ENFORCEMENT

- 19 Sec. 1201. (1) The department shall report to the house and
- 20 senate appropriations subcommittees on state police and the house
- 21 and senate fiscal agencies by March 1, 2008 regarding the
- 22 inspection of school buses and other motor vehicles under section
- 23 715a of the Michigan vehicle code, 1949 PA 300, MCL 257.715a, and
- 24 section 39 of the pupil transportation act, 1990 PA 187, MCL
- 25 257.1839. The report shall include the following information

- 1 regarding inspections conducted in calendar year 2007:
- 2 (a) The number of buses and vehicles inspected by the
- 3 department.
- 4 (b) The number of buses and vehicles passing and failing
- 5 inspection.
- 6 (c) The estimated number of buses and vehicles not inspected.
- 7 (2) If each school bus within a school system receives a 100%
- 8 successful state inspection on its first inspection in a given
- 9 year, the department shall award a certificate to that school
- 10 system.
