### SENATE BILL NO. 241

## A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

by amending sections 1, 2a, 2b, 3c, 3d, 3e, 5, 5f, 5g, 9a, and 11b (MCL 722.111, 722.112a, 722.112b, 722.113c, 722.113d, 722.113e, 722.115, 722.115f, 722.115g, 722.119a, and 722.121b), section 1 as amended by 2005 PA 202, section 2a as amended by 1998 PA 440, section 2b as added by 2004 PA 531, section 3c as added by 1993 PA 219, section 3d as added by 1993 PA 218, section 3e as added by 2002 PA 717, sections 5 and 5f as amended by 2006 PA 580, section 5g as added by 2005 PA 128, section 9a as amended by 2004 PA 315, and section 11b as added by 2002 PA 645.

- 15 (ii) Provides care exclusively to persons who are 18 years of 16 age or older and to minors who have been emancipated by court order 17 under section 4(3) of 1968 PA 293, MCL 722.4, at the same location.
- 18 (b) "Child caring institution" means a child care facility 19 that is organized for the purpose of receiving minor children for 20 care, maintenance, and supervision, usually on a 24-hour basis, in 21 buildings maintained by the child caring institution for that 22 purpose, and operates throughout the year. An educational program 23 may be provided, but the educational program shall not be the 24 primary purpose of the facility. Child caring institution includes a maternity home for the care of unmarried mothers who are minors 25 and an agency group home, that is described as a small child caring 26

institution owned, leased, or rented by a licensed agency providing

- 1 care for more than 4 but less than 13 minor children. Child caring
- 2 institution also includes institutions for mentally retarded or
- 3 emotionally disturbed minor children. Child caring institution does
- 4 not include a hospital, nursing home, or home for the aged licensed
- 5 under article 17 of the public health code, 1978 PA 368, MCL
- 6 333.20101 to 333.22260, a boarding school licensed under section
- 7 1335 of the revised school code, 1976 PA 451, MCL 380.1335, a
- 8 hospital or facility operated by the state or licensed under the
- 9 mental health code, 1974 PA 258, MCL 330.1001 to 330.2106, or an
- 10 adult foster care family home or an adult foster care small group
- 11 home licensed under the adult foster care facility licensing act,
- 12 1979 PA 218, MCL 400.701 to 400.737, in which a child has been
- 13 placed under section 5(6).
- 14 (c) "Child placing agency" means a governmental organization
- 15 or an agency organized under the nonprofit corporation act, 1982 PA
- 16 162, MCL 450.2101 to 450.3192, for the purpose of receiving
- 17 children for placement in private family homes for foster care or
- 18 for adoption. The function of a child placing agency may include
- 19 investigating applicants for adoption and investigating and
- 20 certifying foster family homes and foster family group homes as
- 21 provided in this act. The function of a child placing agency may
- 22 also include supervising children who are 16 or 17 years of age and
- 23 who are living in unlicensed residences as provided in section
- **24** 5(4).
- 25 (d) "Children's camp" means a residential, day, troop, or
- 26 travel camp that provides care and supervision and is conducted in
- 27 a natural environment for more than 4 children, apart from the

- 1 children's parents, relatives, or legal quardians, for 5 or more
- 2 days in a 14-day period. CHILDREN'S CAMP INCLUDES A CAMPSITE THAT
- 3 IS AN OUTDOOR SETTING THAT HAS NATURAL OR MANMADE FEATURES
- 4 AVAILABLE FOR OUTDOOR LIVING OR ACTIVITIES AND THAT IS LOCATED
- 5 WHERE A CHILDREN'S CAMP IS OPERATED.
- 6 (E) "CHILDREN'S THERAPEUTIC GROUP HOME" MEANS A CHILD CARE
- 7 FACILITY RECEIVING NOT MORE THAN 6 MINOR CHILDREN WHO ARE DIAGNOSED
- 8 WITH A DEVELOPMENTAL DISABILITY AS DEFINED IN SECTION 100A OF THE
- 9 MENTAL HEALTH CODE, 1974 PA 258, MCL 330.1100A, OR A SERIOUS
- 10 EMOTIONAL DISTURBANCE AS DEFINED IN SECTION 100D OF THE MENTAL
- 11 HEALTH CODE, 1974 PA 258, MCL 330.1100D. A CHILDREN'S THERAPEUTIC
- 12 GROUP HOME MEETS ALL OF THE FOLLOWING REQUIREMENTS:
- 13 (i) PROVIDES CARE, MAINTENANCE, AND SUPERVISION, USUALLY ON A
- 14 24-HOUR BASIS.
- 15 (ii) COMPLIES WITH THE RULES FOR RESIDENTIAL TREATMENT
- 16 INSTITUTIONS, EXCEPT THAT BEHAVIOR MANAGEMENT ROOMS, PERSONAL
- 17 RESTRAINT, MECHANICAL RESTRAINT, OR SECLUSION WHICH IS ALLOWED IN
- 18 CERTAIN CIRCUMSTANCES UNDER LICENSING RULES ARE PROHIBITED IN A
- 19 CHILDREN'S THERAPEUTIC GROUP HOME.
- 20 (iii) IS NOT A PRIVATE HOME.
- 21 (iv) IS NOT LOCATED ON A CAMPUS WITH OTHER LICENSED FACILITIES.
- 22 (F) (e) "Child care center" or "day care center" means a
- 23 facility, other than a private residence, receiving 1 or more
- 24 preschool or school-age children for care for periods of less than
- 25 24 hours a day, and where the parents or guardians are not
- 26 immediately available to the child. Child care center or day care
- 27 center includes a facility that provides care for not less than 2

- 1 consecutive weeks, regardless of the number of hours of care per
- 2 day. The facility is generally described as a child care center,
- 3 day care center, day nursery, nursery school, parent cooperative
- 4 preschool, play group, before- or after-school program, or drop-in
- 5 center. Child care center or day care center does not include any
- 6 of the following:
- 7 (i) A Sunday school, a vacation bible school, or a religious
- 8 instructional class that is conducted by a religious organization
- 9 where children are attending for not more than 3 hours per day for
- 10 an indefinite period or for not more than 8 hours per day for a
- 11 period not to exceed 4 weeks during a 12-month period.
- 12 (ii) A facility operated by a religious organization where
- 13 children are cared IN THE RELIGIOUS ORGANIZATION'S CARE for not
- 14 more than 3 hours while persons responsible for the children are
- 15 attending religious services.
- 16 (iii) A program that is primarily supervised, school-age-child-
- 17 focused training in a specific subject, including, but not limited
- 18 to, dancing, drama, music, or religion. This exclusion applies only
- 19 to the time a child is involved in supervised, school-age-child-
- 20 focused training.
- 21 (iv) A program that is primarily an incident of group athletic
- 22 or social activities for school-age children sponsored by or under
- 23 the supervision of an organized club or hobby group, including, but
- 24 not limited to, youth clubs, scouting, and school-age recreational
- 25 or supplementary education programs. This exclusion applies only to
- 26 the time the school-age child is engaged in the group athletic or
- 27 social activities and if the school-age child can come and go at

- 1 will.
- 2 (G) "DEPARTMENT" MEANS THE DEPARTMENT OF HUMAN SERVICES OR A
- 3 SUCCESSOR AGENCY OR DEPARTMENT RESPONSIBLE FOR LICENSURE AND
- 4 REGISTRATION UNDER THIS ACT.
- 5 (H) (f)—"Private home" means a private residence in which the
- 6 licensee or registrant permanently resides as a member of the
- 7 household, which residency is not contingent upon caring for
- 8 children or employment by a licensed or approved child placing
- 9 agency. Private home includes a full-time foster family home, a
- 10 full-time foster family group home, a group day CHILD care home, or
- 11 a family day CHILD care home, as follows:
- 12 (i) "Foster family home" is a private home in which 1 but not
- 13 more than 4 minor children, who are not related to an adult member
- 14 of the household by blood or marriage, or who are not placed in the
- 15 household under the Michigan adoption code, chapter X of the
- 16 probate code of 1939, 1939 PA 288, MCL 710.21 to 710.70, are given
- 17 care and supervision for 24 hours a day, for 4 or more days a week,
- 18 for 2 or more consecutive weeks, unattended by a parent, or legal
- 19 guardian, OR LEGAL CUSTODIAN.
- 20 (ii) "Foster family group home" means a private home in which
- 21 more than 4 but fewer than 7 minor children, who are not related to
- 22 an adult member of the household by blood or marriage, or who are
- 23 not placed in the household under the Michigan adoption code,
- 24 chapter X of the probate code of 1939, 1939 PA 288, MCL 710.21 to
- 25 710.70, are provided care for 24 hours a day, for 4 or more days a
- 26 week, for 2 or more consecutive weeks, unattended by a parent, or
- 27 legal guardian, OR LEGAL CUSTODIAN.

- 1 (iii) "Family day CHILD care home" means a private home in which
- 2 1 but fewer than 7 minor children are received for care and
- 3 supervision for periods of less than 24 hours a day, unattended by
- 4 a parent or legal guardian, except children related to an adult
- 5 member of the family by blood, marriage, or adoption. Family day
- 6 CHILD care home includes a home in which care is given to an
- 7 unrelated minor child for more than 4 weeks during a calendar year.
- 8 (iv) "Group day CHILD care home" means a private home in which
- 9 more than 6 but not more than 12 minor children are given care and
- 10 supervision for periods of less than 24 hours a day unattended by a
- 11 parent or legal guardian, except children related to an adult
- 12 member of the family by blood, marriage, or adoption. Group day
- 13 CHILD care home includes a home in which care is given to an
- 14 unrelated minor child for more than 4 weeks during a calendar year.
- 15 (I) "LEGAL CUSTODIAN" MEANS AN INDIVIDUAL WHO IS AT LEAST 18
- 16 YEARS OF AGE IN WHOSE CARE A MINOR CHILD REMAINS OR IS PLACED AFTER
- 17 A COURT MAKES A FINDING UNDER SECTION 13A(5) OF CHAPTER XIIA OF THE
- 18 PROBATE CODE OF 1939, 1939 PA 288, MCL 712A.13A.
- 19 (J) (g) "Licensee" means a person, partnership, firm,
- 20 corporation, association, nongovernmental organization, or local or
- 21 state government child care organization that has been issued a
- 22 license under this act to operate a child care organization.
- 23 (K) (h)—"Provisional license" means a license issued to a
- 24 child care organization that is temporarily unable to conform to
- 25 all of the rules promulgated under this act.
- 26 (l) (i) "Regular license" means a license issued to a child
- 27 care organization indicating that the organization is in compliance

 ecclesiastical corporation, or group, not organized for pecuniary
 profit, that gathers for mutual support and edification in piety or

- 2 (T) (q) "School-age child" means a child who is eligible to be

- 3 enrolled in a grade of kindergarten or above, but is less than 13
- 4 years of age.
- 5 (2) A facility or program for school-age children that is
- 6 currently operated and has been in operation and licensed or
- 7 approved as provided in this act for a minimum of 2 years may apply

- 3 (g) "Mechanical restraint" means a device attached or adjacent
- 4 to the minor child's body that he or she cannot easily remove and
- 5 that restricts freedom of movement or normal access to his or her
- 6 body. Mechanical restraint does not include the use of a protective
- 7 or adaptive device or a device primarily intended to provide
- 8 anatomical support. Mechanical restraint does not include use of a
- 9 mechanical device to ensure security precautions appropriate to the
- 10 condition and circumstances of a minor child placed in the child
- 11 caring institution as a result of an order of the family division
- 12 of circuit court under section 2(a) of chapter XIIA of the probate
- 13 code of 1939, 1939 PA 288, MCL 712A.2.
- 14 (h) "Personal restraint" means the application of physical
- 15 force without the use of a device, for the purpose of restraining
- 16 the free movement of a minor child's body. Personal restraint does
- 17 not include:
- 18 (i) The use of a protective or adaptive device.
- 19 (ii) Briefly holding a minor child without undue force in order
- 20 to calm or comfort him or her.
- 21 (iii) Holding a minor child's hand, wrist, shoulder, or arm to
- 22 safely escort him or her from 1 area to another.
- 23 (iv) The use of a protective or adaptive device or a device
- 24 primarily intended to provide anatomical support.
- 25 (i) "Protective device" means an individually fabricated
- 26 mechanical device or physical barrier, the use of which is
- 27 incorporated in the individualized written plan of service. The use

1 of a protective device is intended to prevent the minor child from

- 2 causing serious self-injury associated with documented, frequent,
- 3 and unavoidable hazardous events.
- 4 (j) "Seclusion" means the involuntary placement of a minor
- 5 child in a room alone, where the minor child is prevented from
- 6 exiting by any means, including the physical presence of a staff
- 7 person if the sole purpose of that staff person's presence is to
- 8 prevent the minor child from exiting the room. Seclusion does not
- 9 include the use of a sleeping room during regular sleeping hours to
- 10 ensure security precautions appropriate to the condition and
- 11 circumstances of a minor child placed in the child caring
- 12 institution as a result of an order of the family division of
- 13 circuit court under section 2(a) and (b) of chapter XIIA of the
- 14 probate code of 1939, 1939 PA 288, MCL 712A.2, if the minor child's
- 15 individual case treatment plan indicates that the security
- 16 precautions would be in the minor child's best interest.
- 17 (k) "Serious injury" means any significant impairment of the
- 18 physical condition of the minor child as determined by qualified
- 19 medical personnel that results from an emergency safety
- 20 intervention. This includes, but is not limited to, burns,
- 21 lacerations, bone fractures, substantial hematoma, and injuries to
- 22 internal organs, whether self-inflicted or inflicted by someone
- 23 else.
- 24 (2) The provisions of this section and sections 2c, 2d, and 2e
- 25 only apply to a child caring institution that contracts with or
- 26 receives payment from a community mental health services program or
- 27 prepaid inpatient health plan for the care, treatment, maintenance,

- 1 and supervision of a minor child in that child caring institution.
- 2 Sec. 3c. (1) An individual shall not smoke on the premises of
- 3 a family day CHILD care home during the hours of operation of the

- 26 prescribed, by the department. Before issuing or renewing a

- 19 conducive to the welfare of children. The department shall make
- 20 available to applicants for registration an orientation session to
- 21 applicants for registration regarding this act, the rules
- 22 promulgated under this act, and the needs of children in family day
- 23 CHILD care before issuing a certificate of registration. The
- 24 department shall issue a certificate of registration to a specific
- 25 person at a specific location. A certificate of registration is

- 21 facility licensing act, 1979 PA 218, MCL 400.701 to 400.737, if a
- 22 licensed child placing agency or approved governmental unit retains

- 12 (b) The placement has the concurrence of the parent or
- 13 quardian of the child.
- 14 (c) The identified needs of the child can be met adequately by
- 15 the adult foster care family home or small group home.
- 16 (d) The child's psychosocial and clinical needs are compatible
- 17 with those of other residents of the adult foster care family home
- 18 or small group home.
- 19 (e) The clinical treatment of the child's condition is similar
- 20 to that of the other residents of the adult foster care family home
- 21 or small group home.
- 22 (f) The child's cognitive level is consistent with the
- 23 cognitive level of the other residents of the adult foster care
- 24 family home or small group home.
- 25 (g) The child is neurologically disabled and is also
- 26 physically limited to such a degree as to require complete physical
- 27 assistance with mobility and activities of daily living.

- 1 (h) The child placing agency or approved governmental unit
- 2 will periodically reevaluate the placement of a child under this
- 3 subsection to determine that the criteria for placement in
- 4 subdivisions (a) to (g) continue to be met.
- 5 (9) Beginning October 1, 2007, except as provided in
- 6 subsection (1) and section 5b, the department shall issue an

- 14 (c) "Member of the household" means any individual, other than
- 15 a foster child, who resides in a foster family home or foster
- 16 family group home on an ongoing or recurrent basis.
- 17 Sec. 5f. (1) Except as provided in subsection (13), when a
- 18 person applies for or to renew a certificate of registration to
- 19 operate a family day CHILD care home or a license to operate a
- 20 group day CHILD care home under section 5, the department shall
- 21 request the department of state police to perform both of the

1 (vi) A misdemeanor violation of section 701 of the Michigan

- (vii) Any misdemeanor that is a listed offense.
- 4 (c) A violation of a substantially similar law of another
- 5 state, of a political subdivision of this state or another state,
- 6 or of the United States.
- 7 (8) A person who violates subsection (7) is guilty of a crime
- 8 as follows:
- 9 (a) If the person violates subsection (7) and the crime
- 10 involved in the violation is a misdemeanor that is a listed offense
- 11 or is a felony, the person is quilty of a felony punishable by
- 12 imprisonment for not more than 2 years or a fine of not more than
- 13 \$2,000.00, or both.
- 14 (b) If the person violates subsection (7) and the crime
