A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 498c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 498C. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), A PERSON
- 2 WHO, WITHOUT LAWFUL AUTHORITY, TAMPERS WITH, TAKES, OR REMOVES A
- 3 PUBLIC SAFETY DEVICE OWNED OR MAINTAINED BY THIS STATE OR A
- 4 POLITICAL SUBDIVISION OF THIS STATE KNOWING OR HAVING REASON TO
- 5 KNOW THAT THE DEVICE IS A PUBLIC SAFETY DEVICE IS GUILTY OF A
- 6 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 7 A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 8 (2) A PERSON WHO, WITHOUT LAWFUL AUTHORITY, TAMPERS WITH,
  - TAKES, OR REMOVES A PUBLIC SAFETY DEVICE OWNED OR MAINTAINED BY

## Senate Bill No. 358 as amended May 17, 2007

- 1 THIS STATE OR A POLITICAL SUBDIVISION OF THIS STATE KNOWING OR

- 7 GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5
- 8 YEARS OR A FINE OF NOT LESS THAN \$1,000.00 OR MORE THAN \$5,000.00,
- 9 OR BOTH IMPRISONMENT AND A FINE.
- 10 (B) IF THE VIOLATION IS THE PROXIMATE CAUSE OF THE DEATH OF
- 11 ANOTHER PERSON, THE PERSON IS GUILTY OF A FELONY PUNISHABLE BY
- 12 IMPRISONMENT FOR NOT MORE THAN 15 YEARS OR A FINE OF NOT LESS THAN
- 13 \$2,500.00 OR MORE THAN \$10,000.00, OR BOTH IMPRISONMENT AND A FINE.
- 14 (3) AS USED IN THIS SECTION:
- 15 (A) "PUBLIC SAFETY DEVICE" MEANS EITHER OF THE FOLLOWING:
- 16 (i) A DEVICE TO RENDER EMERGENCY MEDICAL ASSISTANCE TO AN
- 17 INDIVIDUAL INCLUDING << >> A FIRST AID KIT, AN
- 18 OXYGEN SUPPLY KIT, A CARDIAC DEFIBRILLATOR, OR A STRETCHER.
- 19 (ii) A DEVICE TO PREVENT OR SUPPRESS A FIRE INCLUDING <<
- 20 >> A FIRE DETECTOR, FIRE ALARM, OR FIRE EXTINGUISHER.
- 21 (B) "SERIOUS IMPAIRMENT OF A BODY FUNCTION" MEANS THAT TERM AS
- 22 DEFINED IN SECTION 58C OF THE MICHIGAN VEHICLE CODE, 1949 PA 300,
- 23 MCL 257.58C.
