## SENATE BILL NO. 654

## A bill to amend 1972 PA 222, entitled

"An act to provide for an official personal identification card; to provide for its form, issuance and use; to regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations; and to provide an appropriation for certain purposes,"

by amending sections 1, 1a, and 2 (MCL 28.291, 28.291a, and 28.292), sections 1 and 2 as amended by 2005 PA 143 and section 1a as added by 1997 PA 99.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) A person who is a resident of this state may apply
- 2 to the department of state for an official state personal
- 3 identification card. Upon application, the applicant shall supply A
- 4 PHOTOGRAPHIC IDENTITY DOCUMENT, a birth certificate attesting to
- 5 his or her age or OTHER NONPHOTOGRAPHIC IDENTITY DOCUMENT, AND

- 1 other sufficient documents or identification as the secretary of
- 2 state may require TO VERIFY THE IDENTITY AND CITIZENSHIP OF THE
- 3 APPLICANT. IF AN APPLICANT FOR AN OFFICIAL STATE PERSONAL
- 4 IDENTIFICATION CARD IS NOT A CITIZEN OF THE UNITED STATES, THE
- 5 APPLICANT SHALL SUPPLY A PHOTOGRAPHIC IDENTITY DOCUMENT AND OTHER
- 6 SUFFICIENT DOCUMENTS TO VERIFY THE IDENTITY OF THE APPLICANT AND
- 7 THE APPLICANT'S LEGAL PRESENCE IN THE UNITED STATES UNDER
- 8 SUBSECTION (3). THE DOCUMENTS REQUIRED UNDER THIS SUBSECTION SHALL
- 9 INCLUDE THE APPLICANT'S FULL LEGAL NAME, DATE OF BIRTH, AND ADDRESS
- 10 AND RESIDENCY AND DEMONSTRATE THAT THE APPLICANT IS A CITIZEN OF
- 11 THE UNITED STATES OR IS LEGALLY PRESENT IN THE UNITED STATES. IF
- 12 THE APPLICANT'S FULL LEGAL NAME DIFFERS FROM THE NAME OF THE
- 13 APPLICANT THAT APPEARS ON A DOCUMENT PRESENTED UNDER THIS
- 14 SUBSECTION, THE APPLICANT SHALL PRESENT DOCUMENTS TO VERIFY HIS OR
- 15 HER CURRENT FULL LEGAL NAME. An application for a state personal
- 16 identification card shall be made in a manner prescribed by the
- 17 secretary of state and shall contain the applicant's full LEGAL
- 18 name, date of birth, SOCIAL SECURITY NUMBER, residence address,
- 19 height, sex, eye color, signature, and , beginning January 1, 2007,
- 20 intent to be an organ donor, and other information required or
- 21 permitted on the official state personal identification card. The
- 22 applicant may provide a mailing address if the applicant receives
- 23 mail at an address different from his or her residence address.
- 24 (2) The secretary of state shall not issue an official state
- 25 personal identification card to a person who holds an operator's or
- 26 chauffeur's license issued under the Michigan vehicle code, 1949 PA
- 27 300, MCL 257.1 to 257.923, unless the license has been suspended,

- 1 revoked, or restricted.
- 2 (3) IF THE APPLICANT IS NOT A CITIZEN OF THE UNITED STATES,
- 3 THE APPLICANT SHALL PROVIDE DOCUMENTS DEMONSTRATING HIS OR HER
- 4 LEGAL PRESENCE IN THE UNITED STATES. A PERSON LEGALLY PRESENT IN
- 5 THE UNITED STATES INCLUDES, BUT IS NOT LIMITED TO, A PERSON
- 6 AUTHORIZED BY THE UNITED STATES GOVERNMENT FOR EMPLOYMENT IN THE
- 7 UNITED STATES, A PERSON WITH NONIMMIGRANT STATUS AUTHORIZED UNDER
- 8 FEDERAL LAW, AND A PERSON WHO IS THE BENEFICIARY OF AN APPROVED
- 9 IMMIGRANT VISA PETITION OR AN APPROVED LABOR CERTIFICATION. THE
- 10 SECRETARY OF STATE SHALL ADOPT RULES UNDER THE ADMINISTRATIVE
- 11 PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO 24.328, AS ARE
- 12 NECESSARY FOR THE ADMINISTRATION OF THIS SUBSECTION. A
- 13 DETERMINATION BY THE SECRETARY OF STATE THAT AN APPLICANT IS NOT
- 14 LEGALLY PRESENT IN THE UNITED STATES MAY BE APPEALED UNDER SECTION
- 15 631 OF THE REVISED JUDICATURE ACT OF 1961, 1961 PA 236, MCL
- 16 600.631.
- 17 (4) THE SECRETARY OF STATE SHALL NOT DISCLOSE A SOCIAL
- 18 SECURITY NUMBER OBTAINED UNDER SUBSECTION (1) TO ANOTHER PERSON
- 19 EXCEPT FOR USE FOR 1 OR MORE OF THE FOLLOWING PURPOSES:
- 20 (A) COMPLIANCE WITH 49 USC 31301 TO 31317 AND REGULATIONS AND
- 21 RULES RELATED TO THIS ACT.
- 22 (B) TO CARRY OUT THE PURPOSES OF SECTION 466(A) OF THE SOCIAL
- 23 SECURITY ACT, 42 USC 666, IN CONNECTION WITH MATTERS RELATING TO
- 24 PATERNITY, CHILD SUPPORT, OR OVERDUE CHILD SUPPORT.
- 25 (C) TO CHECK AN APPLICANT'S DRIVING RECORD THROUGH THE
- 26 NATIONAL DRIVER REGISTER AND THE COMMERCIAL DRIVER LICENSE
- 27 INFORMATION SYSTEM WHEN ISSUING AN OFFICIAL STATE PERSONAL

- 1 IDENTIFICATION CARD UNDER THIS ACT.
- 2 (D) WITH THE DEPARTMENT OF COMMUNITY HEALTH, FOR COMPARISON
- 3 WITH VITAL RECORDS MAINTAINED BY THE DEPARTMENT OF COMMUNITY HEALTH
- 4 UNDER PART 28 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.2801
- 5 TO 333.2899.
- 6 (E) AS OTHERWISE REQUIRED BY LAW.
- 7 (5) THE SECRETARY OF STATE SHALL NOT DISPLAY A PERSON'S SOCIAL
- 8 SECURITY NUMBER ON THE PERSON'S OFFICIAL STATE PERSONAL
- 9 IDENTIFICATION CARD.
- 10 (6) A REQUIREMENT UNDER THIS SECTION TO INCLUDE A SOCIAL
- 11 SECURITY NUMBER ON AN APPLICATION DOES NOT APPLY TO AN APPLICANT
- 12 WHO DEMONSTRATES HE OR SHE IS EXEMPT UNDER LAW FROM OBTAINING A
- 13 SOCIAL SECURITY NUMBER.
- 14 (7) THE SECRETARY OF STATE, WITH THE APPROVAL OF THE STATE
- 15 ADMINISTRATIVE BOARD CREATED UNDER 1921 PA 2, MCL 17.1 TO 17.3, MAY
- 16 ENTER INTO AGREEMENTS WITH THE UNITED STATES GOVERNMENT TO VERIFY
- 17 WHETHER AN APPLICANT FOR AN OFFICIAL STATE PERSONAL IDENTIFICATION
- 18 CARD UNDER THIS SECTION WHO IS NOT A CITIZEN OF THE UNITED STATES
- 19 IS AUTHORIZED UNDER FEDERAL LAW TO BE PRESENT IN THE UNITED STATES.
- 20 (8) THE SECRETARY OF STATE SHALL NOT ISSUE AN OFFICIAL STATE
- 21 PERSONAL IDENTIFICATION CARD TO A PERSON HOLDING AN OFFICIAL STATE
- 22 PERSONAL IDENTIFICATION CARD ISSUED BY ANOTHER STATE WITHOUT
- 23 CONFIRMATION THAT THE PERSON IS TERMINATING OR HAS TERMINATED THE
- 24 OFFICIAL STATE PERSONAL IDENTIFICATION CARD ISSUED BY THE OTHER
- 25 STATE.
- 26 (9) THE SECRETARY OF STATE SHALL DO ALL OF THE FOLLOWING:
- 27 (A) ENSURE THE PHYSICAL SECURITY OF LOCATIONS WHERE OFFICIAL

- 1 STATE PERSONAL IDENTIFICATION CARDS ARE PRODUCED AND THE SECURITY
- 2 OF DOCUMENT MATERIALS AND PAPERS FROM WHICH OFFICIAL STATE PERSONAL
- 3 IDENTIFICATION CARDS ARE PRODUCED.
- 4 (B) SUBJECT ALL PERSONS AUTHORIZED TO MANUFACTURE OR PRODUCE
- 5 OFFICIAL STATE PERSONAL IDENTIFICATION CARDS AND ALL PERSONS WHO
- 6 HAVE THE ABILITY TO AFFECT THE IDENTITY INFORMATION THAT APPEARS ON
- 7 OFFICIAL STATE PERSONAL IDENTIFICATION CARDS TO APPROPRIATE
- 8 SECURITY CLEARANCE REQUIREMENTS. THE SECURITY REQUIREMENTS OF THIS
- 9 SUBDIVISION AND SUBDIVISION (A) MAY REQUIRE THAT OFFICIAL STATE
- 10 PERSONAL IDENTIFICATION CARDS BE MANUFACTURED OR PRODUCED IN THIS
- 11 STATE.
- 12 (C) PROVIDE FRAUDULENT DOCUMENT RECOGNITION PROGRAMS TO
- 13 DEPARTMENT OF STATE EMPLOYEES ENGAGED IN THE ISSUANCE OF OFFICIAL
- 14 STATE PERSONAL IDENTIFICATION CARDS.
- 15 Sec. 1a. As used in this act:
- (a) "Highly restricted personal information" includes an
- 17 individual's photograph or image, social security number, digitized
- 18 signature, and medical and disability information AND SOURCE
- 19 DOCUMENTS PRESENTED BY AN APPLICANT TO OBTAIN A PERSONAL
- 20 IDENTIFICATION CARD UNDER SECTION 2.
- 21 (b) "Personal information" means information that identifies
- 22 an individual, including the individual's photograph or image,
- 23 name, address (but not the 5-digit zip code), driver license
- 24 number, social security number, telephone number, digitized
- 25 signature, and medical and disability information.
- 26 (C) "RESIDENT" MEANS EVERY PERSON WHO RESIDES IN THIS STATE
- 27 AND ESTABLISHES THAT HE OR SHE IS LEGALLY PRESENT IN THE UNITED

- 1 STATES. THIS DEFINITION APPLIES TO THE PROVISIONS OF THIS ACT ONLY.
- 2 Sec. 2. (1) The official state personal identification card
- 3 shall contain the following:
- 4 (a) An identification number permanently assigned to the
- 5 person.
- 6 (b) The full **LEGAL** name, date of birth, sex, residential
- 7 address, height, weight, eye color, DIGITAL PHOTOGRAPHIC image, and
- 8 signature of the person to whom the identification card is issued
- 9 APPLICANT.
- 10 (c) An indication that the identification card contains 1 or
- more of the following:
- 12 (i) The blood type of the person.
- 13 (ii) Immunization data of the person.
- 14 (iii) Medication data of the person.
- 15 (iv) A statement that the person is deaf.
- 16 (v) Until January 1, 2007, a statement that the person is an
- 17 organ and tissue donor under part 101 of the public health code,
- 18 1978 PA 368, MCL 333.10101 to 333.10109. If the identification card

- 22 (vi) Emergency contact information of the person.
- 23 (vii) A sticker or decal as specified by the secretary of state
- 24 to indicate that the holder of the official state personal
- 25 identification card has designated 1 or more patient advocates in
- 26 accordance with section 5506 of the estates and protected
- 27 individuals code, 1998 PA 386, MCL 700.5506, or a statement that he

- 1 or she carries an emergency medical information card, as described
- 2 in subsection (5).
- 3 (d) In the case of a person who is less than 18 years of age
- 4 at the time of issuance of the identification card, the dates on
- 5 which the person will become 18 years of age and 21 years of age.
- 6 (e) In the case of a person who is not less than 18 years of
- 7 age but less than 21 years of age at the time of issuance of the
- 8 identification card, the date on which the person will become 21
- 9 years of age.
- 10 (D) (f) Beginning January 1, 2007, in IN the case of a holder
- 11 of an official state personal identification card who has indicated
- 12 his or her wish to participate in the organ and tissue donor
- 13 registry under part 101 of the public health code, 1978 PA 368, MCL
- 14 333.10101 to 333.10109, a heart insignia on the front of the
- 15 official state personal identification card.
- 16 (E) PHYSICAL SECURITY FEATURES DESIGNED TO PREVENT TAMPERING,
- 17 COUNTERFEITING, OR DUPLICATION OF THE OFFICIAL STATE PERSONAL
- 18 IDENTIFICATION CARD FOR FRAUDULENT PURPOSES.
- 19 (2) In conjunction with the application for or, until January
- 20 1, 2007, the issuance of an official state personal identification
- 21 card, the secretary of state shall do all of the following:
- 22 (a) Provide the applicant with all of the following:
- 23 (i) Information explaining the applicant's right to make an
- 24 anatomical gift in the event of death under part 101 of the public
- 25 health code, 1978 PA 368, MCL 333.10101 to 333.10109, and in
- 26 accordance with this section.
- 27 (ii) Information describing the organ, tissue, and eye donor

- 1 registry program maintained by Michigan's federally designated
- 2 organ procurement organization or its successor organization. The
- 3 information required under this subparagraph includes the address
- 4 and telephone number of Michigan's federally designated organ
- 5 procurement organization or its successor organization.
- 6 (iii) Information giving the applicant the opportunity to have
- 7 his or her name placed on the registry described in subparagraph
- 8 (*ii*).
- 9 (b) Provide the applicant with the opportunity to specify on
- 10 his or her official state personal identification card that he or
- 11 she is willing to make an anatomical gift in the event of death
- 12 pursuant to part 101 of the public health code, 1978 PA 368, MCL
- 13 333.10101 to 333.10109, and in accordance with this section.
- 14 (c) Inform the applicant that, if he or she indicates to the
- 15 secretary of state under this section a willingness to have his or
- 16 her name placed on the registry described in subdivision (a) (ii),
- 17 the secretary of state will mark the applicant's record for the
- 18 registry.
- 19 (3) The secretary of state may fulfill the requirements of
- 20 subsection (2) by 1 or more of the following methods:
- (a) Providing printed material enclosed with a mailed notice
- 22 for the issuance or renewal of an official state personal
- 23 identification card.
- 24 (b) Providing printed material to an applicant who personally
- 25 appears at a secretary of state branch office.
- 26 (c) Through electronic information transmittals for
- 27 applications processed by electronic means.

          (4) Until January 1, 2007, if an applicant indicates a

    identification card a space where the applicant may place a sticker
    or decal of the uniform size as the secretary may specify to

    information card. The sticker or decal may be provided by any
24
    person, hospital, school, medical group, or association interested
    in assisting in implementing the emergency medical information
25
    card, but shall meet the specifications of the secretary of state.

The sticker or decal also may be used to indicate that the

- 1 cardholder has designated 1 or more patient advocates in accordance

- 4 carried separately by the cardholder, may contain the information

- 7 indication of a willingness to have his or her name placed on the
- 8 registry that is obtained by the secretary of state and forwarded
- 9 under this section is exempt from disclosure under section 13(1)(d)
- 10 of the freedom of information act, 1976 PA 442, MCL 15.243. The
- 11 secretary of state shall establish and maintain the organ, tissue,
- 12 and eye donor registry in a manner that provides electronic access,
- including, but not limited to, the transfer of data to this state's
- 14 federally designated organ procurement organizations, their
- 15 successor organizations, and tissue and eye banks with limitations
- 16 on the use of and access to the donor registry as determined by the
- 17 secretary of state.
- 18 (10) An official state personal identification card may
- 19 contain an identifier for voter registration purposes.
- 20 (11) An official state personal identification card may SHALL
- 21 contain information appearing in electronic or machine readable
- 22 codes needed to conduct a transaction with the secretary of state.
- 23 The information shall be limited to the person's identification
- 24 card number, birth date, expiration date, FULL LEGAL NAME, DATE OF
- 25 TRANSACTION, GENDER, ADDRESS, STATE OF ISSUANCE, and other
- 26 information necessary for use with electronic devices, machine
- 27 readers, or automatic teller machines and shall not contain the

- 1 person's name, address, driving record , or other personal
- 2 identifier. The identification card shall identify the encoded
- 3 information.
- 4 (12) (11) An official state personal identification card shall

- 5 be issued only upon authorization of the secretary of state, and
- 6 shall be manufactured in a manner to prohibit as nearly as possible
- 7 the ability to reproduce, alter, counterfeit, forge, or duplicate

- 10 applicant shall pay a fee of \$10.00 to the secretary of state for
- 11 each original or renewal identification card issued. The department
- 12 of treasury shall deposit the fees received and collected under

- 15 provided in 1978 PA 260, MCL 393.351 to 393.368.
- 16 (d) A person who presents other good cause for a fee waiver.
- 17 (e) Beginning January 1, 2007, a A person who wishes to add or
- 18 remove a heart insignia described in subsection (1)(f).
- 19 (16) (15) A person who has been issued an official state
- 20 personal identification card shall apply for a renewal official
- 21 state personal identification card if the person changes his or her
- 22 name.
- 23 (17) (16)—A person who has been issued an official state
- 24 personal identification card shall apply for a corrected
- 25 identification card if he or she changes his or her residential
- 26 address. The secretary of state may correct the address on an
- 27 identification card by a method prescribed by the secretary of

- 1 state. A fee shall not be charged for a change of residential
- 2 address.

- 21 PA 293, MCL 722.1 to 722.6, the official state personal
- 22 identification card shall bear the designation of the individual's
- 23 emancipated status in a manner prescribed by the secretary of
- 24 state.
- 25 (21) (20) Beginning January 1, 2007, the THE secretary of
- 26 state shall inquire of each person who applies for or who holds an
- 27 official state personal identification card, in person or by mail,

- 1 whether he or she agrees to participate in the organ, tissue, and
- 2 eye donor registry under part 101 of the public health code, 1978
- **3** PA 368, MCL 333.10101 to 333.10109. A person who has agreed to
- 4 participate in that registry shall not be considered to have
- 5 revoked that agreement solely because the person's official state
- 6 personal identification card has expired. Enrollment in the organ,
