## SUBSTITUTE FOR SENATE BILL NO. 1178

A bill to amend 1984 PA 431, entitled "The management and budget act,"

(MCL 18.1101 to 18.1594) by adding section 125.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 125. (1) THE DIRECTOR MAY AUTHORIZE A PERSON ENGAGED IN
- 2 THE PRODUCTION OF A FILM IN THIS STATE TO USE WITHOUT CHARGE
- 3 PROPERTY OWNED BY OR UNDER THE CONTROL OF THE DEPARTMENT FOR THE
- 4 PURPOSE OF PRODUCING A FILM UNDER TERMS AND CONDITIONS ESTABLISHED
- 5 BY THE DIRECTOR. THE ECONOMIC AND OTHER BENEFITS TO THIS STATE OF
- 6 FILM PRODUCTION LOCATED IN THIS STATE SHALL BE CONSIDERED TO BE THE
- 7 VALUE RECEIVED BY THIS STATE IN EXCHANGE FOR THE USE OF PROPERTY
- 8 UNDER THIS SECTION.
- 9 (2) THE DIRECTOR SHALL NOT AUTHORIZE THE USE OF PROPERTY OWNED
- 10 BY OR UNDER THE CONTROL OF THE DEPARTMENT FOR THE PRODUCTION OF A

- 1 FILM THAT INCLUDES OBSCENE MATTER OR AN OBSCENE PERFORMANCE OR FOR
- 2 A PRODUCTION FOR WHICH RECORDS ARE REQUIRED TO BE MAINTAINED WITH
- 3 RESPECT TO ANY PERFORMER UNDER 18 USC 2257.
- 4 (3) THE DEPARTMENT SHALL COOPERATE WITH THE MICHIGAN FILM
- 5 OFFICE IN PROVIDING THE OFFICE WITH INFORMATION ABOUT POTENTIAL
- 6 FILM LOCATIONS OWNED BY OR UNDER THE CONTROL OF THE DEPARTMENT AND
- 7 THE USE OF PROPERTY OWNED BY OR UNDER THE CONTROL OF THE
- 8 DEPARTMENT.
- 9 (4) AS USED IN THIS SECTION:
- 10 (A) "FILM" MEANS SINGLE MEDIA OR MULTIMEDIA ENTERTAINMENT
- 11 CONTENT FOR DISTRIBUTION OR EXHIBITION TO THE GENERAL PUBLIC BY ANY
- 12 MEANS AND MEDIA IN ANY DIGITAL MEDIA FORMAT, FILM, OR VIDEO TAPE,
- 13 INCLUDING, BUT NOT LIMITED TO, A MOTION PICTURE, A DOCUMENTARY, A
- 14 TELEVISION SERIES, A TELEVISION MINISERIES, A TELEVISION SPECIAL,
- 15 INTERSTITIAL TELEVISION PROGRAMMING, LONG-FORM TELEVISION,
- 16 INTERACTIVE TELEVISION, MUSIC VIDEOS, INTERACTIVE GAMES, VIDEO
- 17 GAMES, COMMERCIALS, INTERNET PROGRAMMING, AN INTERNET VIDEO, A
- 18 SOUND RECORDING, A VIDEO, DIGITAL ANIMATION, OR AN INTERACTIVE
- 19 WEBSITE.
