## SUBSTITUTE FOR SENATE BILL NO. 1572

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 5391.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 539l. (1) A PERSON WHO DOES EITHER OF THE FOLLOWING IS
- 2 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 3 THAN 1 YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH:
- 4 (A) INSTALLS OR PLACES A TRACKING DEVICE, OR CAUSES A TRACKING
- 5 DEVICE TO BE INSTALLED OR PLACED, IN OR ON A MOTOR VEHICLE WITHOUT
- 6 THE KNOWLEDGE AND CONSENT OF THE OWNER OF THAT MOTOR VEHICLE OR, IF
- 7 THE MOTOR VEHICLE IS LEASED, THE LESSEE OF THAT MOTOR VEHICLE.
- 8 (B) TRACKS THE LOCATION OF A MOTOR VEHICLE WITH A TRACKING
- 9 DEVICE WITHOUT THE KNOWLEDGE AND CONSENT OF EITHER THE OWNER OR THE

- 1 AUTHORIZED OPERATOR OF THAT MOTOR VEHICLE OR, IF THE MOTOR VEHICLE
- 2 IS LEASED, EITHER THE LESSEE OR THE AUTHORIZED OPERATOR OF THAT
- 3 MOTOR VEHICLE.
- 4 (2) SUBSECTION (1) DOES NOT APPLY TO ANY OF THE FOLLOWING:
- 5 (A) THE USE OF ANY DEVICE THAT PROVIDES VEHICLE TRACKING ONLY
- 6 FOR PURPOSES OF PROVIDING MECHANICAL, DIRECTIONAL, WEATHER, OR
- 7 TRAFFIC INFORMATION TO THE OPERATOR OF THE VEHICLE.
- 8 (B) THE USE OF ANY DEVICE FOR PROVIDING EMERGENCY ASSISTANCE
- 9 TO THE OPERATOR OR PASSENGERS OF THE VEHICLE THROUGH A SUBSCRIPTION
- 10 SERVICE, INCLUDING ANY TRIAL PERIOD OF THAT SUBSCRIPTION SERVICE.
- 11 (C) THE USE OF ANY DEVICE ONLY FOR PROVIDING STOLEN VEHICLE
- 12 ASSISTANCE FOR THE BENEFIT OF THE OWNER OF THE VEHICLE UNDER THE
- 13 TERMS AND CONDITIONS OF A SUBSCRIPTION SERVICE, INCLUDING ANY TRIAL
- 14 PERIOD OF THE SUBSCRIPTION SERVICE.
- 15 (D) THE USE OF ANY DEVICE ONLY TO PROVIDE DIAGNOSTIC SERVICES
- 16 REGARDING THE MECHANICAL OPERATION OF A VEHICLE UNDER THE TERMS AND
- 17 CONDITIONS OF A SUBSCRIPTION SERVICE, INCLUDING ANY TRIAL PERIOD OF
- 18 THE SUBSCRIPTION SERVICE.
- 19 (E) A POLICE OFFICER WHILE PERFORMING HIS OR HER DUTIES AS A
- 20 POLICE OFFICER.
- 21 (F) A PERSON LICENSED UNDER THE PROFESSIONAL INVESTIGATOR
- 22 LICENSURE ACT, 1965 PA 285, MCL 338.821 TO 338.851, WHILE
- 23 PERFORMING HIS OR HER DUTIES AS A PROFESSIONAL INVESTIGATOR.
- 24 (G) A PERSON LAWFULLY PERFORMING HIS OR HER DUTIES AS A BAIL
- 25 AGENT AS AUTHORIZED UNDER SECTION 167B.
- 26 (3) AS USED IN THIS SECTION, "TRACKING DEVICE" MEANS ANY
- 27 ELECTRONIC DEVICE THAT IS DESIGNED OR INTENDED TO BE USED TO TRACK

- 1 THE LOCATION OF A MOTOR VEHICLE ON A STREET OR HIGHWAY OF THIS
- 2 STATE REGARDLESS OF WHETHER THAT INFORMATION IS RECORDED.
