HOUSE BILL No. 4183

January 31, 2007, Introduced by Rep. Lemmons and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 411a, 412a, and 416 (MCL 380.411a, 380.412a, and 380.416), as amended by 2004 PA 303.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 411a. (1) This section applies to a first class school
- 2 district only if the question under section 410 is not approved in
- 3 the first class school district.
- 4 (2) Four members of the board of a first class school district
- 5 shall be elected at large. The following provisions apply to the
- 6 terms, nomination, and election of the at large members of the
- 7 board of a school district organized as a first class school
- 8 district:
 - (a) Four SUBJECT TO SUBSECTION (8), 4 members shall be elected

- 1 for a term of 4 years at the general election to be held in the
- 2 next November after the question under section 410 is presented to
- 3 the school electors of the first class school district and every 4
- 4 years after that November.
- 5 (b) Each candidate shall be nominated at a primary held in
- 6 conjunction with the preceding primary election conducted pursuant
- 7 to section 534 of the Michigan election law, 1954 PA 116, MCL
- 8 168.534. The nominating petitions shall contain not less than 500
- 9 or more than 1,000 signatures of registered school electors of the
- 10 city in which the first class school district is located; shall
- 11 meet the requirements of section 544c of the Michigan election law,
- 12 1954 PA 116, MCL 168.544c; and shall be filed with the clerk of the
- 13 city in which the first class school district is located on or
- 14 before 4 p.m. of the twelfth Tuesday before the primary election.
- 15 The city clerk may compare the signatures on the petitions with the
- 16 signatures appearing on the registration records, or in some other
- 17 proper manner determine whether the signatures appearing on the
- 18 petition are genuine and comply with the requirements of this
- 19 section. With the petitions, a candidate shall file an affidavit as
- 20 provided in section 558 of the Michigan election law, 1954 PA 116,
- 21 MCL 168.558. The clerk of the city shall notify the county clerk of
- 22 the name and address of each candidate not later than 3 days after
- 23 the last day for candidate withdrawal. However, if the third day is
- 24 a Saturday, Sunday, or legal holiday, the notice may be made on the
- 25 next day that is not a Saturday, Sunday, or legal holiday.
- (c) Each member shall commence his or her term of office on
- 27 January 1 following his or her election.

- 1 (3) The EXCEPT AS OTHERWISE PROVIDED IN SECTION 416, THE board
- 2 of a first class school district shall elect its officers during
- 3 the month of January of each odd numbered year. The president of
- 4 the board shall be a member of the board, and the duties of the
- 5 president shall be determined by the board.
- 6 (4) A board member of a first class school district who is
- 7 recalled may be a candidate for the same office at the next
- 8 election for an office at which the recalled member is otherwise
- 9 eliqible.
- 10 (5) The term of office of each board member serving in a
- 11 school district that becomes a first class school district after
- 12 April 15, 2004 expires on the next succeeding December 31 of an
- 13 even numbered year, except that if the school district becomes a
- 14 first class school district later than April 1 of an even numbered
- 15 year, the term of office of each board member expires on December
- 16 31 of the next succeeding even numbered year after the year in
- 17 which the district became a first class school district. For a
- 18 district becoming a first class school district after April 15,
- 19 2004, 4 school board members shall be elected in the general
- 20 election of the even numbered year in which the terms of office
- 21 expire, and the 4 school board members elected shall commence 4-
- 22 year terms on January 1 of the odd numbered year following the
- 23 general election.
- 24 (6) If a vacancy occurs on the first class school district
- 25 board from among the at large members, the vacancy shall be filled
- 26 by majority vote of the remaining first class school district board
- 27 members at a meeting called by the president of the board for that

- 1 purpose. If a person is appointed to fill a vacancy for which the
- 2 unexpired term is more than 1 year and 8 months, that person shall
- 3 serve until January 1 following the next general election. At that
- 4 first general election the vacancy shall be filled for the
- 5 unexpired term. A vacancy shall not be filled later than 60 days
- 6 before a primary election at which at large board members are to be
- 7 nominated.
- 8 (7) A candidate for the office of board member at large or a
- 9 person appointed to fill a vacancy on the board pursuant to
- 10 subsection (6) shall be 18 years of age or older at the time of his
- 11 or her election or appointment and shall be a registered school
- 12 elector residing in the first class school district in which the
- 13 person becomes a candidate or which the person is appointed to
- 14 represent. If an at large member's residence is moved from the
- 15 first class school district during the at large member's term of
- 16 office, it constitutes a vacating of office.
- 17 (8) ALL OF THE FOLLOWING APPLY TO A BOARD MEMBER ELECTED UNDER
- 18 THIS SECTION AT THE 2005 NOVEMBER GENERAL ELECTION:
- 19 (A) THE INITIAL TERM OF OFFICE FOR EACH OF THOSE BOARD MEMBERS
- 20 IS CONTINUED UNTIL A SUCCESSOR IS ELECTED AND QUALIFIED AT THE 2010
- 21 NOVEMBER GENERAL ELECTION.
- 22 (B) SUCCESSORS FOR EACH OF THOSE BOARD MEMBERS SHALL BE
- 23 ELECTED FOR A TERM OF 4 YEARS AT THE 2010 NOVEMBER GENERAL ELECTION
- 24 AND EVERY 4 YEARS THEREAFTER.
- Sec. 412a. (1) This section applies to a first class school
- 26 district only if the question under section 410 is not approved in
- 27 the first class school district.

- 1 (2) In SUBJECT TO SUBSECTION (8), AT the next November general
- 2 election after the question under section 410 is presented to the
- 3 school electors of the first class school district, 7 members of
- 4 the board of a first class school district shall be elected by
- 5 voting districts for an initial term of 2 years. At SUBJECT TO
- 6 SUBSECTION (8), AT the November general election held 2 years after
- 7 that election and every 4 years thereafter, 7 members of the board
- 8 shall be elected by voting districts for a term of 4 years. Each
- 9 member shall represent a voting district described in section 404b.
- 10 (3) The members shall be nominated and elected by the
- 11 registered school electors of each voting district in the manner
- 12 provided by law for the nomination and election of the first class
- 13 school board members elected at large, except that the number of
- 14 signatures required on nominating petitions of a candidate for
- 15 election as a representative of a voting district shall be not less
- 16 than 250 or more than 500. A signature on a nominating petition is
- 17 not valid unless the petitioner is a registered school elector of
- 18 the voting district in which the candidate is running for election.
- 19 Not more than 2 candidates shall be nominated at the primary
- 20 election for each voting district.
- 21 (4) Candidates shall be nominated at a primary held in
- 22 conjunction with the preceding primary election conducted pursuant
- 23 to section 534 of the Michigan election law, 1954 PA 116, MCL
- 24 168.534. Nominating petitions shall meet the requirements of
- 25 section 544c of the Michigan election law, 1954 PA 116, MCL
- 26 168.544c, and shall be filed with the clerk of the city in which
- 27 the first class school district is located on or before 4 p.m. of

- 1 the twelfth Tuesday preceding the primary election. The city clerk
- 2 may compare the signatures on the petitions with the signatures
- 3 appearing on the registration records, or in some other proper
- 4 manner determine whether the signatures appearing on the petitions
- 5 are genuine and comply with the requirements of this section. With
- 6 the petitions, a candidate shall file an affidavit as provided in
- 7 section 558 of the Michigan election law, 1954 PA 116, MCL 168.558.
- 8 (5) The 7 board members elected to represent the voting
- 9 districts shall commence their terms of office on January 1
- 10 following the election.
- 11 (6) A candidate for the office of board member representing a
- 12 voting district or a person appointed to fill a vacancy pursuant to
- 13 subsection (7) shall be 18 years of age or older at the time of his
- 14 or her election or appointment and shall be a registered school
- 15 elector residing in the voting district in which the person becomes
- 16 a candidate or which the person is appointed to represent. If a
- 17 voting district member's residence is moved from the voting
- 18 district during the voting district member's term of office, this
- 19 constitutes a vacating of office.
- 20 (7) If a vacancy occurs on the first class school district
- 21 board from among the voting district members, the vacancy shall be
- 22 filled from among registered school electors of the voting district
- 23 by majority vote of the remaining first class school district board
- 24 members. If a person is appointed to fill a vacancy in a voting
- 25 district for which the unexpired term is more than 1 year and 8
- 26 months, that person shall serve until January 1 following the next
- 27 general election. At that next general election the vacancy shall

- 1 be filled for the unexpired term. A vacancy shall not be filled
- 2 later than 60 days before a primary election at which voting
- 3 district board members are to be nominated.
- 4 (8) ALL OF THE FOLLOWING APPLY TO A BOARD MEMBER ELECTED UNDER
- 5 THIS SECTION AT THE 2005 NOVEMBER GENERAL ELECTION:
- 6 (A) THE INITIAL TERM OF OFFICE FOR EACH OF THOSE BOARD MEMBERS
- 7 IS CONTINUED UNTIL A SUCCESSOR IS ELECTED AND QUALIFIED AT THE 2008
- 8 NOVEMBER GENERAL ELECTION.
- 9 (B) SUCCESSORS FOR EACH OF THOSE BOARD MEMBERS SHALL BE
- 10 ELECTED FOR A TERM OF 4 YEARS AT THE 2008 NOVEMBER GENERAL ELECTION
- 11 AND EVERY 4 YEARS THEREAFTER.
- 12 Sec. 416. (1) This section applies to a first class school
- 13 district only if the question under section 410 is not approved in
- 14 the first class school district.
- 15 (2) The officers of the first class school district board
- 16 shall be a president, vice-president, secretary, and treasurer. The
- 17 SUBJECT TO SUBSECTION (7), THE board, a majority of which shall
- 18 constitute CONSTITUTES a quorum, shall elect its president and
- 19 vice-president biennially from among the members of the board. In
- 20 case of a vacancy in the office of president, the vice-president
- 21 shall succeed to the office of president for the balance of the
- 22 unexpired term. The secretary and treasurer shall be appointed by
- 23 the board but shall not be members of the board and shall receive a
- 24 salary fixed by the board.
- 25 (3) The president, vice-president, and secretary shall perform
- 26 the duties prescribed by the bylaws and regulations of the board.
- 27 The duties of the treasurer shall be determined by the school

- 1 district general superintendent, as approved by the board.
- 2 (4) The officers of the board who in the discharge of the
- 3 duties of their respective positions handle funds belonging to the
- 4 first class school district shall be required to give bonds for the
- 5 faithful performance of their duties in accordance with the bylaws
- 6 and regulations of the board. The premium of the bonds shall be
- 7 paid from the funds of the board.
- 8 (5) The school district treasurer shall have the custody of
- 9 all money belonging to the school district and shall pay out money
- 10 pursuant to section 433. The funds shall be deposited with
- 11 depositories selected by the board, and the interest derived shall
- 12 be paid into the general fund of the board.
- 13 (6) The board shall require from the school district treasurer
- 14 a separate bond of not less than \$200,000.00 to protect the funds
- 15 of the board.
- 16 (7) ALL OF THE FOLLOWING APPLY TO THE BOARD MEMBERS ELECTED BY
- 17 THE BOARD IN 2006 AS PRESIDENT AND VICE PRESIDENT OF THE BOARD:
- 18 (A) THE INITIAL TERM AS PRESIDENT AND VICE PRESIDENT FOR EACH
- 19 OF THOSE BOARD MEMBERS IS CONTINUED UNTIL A SUCCESSOR IS ELECTED BY
- 20 THE BOARD FOR EACH IN JANUARY OF 2009.
- 21 (B) SUCCESSORS FOR EACH OF THOSE OFFICERS AS DESCRIBED IN
- 22 SUBDIVISION (A) SHALL BE ELECTED BIENNIALLY BY THE BOARD AS
- 23 PROVIDED UNDER SUBSECTION (2).
