A bill to amend 2004 PA 46, entitled

"Public safety officers benefit act,"

by amending the title and section 2 (MCL 28.632) and by adding section 4a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

2	An act to provide compensation AND OTHER BENEFITS to
3	dependents of public safety officers who are killed or who are
4	permanently and totally disabled in the line of duty; to create the
5	public safety officers benefit fund; to prescribe the duties and

(a) "Commission" means the commission on law enforcement

- 16 (F) (e)—"Law enforcement officer" means an individual involved
- 17 in crime and juvenile delinquency control or reduction or
- 18 enforcement of the criminal law. Law enforcement officer includes
- 19 police, corrections, probation, parole, bailiffs, or other similar
- 20 court officers.
- 21 (G) (f) "Line of duty" means either of the following:
- (i) Any action which an officer whose primary function is crime
- 23 control or reduction, enforcement of the criminal law, or
- 24 suppression of fires is obligated or authorized by rule,
- 25 regulations, condition of employment or service, or law to perform,
- 26 including those social, ceremonial, or athletic functions to which
- 27 the officer is assigned, or for which the officer is compensated,

- 2 duty means any action the officer is so obligated or authorized to
- 3 perform in the course or controlling or reducing crime, enforcing

- 6 public employee member of a rescue squad or ambulance crew is

- 14 that permanently prevent a former public safety officer from

- 17 public agency in an official capacity, with or without
- 18 compensation, as a law enforcement officer, firefighter, EMERGENCY
- 19 FIRST RESPONDER, rescue squad member, or ambulance crew member.
- 20 (K) (j) "Surviving spouse" means the husband or wife of the
- 21 deceased officer at the time of the officer's death, and includes a
- 22 spouse living apart from the officer at the time of the officer's
- 23 death for any reason.
- 24 SEC. 4A. IF A PUBLIC SAFETY OFFICER DIES IN THE LINE OF DUTY,
- 25 THE STATE SHALL PROVIDE THE SURVIVING SPOUSE AND HIS OR HER
- 26 DEPENDENTS HEALTH INSURANCE COMPARABLE TO THE INSURANCE COVERAGE
- 27 THE PUBLIC SAFETY OFFICER WAS RECEIVING BEFORE HIS OR HER DEATH.

- 4 BIRTHDAY.
