A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1	Sec. 819. (1) Except as OTHERWISE provided in subsections (2)
2	and (3) THIS SECTION, revenue from the increases in fees provided
3	in the 1987 amendatory act that added this section PA 232 is
4	appropriated to the transportation economic development fund, and
5	shall not be appropriated for any other purpose in any act making
6	appropriations of state funds.

(2) For the fiscal year ending September 30, 1988, of the revenue from the increases in fees provided by the 1987 amendatory act that added this section PA 232, \$1,350,000.00 shall be
