## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1209. (1) AT LEAST ONCE EACH YEAR, THE BOARD OF A SCHOOL
- 2 DISTRICT SHALL CALCULATE AND PUBLISH A STATEMENT OF THE PERCENTAGE
- 3 OF THE SCHOOL DISTRICT'S GENERAL OPERATING BUDGET THAT IS EXPENDED
- 4 FOR INSTRUCTION, AS DEFINED BY THE NATIONAL CENTER FOR EDUCATION
- 5 STATISTICS.
- 6 (2) THE BOARD OF A SCHOOL DISTRICT SHALL PUBLISH THE
  - INFORMATION UNDER SUBSECTION (1) ON THE SCHOOL DISTRICT'S WEBSITE
- 8 AND EITHER IN THE ANNUAL EDUCATIONAL REPORT THAT IS REQUIRED FOR
- 9 EACH OF ITS SCHOOLS UNDER SECTION 1204A OR IN ANOTHER DISTRICTWIDE
- 10 PUBLICATION. THE BOARD ALSO SHALL ENSURE THAT THIS INFORMATION IS
