## **HOUSE BILL No. 4971**

June 21, 2007, Introduced by Reps. Bieda, Condino and Warren and referred to the Committee on Tax Policy.

A bill to amend 2000 PA 92, entitled

"Food law of 2000,"

(MCL 289.1101 to 289.8111) by adding section 4116a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 4116A. (1) AS USED IN THIS SECTION:
- 2 (A) "SMOKING" MEANS THAT TERM AS DEFINED IN SECTION 12905 OF
- 3 THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.12905.
- 4 (B) "SMOKING PERMIT" MEANS A PERMIT ISSUED TO A HOLDER OF A
- 5 FOOD SERVICE ESTABLISHMENT LICENSE THAT ALLOWS SMOKING ON THE
- 6 PREMISES.
- 7 (2) NOTWITHSTANDING ANY STATE LAW OR LOCAL ORDINANCE TO THE
  - CONTRARY, A LICENSEE THAT IS ISSUED A SMOKING PERMIT MAY ALLOW
  - SMOKING AND MAY ADVERTISE THE AVAILABILITY OF SMOKING IN THE FOOD
  - SERVICE ESTABLISHMENT, SUBJECT TO THE PROVISIONS OF SECTION 12905
