

HOUSE BILL No. 5057

July 24, 2007, Introduced by Reps. Donigan, Constan, Condino, Ebli, Mayes, Warren, Kathleen Law, Meisner, Miller, Alma Smith, Johnson, Byrnes, Cushingberry, Tobocman and Vagnozzi and referred to the Committee on Judiciary.

A bill to amend 1961 PA 236, entitled
"Revised judicature act of 1961,"
by amending section 181 (MCL 600.181), as added by 2003 PA 97.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 181. (1) The justice system fund is created in the state
2 treasury. The money in the fund shall be used as provided in this
3 section.

4 (2) The state treasurer shall credit to the justice system
5 fund deposits of proceeds from the collection of revenue from court
6 assessments and costs designated by law for deposit in the fund and
7 shall credit all income from investment credited to the fund by the
8 state treasurer. The state treasurer may invest money in the fund
9 in any manner authorized by law for the investment of state money.

1 However, an investment shall not interfere with any apportionment,
2 allocation, or payment of money as required by this section. The
3 unencumbered balance remaining in the fund at the end of a fiscal
4 year shall remain in the fund and shall not revert to the general
5 fund.

26 subdivision (a) shall be distributed as follows:

3 (ii) To the jail reimbursement program fund created in section

5 **12.05%** of the fund balance.

6 (iii) To the Michigan justice training fund created in section 5
7 of 1982 PA 302, MCL 18.425, ~~12.4%~~**12.05%** of the fund balance.

8 (iv) To the secretary of the legislative retirement system for
9 deposit with the state treasurer in the retirement fund created in
10 the Michigan legislative retirement system act, 1957 PA 261, MCL
11 38.1001 to 38.1080, ~~1.15%~~**1.12%** of the fund balance.

12 (v) To the drug treatment courts fund created in section 185,
13 ~~2.85%~~**2.77%** of the fund balance.

14 (vi) To the state forensic lab fund created in section 3 of the
15 forensic laboratory funding act, 1994 PA 35, MCL 12.203, ~~5.6%~~**5.44%**
16 of the fund balance.

17 (vii) To the state court fund created in section 151a, ~~13.3%~~
18 **12.93%** of the fund balance.

19 (viii) To the court equity fund created in section 151b, ~~25.5%~~
20 **24.79%** of the fund balance.

21 (ix) To the state treasurer for monitoring of collection and
22 distribution of fund receipts, 1% of the fund balance.

23 (x) To the state court administrative office for management
24 assistance and audit of trial court collections, 1% of the fund
25 balance.

26 (xi) **TO THE SEXUAL ASSAULT VICTIMS' MEDICAL FORENSIC**
27 **INTERVENTION AND TREATMENT FUND, 2.74% OF THE FUND BALANCE.**
