A bill to amend 1978 PA 59, entitled

"Condominium act,"

(MCL 559.101 to 559.276) by adding section 63a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 63A. (1) THE OFFICE OF THE CONDOMINIUM OMBUDSMAN IS
- 2 CREATED IN THE ADMINISTRATOR. THE CONDOMINIUM OMBUDSMAN SHALL
- 3 DEVELOP PROGRAMS TO DO ALL OF THE FOLLOWING:
- 4 (A) ASSIST THE PRIVATE SECTOR TO UNDERSTAND THEIR LEGAL RIGHTS
- 5 AND RESPONSIBILITIES UNDER THE LAW AND THE CONDOMINIUM DOCUMENTS.
- 6 (B) MONITOR AND REVIEW PROCEDURES AND DISPUTES CONCERNING
- 7 CONDOMINIUM ELECTIONS AND MEETINGS.
 - (C) ENCOURAGE AND FACILITATE VOLUNTARY MEETINGS WITH AND
 - BETWEEN CONDOMINIUM UNIT OWNERS, THE ASSOCIATION OF CO-OWNERS, THE

- 1 BOARD OF DIRECTORS FOR THE ASSOCIATION OF CO-OWNERS, AND OTHER

- 3 (D) ACT AS A NEUTRAL RESOURCE CONCERNING THE RIGHTS AND

- 12 (2) THE HEAD OF THE OFFICE OF THE CONDOMINIUM OMBUDSMAN SHALL
- 13 BE APPOINTED BY THE GOVERNOR. THE HEAD OF THE OFFICE OF THE
- 14 CONDOMINIUM OMBUDSMAN SHALL BE AN ATTORNEY LICENSED TO PRACTICE LAW
- 15 IN THIS STATE AND SHALL SERVE AT THE PLEASURE OF THE GOVERNOR. A
- 16 VACANCY IN THE OFFICE SHALL BE FILLED IN THE SAME MANNER AS THE

- 18 (3) AN OFFICER OR FULL-TIME EMPLOYEE OF THE CONDOMINIUM
- 19 OMBUDSMAN SHALL NOT DO ANY OF THE FOLLOWING:
- 20 (A) ENGAGE IN ANY OTHER BUSINESS OR PROFESSION.
- 21 (B) SERVE AS THE REPRESENTATIVE OR EMPLOYEE OF A POLITICAL
- 22 PARTY.
- 23 (C) RECEIVE REMUNERATION FOR ACTIVITIES ON BEHALF OF ANY
- 24 CANDIDATE FOR PUBLIC OFFICE.
- 25 (D) ENGAGE IN SOLICITATION OF VOTES FOR ANY CANDIDATE FOR
- 26 PUBLIC OFFICE.
- 27 (E) BECOME A CANDIDATE FOR PUBLIC OFFICE BEFORE RESIGNING FROM
