A bill to amend 1996 PA 195, entitled "Police officer's and fire fighter's survivor tuition act," by amending section 4 (MCL 390.1244).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 4. (1) Beginning in the 1996-1997 academic year, upon receiving an application under section 3(c), the department shall determine whether the applicant and the courses for which tuition waiver is sought meet the requirements of section 3 and, if so, shall approve the application and notify the state institution of higher education that the application has been approved.
 - (2) Beginning SUBJECT TO SUBSECTION (3), BEGINNING in the 1996-1997 academic year, upon application by the state institution

- 16 TIME ENROLLMENT IN THE ACADEMIC DEGREE PROGRAM IN WHICH HE OR SHE
- 17 IS ENROLLED IF THAT ACTIVE DUTY MEMBER IS TRANSFERRED TO ACTIVE
- 18 DUTY OUTSIDE OF THIS STATE.
