A bill to amend 1919 PA 339, entitled

"Dog law of 1919,"

by amending section 1 (MCL 287.261), as amended by 1996 PA 63.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) This act shall be known and may be cited as the
- 2 "dog law of 1919".
- 3 (2) For the purpose of this act:
- 4 (a) "Livestock" means horses, stallions, colts, geldings,
- 5 mares, sheep, PRIVATELY OWNED CERVIDS, LLAMAS, ALPACAS, rams,
- 6 lambs, bulls, bullocks, steers, heifers, cows, calves, mules,
- 7 jacks, jennets, burros, goats, kids and swine, and fur-bearing
- 8 animals being raised in captivity.
- (b) "Poultry" means all domestic fowl, ornamental birds, and
- 10 game birds possessed or being reared under authority of a breeder's

- 1 license pursuant to part 427 (breeders and dealers) of the natural
- 2 resources and environmental protection act, Act No. 451 of the
- 3 Public Acts of 1994, being sections 324.42701 to 324.42714 of the
- 4 Michigan Compiled Laws 1994 PA 451, MCL 324.42701 TO 324.42714.
- 5 (c) "Owner" when applied to the proprietorship of a dog means
- 6 every person having a right of property in the dog, and every
- 7 person who keeps or harbors the dog or has it in his OR HER care,
- 8 and every person who permits the dog to remain on or about any
- 9 premises occupied by him OR HER.
- 10 (d) "Kennel" means any establishment wherein or whereon WHERE
- 11 dogs are kept for the purpose of breeding, sale, or sporting
- 12 purposes.
- (e) "Law enforcement officer" means any person employed or
- 14 elected by the people of the THIS state, or by any municipality,
- 15 county, or township, whose duty it is to preserve peace or to make
- 16 arrests or to enforce the law, and includes conservation officers
- 17 and members of the state police.
- 18 (f) "Hunting" means allowing a dog to range freely within
- 19 sight or sound of its owner while in the course of hunting legal
- 20 game or an unprotected animal.
- 21 (G) "PRIVATELY OWNED CERVID" MEANS THAT TERM AS DEFINED IN
- 22 SECTION 6 OF THE ANIMAL INDUSTRY ACT, 1988 PA 466, MCL 287.706.
