## **HOUSE BILL No. 5239**

September 15, 2007, Introduced by Reps. Sheltrown, Rick Jones, Agema, Stahl, Sak and Mayes and referred to the Committee on Military and Veterans Affairs and Homeland Security.

A bill to amend 1986 PA 102, entitled

"An act to establish a grant program for certain part-time, independent students in this state; and to prescribe the powers and duties of certain state agencies and institutions of higher education,"

by amending section 3 (MCL 390.1283), as amended by 2004 PA 180.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. A person is eliqible to participate in the grant
- 2 program if he or she meets all of the following:
- 3 (a) Is a part-time student.
- **4** (b) Is an independent student.
- 5 (c) Has not been enrolled in a high school diploma program
- 6 other than general educational development (GED) or adult education
- for at least the 2 preceding years.

- 1 (d) Is enrolled or accepted for enrollment in an undergraduate
- 2 program of not less than 9 months duration leading to a degree or
- 3 certificate from a Michigan degree granting educational institution
- 4 that is MEETS BOTH OF THE FOLLOWING:
- 5 (i) IS approved by the department of labor and economic growth.
- 6 (ii) CONSIDERS A STUDENT ENROLLED IN THAT INSTITUTION A
- 7 RESIDENT OF THIS STATE FOR DETERMINING HIS OR HER TUITION RATES IF
- 8 THE STUDENT IS ANY OF THE FOLLOWING:
- 9 (A) AN ACTIVE DUTY MEMBER, OR THE SPOUSE OR DEPENDENT CHILD OF
- 10 AN ACTIVE DUTY MEMBER, OF THE ARMED FORCES OF THE UNITED STATES,
- 11 WHILE THAT ACTIVE DUTY MEMBER IS STATIONED IN THIS STATE AND DURING
- 12 THE STUDENT'S CONTINUOUS ENROLLMENT IN THE ACADEMIC DEGREE PROGRAM
- 13 IN WHICH HE OR SHE IS ENROLLED IF THAT ACTIVE DUTY MEMBER IS
- 14 TRANSFERRED TO ACTIVE DUTY OUTSIDE OF THIS STATE.
- 15 (B) A CHILD OF AN ACTIVE DUTY MEMBER OF THE ARMED FORCES OF
- 16 THE UNITED STATES WHO WAS STATIONED IN THIS STATE BUT IS
- 17 TRANSFERRED TO A DUTY LOCATION OUTSIDE OF THIS STATE WITHIN THE 1-
- 18 YEAR PERIOD PRECEDING THE STUDENT'S INITIAL ENROLLMENT IN THAT
- 19 INSTITUTION AND THE STUDENT CONTINUES TO LIVE IN THIS STATE.
- (e) Has resided continuously in this state for the immediately
- 21 preceding 12 months and is not considered a resident of any other
- 22 state.
- 23 (f) Is not incarcerated in a corrections institution.
- 24 (g) Has complied with this act and the rules promulgated under
- 25 this act by the authority.
- 26 (h) Is a United States citizen or permanent resident.
- 27 (i) Is not enrolled in an institution whose primary purpose is

- 1 to prepare students for ordination or appointment as a member of
- 2 the clergy of a church, denomination, or religious association,
- 3 order, or sect.
- 4 (j) Is not in default on a loan guaranteed by the authority.
- 5 (k) Is shown by the school to be making satisfactory academic
- 6 progress.
