

HOUSE BILL No. 5355

October 24, 2007, Introduced by Rep. McDowell and referred to the Committee on Appropriations.

A bill to amend 1989 PA 196, entitled

"An act to abolish the criminal assessments commission; to prescribe certain duties of the crime victim services commission; to create the crime victim's rights fund; to provide for expenditures from the fund; to provide for assessments against criminal defendants and certain juvenile offenders; to provide for payment of crime victim's rights services; and to prescribe the powers and duties of certain state and local agencies and departments,"

by amending sections 1, 4, and 8 (MCL 780.901, 780.904, and 780.908), sections 1 and 4 as amended by 1996 PA 520 and section 8 as amended by 1993 PA 345.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. As used in this act:

2 (a) "Commission" means the crime victim services commission

10 (d) "Felony" means a violation of a penal law of this state
11 for which the offender, upon conviction, may be punished by
12 imprisonment for more than 1 year or an offense expressly
13 designated by law to be a felony.

14 (e) "Fund" means the crime victim's rights fund created under
15 section 4.

16 (f) "Juvenile offense" means an offense committed by a
17 juvenile under the jurisdiction of the juvenile division of the
18 probate court or the family division of circuit court under section
19 2(a)(1) of chapter XIIIA of ~~Act No. 288 of the Public Acts of 1939,~~
20 ~~being section 712A.2 of the Michigan Compiled Laws~~ **THE PROBATE CODE**

22 would be a felony, serious misdemeanor, or a specified misdemeanor

19 ~~Sec. 4. (1) The crime victim's rights fund is created as a~~
 20 ~~separate fund in the state treasury. The state treasurer shall~~
 21 ~~credit to the fund all amounts received under this act and as~~
 22 ~~provided by law. The state treasurer shall invest fund money in the~~
 23 ~~same manner as surplus funds are invested under section 3 of Act~~
 24 ~~No. 105 of the Public Acts of 1855, being section 21.143 of the~~
 25 ~~Michigan Compiled Laws 1855 PA 105, MCL 21.143. Earnings from the~~
 26 ~~fund shall be credited to the fund.~~

1 Amounts in the fund in excess of the necessary revenue determined
2 by the commission under section 3(a) may be used for crime victims'
