- 1 PART 96A. CLINICAL TRIALS HUMAN SUBJECT RESEARCH
- 2 SEC. 9651. AS USED IN THIS PART:
- 3 (A) "CLINICAL TRIAL" MEANS A CLINICAL INVESTIGATION APPROVED
- 4 BY THE FEDERAL FOOD AND DRUG ADMINISTRATION THAT INVOLVES ANY
- 5 EXPERIMENT TO TEST THE SAFETY OR EFFICACY OF A DRUG OR BIOLOGICAL
- 6 PRODUCT AND 1 OR MORE HUMAN SUBJECTS AND IS INTENDED TO BE
- 7 SUBMITTED TO, OR HELD FOR INSPECTION BY, THE FEDERAL FOOD AND DRUG
- 8 ADMINISTRATION AS PART OF AN APPLICATION FOR A RESEARCH OR
- 9 MARKETING PERMIT.
