

HOUSE BILL No. 5503

December 1, 2007, Introduced by Reps. Opsommer, Horn, Meekhof, Rick Jones and Emmons and referred to the Committee on Tax Policy.

A bill to amend 1933 PA 167, entitled
"General sales tax act,"
by amending section 25 (MCL 205.75), as amended by 2007 PA 69.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 25. (1) All money received and collected under this act
2 shall be deposited by the department in the state treasury to the
3 credit of the general fund, except as otherwise provided in this
4 section.

5 (2) Fifteen percent of the collections of the tax imposed at a
6 rate of 4% shall be distributed to cities, villages, and townships
7 pursuant to the Glenn Steil state revenue sharing act of 1971, 1971
8 PA 140, MCL 141.901 to 141.921.

9 (3) Sixty percent of the collections of the tax imposed at a

1 rate of 4% shall be deposited in the state school aid fund
2 established in section 11 of article IX of the state constitution
3 of 1963 and distributed as provided by law. In addition, all of the
4 collections of the tax imposed at the additional rate of 2%
5 approved by the electors March 15, 1994 shall be deposited in the
6 state school aid fund.

7 (4) For the fiscal year ending September 30, 1988 and each
8 fiscal year ending after September 30, 1988, of the 25% of the
9 collections of the general sales tax imposed at a rate of 4%
10 directly or indirectly on fuels sold to propel motor vehicles upon
11 highways, on the sale of motor vehicles and on the sale of the
12 parts and accessories of motor vehicles by new and used car
13 businesses, used car businesses, accessory dealer businesses, and
14 gasoline station businesses as classified by the department of
15 treasury remaining after the allocations and distributions are made
16 pursuant to subsections (2) and (3), the following amounts shall be
17 deposited each year into the respective funds:

18 (a) For the fiscal year ending September 30, 2003 and for the
19 fiscal year ending September 30, 2006 and each fiscal year ending
20 after September 30, 2006, not less than 27.9% to the comprehensive
21 transportation fund. For the fiscal year ending September 30, 2004
22 through the fiscal year ending September 30, 2005, not less than
23 24% to the comprehensive transportation fund. For the fiscal year
24 ending September 30, 2006 only, the amount deposited to the
25 comprehensive transportation fund under this subdivision shall be
26 reduced by \$11,100,000.00. For the fiscal year ending September 30,
27 2007 only, the amount deposited to the comprehensive transportation

1 fund under this subdivision shall be reduced by \$10,270,000.00.

2 (b) The balance to the state general fund.

3 (5) After the allocations and distributions are made pursuant
4 to subsections (2) and (3), an amount equal to the collections of
5 the tax imposed at a rate of 4% under this act from the sale at
6 retail of computer software as defined in section 1a shall be
7 deposited in the Michigan health initiative fund created in section
8 5911 of the public health code, 1978 PA 368, MCL 333.5911, and
9 shall be considered in addition to, and is not intended as a
10 replacement for any other money appropriated to the department of
11 community health. The funds deposited in the Michigan health
12 initiative fund on an annual basis shall not be less than
13 \$9,000,000.00 or more than \$12,000,000.00.

14 (6) AFTER THE ALLOCATIONS AND DISTRIBUTIONS ARE MADE PURSUANT
15 TO SUBSECTIONS (2) THROUGH (5), \$8,000,000.00 OF THE COLLECTIONS OF
16 THE TAX IMPOSED AT A RATE OF 4% UNDER THIS ACT SHALL BE DEPOSITED
17 EACH YEAR INTO THE GAME AND FISH PROTECTION ACCOUNT OF THE MICHIGAN
18 CONSERVATION AND RECREATION LEGACY FUND ESTABLISHED UNDER SECTION
19 40 OF ARTICLE IX OF THE STATE CONSTITUTION OF 1963.

20 (7) AFTER THE ALLOCATIONS AND DISTRIBUTIONS ARE MADE PURSUANT
21 TO SUBSECTIONS (2) THROUGH (6), \$1,000,000.00 OF THE COLLECTIONS OF
22 THE TAX IMPOSED AT A RATE OF 4% UNDER THIS ACT SHALL BE DEPOSITED
23 INTO A RESTRICTED FUND IN THE STATE GENERAL FUND, WHICH RESTRICTED
24 FUND SHALL BE ADMINISTERED BY THE DEPARTMENT OF NATURAL RESOURCES
25 AND USED ONLY FOR THE PROGRAMS OF CONSERVATION DISTRICTS CREATED
26 UNDER PART 93 OF THE NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION
27 ACT, 1994 PA 451, MCL 324.9301 TO 324.9313.

1 (8) ~~(6)~~—The balance in the state general fund shall be
2 disbursed only on an appropriation or appropriations by the
3 legislature.
