## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 629. (1) WHEN 1 OR MORE CUSTOMERS ESTABLISH A JOINT

ACCOUNT AT AN ASSOCIATION, THE ASSOCIATION SHALL PROVIDE TO EACH

JOINT ACCOUNT HOLDER A WRITTEN SUMMARY OF THAT ACCOUNT HOLDER'S

RIGHTS AND RESPONSIBILITIES CONCERNING USE OF THE JOINT ACCOUNT.

(2) IF THE TERMS OF A JOINT ACCOUNT DESCRIBED IN SUBSECTION

(1) WILL ALLOW EACH ACCOUNT HOLDER TO WITHDRAW ALL OF THE MONEY IN

THE ACCOUNT WITHOUT NOTICE TO OR CONSENT OF ANY OTHER ACCOUNT

HOLDERS, AND PROVIDE THAT THE SURVIVING ACCOUNT HOLDERS WILL BECOME

THE OWNERS OF THAT ACCOUNT WHEN AN ACCOUNT HOLDER DIES, THEN, IN

- 7 OF THE MONEY IN THIS ACCOUNT. THIS MEANS THAT YOU AND EACH OF THE
- 8 OTHER ACCOUNT HOLDERS HAVE THE AUTHORITY TO DEPOSIT OR WITHDRAW
- 9 MONEY FROM THIS ACCOUNT AT ANY TIME.
- 10 IF THAT IS NOT YOUR INTENTION, YOU SHOULD NOT OPEN THIS
- 11 ACCOUNT.
- 12 IF IT IS YOUR INTENTION THAT THE OTHER ACCOUNT HOLDER OR
- 13 ACCOUNT HOLDERS RECEIVE THE MONEY IN THE ACCOUNT ONLY WHEN YOU DIE,
- 14 THERE ARE OTHER TYPES OF ACCOUNTS AVAILABLE THAT DESIGNATE OTHER
- 15 INDIVIDUALS AS BENEFICIARIES OF THE ACCOUNT AND DO NOT ALLOW THEM
- 16 ACCESS TO THE MONEY IN THE ACCOUNT DURING YOUR LIFETIME.
- 17 IF IT IS YOUR INTENTION TO OPEN AN ACCOUNT THAT DESIGNATES 1
- 18 OR MORE INDIVIDUALS AS BENEFICIARIES OF YOUR ACCOUNT WHEN YOU DIE,
- 19 AND NOT TO CREATE A JOINT ACCOUNT, PLEASE LET US KNOW.".
- 20 (B) READ THE DISCLOSURE DESCRIBED IN SUBDIVISION (A) TO EACH
- 21 ACCOUNT HOLDER.
- 22 (C) REQUIRE EACH ACCOUNT HOLDER TO SIGN AND DELIVER TO THE
- 23 ASSOCIATION AN ACKNOWLEDGMENT THAT THE BANK HAS COMPLIED WITH ITS
- 24 OBLIGATIONS UNDER THIS SUBSECTION.
