THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2212C. (1) AN INSURER THAT DELIVERS, ISSUES FOR DELIVERY,
- 2 OR RENEWS IN THIS STATE AN EXPENSE-INCURRED HOSPITAL, MEDICAL, OR
- 3 SURGICAL POLICY OR CERTIFICATE THAT PROVIDES FOR COVERAGE FOR
- 4 DENTAL SERVICES AND A HEALTH MAINTENANCE ORGANIZATION THAT ISSUES A
- 5 HEALTH MAINTENANCE ORGANIZATION CONTRACT THAT PROVIDES FOR COVERAGE
- 6 FOR DENTAL SERVICES SHALL INCLUDE ON ANY EXPLANATION OF BENEFITS OR
- 7 SIMILAR COMMUNICATION TO AN INSURED OR ENROLLEE FOR DENTAL SERVICE
- 8 WHERE THE INSURER OR HEALTH MAINTENANCE ORGANIZATION IS PAYING THE
 - MAXIMUM COVERED BENEFIT AMOUNT ALL OF THE FOLLOWING:
 - (A) THAT THE AMOUNT PAID OR TO BE PAID IS THE MAXIMUM AMOUNT
