- 4 (A) IS AT LEAST 16 YEARS OF AGE BUT LESS THAN 17-1/2 YEARS OF

- 6 (B) HAS BEEN ISSUED EITHER A GRADUATED LICENSING STATUS TO
 - OPERATE A MOTOR VEHICLE UNDER SECTION 310E OF THE MICHIGAN VEHICLE
 - CODE, 1949 PA 300, MCL 257.310E, OR AN OFFICIAL STATE PERSONAL
- 9 IDENTIFICATION CARD UNDER 1972 PA 222, MCL 28.291 TO 28.300.
 - (C) IS A CITIZEN OF THE UNITED STATES.
