## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 337. (1) THE ADJUTANT GENERAL MAY AUTHORIZE A PERSON
- 2 ENGAGED IN THE PRODUCTION OF A FILM IN THIS STATE TO USE WITHOUT
- 3 CHARGE PROPERTY OWNED OR UNDER THE CONTROL OF THE DEPARTMENT OF
- 4 MILITARY AND VETERANS AFFAIRS FOR THE PURPOSE OF PRODUCING A FILM
- 5 UNDER TERMS AND CONDITIONS ESTABLISHED BY THE ADJUTANT GENERAL. THE
  - ECONOMIC AND OTHER BENEFITS TO THIS STATE OF FILM PRODUCTION
  - LOCATED IN THIS STATE SHALL BE DEEMED TO BE THE VALUE RECEIVED BY
- 8 THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS IN EXCHANGE FOR THE
- USE OF PROPERTY UNDER THIS SECTION.

- 17 TELEVISION SERIES, A TELEVISION MINISERIES, A TELEVISION SPECIAL,
