March 4, 2008, Introduced by Reps. Clemente, Griffin, Coulouris, Robert Jones, Meisner, Pastor, Hammel, Vagnozzi and Huizenga and referred to the Committee on New Economy and Quality of Life.

A bill to amend 2007 PA 36, entitled

"Michigan business tax act,"

(MCL 208.1101 to 208.1601) by adding section 431c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 431C. (1) EXCEPT AS OTHERWISE PROVIDED UNDER THIS
- 2 SECTION, A QUALIFIED TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX
- 3 IMPOSED BY THIS ACT EQUAL TO THE SUM OF UP TO 5.0% OF THE TAXABLE
- 4 VALUE OF EACH QUALIFIED SUPPLIER'S OR CUSTOMER'S TAXABLE PROPERTY
- 5 THAT IS LOCATED WITHIN THE 10-MILE RADIUS OF THE QUALIFIED TAXPAYER
- 6 AND THAT IS SUBJECT TO COLLECTION OF GENERAL AD VALOREM TAXES UNDER
- 7 THE GENERAL PROPERTY TAX ACT, 1893 PA 206, MCL 211.1 TO 211.155,
- 8 FOR A PERIOD OF UP TO 5 YEARS, AS DETERMINED BY THE MICHIGAN
- 9 ECONOMIC GROWTH AUTHORITY. IF A QUALIFIED SUPPLIER'S OR CUSTOMER'S
- 10 TAXABLE PROPERTY IS SUBJECT TO THE SPECIFIC TAX LEVIED UNDER 1974

- 1 PA 198, MCL 207.551 TO 207.572, THE QUALIFIED TAXPAYER MAY ONLY
- 2 INCLUDE UP TO 2.5% OF THE TAXABLE VALUE OF THAT PROPERTY IN THE
- 3 CALCULATION OF THE AMOUNT OF THE CREDIT ALLOWED UNDER THIS SECTION.
- 4 THE MICHIGAN ECONOMIC GROWTH AUTHORITY SHALL NOT DESIGNATE MORE
- 5 THAN 5 TAXPAYERS AS AN ANCHOR COMPANY IN EACH CALENDAR YEAR AND
- 6 SHALL NOT APPROVE MORE THAN 5 NEW CREDITS IN EACH CALENDAR YEAR
- 7 UNDER THIS SUBSECTION. A TAXPAYER HAS 5 YEARS FROM THE DATE ON
- 8 WHICH THE TAXPAYER IS DESIGNATED AS AN ANCHOR COMPANY TO SEEK
- 9 CERTIFICATION AS A QUALIFIED TAXPAYER FOR EACH QUALIFIED SUPPLIER
- 10 OR CUSTOMER FOR WHICH A CREDIT IS SOUGHT UNDER THIS SECTION.
- 11 (2) A TAXPAYER SHALL NOT CLAIM A CREDIT UNDER THIS SECTION
- 12 UNLESS THE MICHIGAN ECONOMIC GROWTH AUTHORITY HAS ISSUED A
- 13 CERTIFICATE TO THE QUALIFIED TAXPAYER. HOWEVER, A CREDIT SHALL NOT
- 14 BE PROVIDED FOR A TAX YEAR PRIOR TO THE TAX YEAR DURING WHICH THE
- 15 CERTIFICATION IS ISSUED. THE QUALIFIED TAXPAYER SHALL ATTACH THE
- 16 CERTIFICATE TO THE ANNUAL RETURN FILED UNDER THIS ACT ON WHICH THE
- 17 CREDIT UNDER THIS SECTION IS CLAIMED. THE CERTIFICATE REQUIRED BY
- 18 THIS SUBSECTION SHALL STATE ALL OF THE FOLLOWING:
- 19 (A) THE TAXPAYER IS A QUALIFIED TAXPAYER AND THE DATE ON WHICH
- 20 THE TAXPAYER WAS DESIGNATED AS AN ANCHOR COMPANY.
- 21 (B) THE AMOUNT OF THE CREDIT UNDER THIS SECTION FOR THE
- 22 TAXPAYER FOR THE DESIGNATED TAX YEAR.
- 23 (C) THE TAXPAYER'S FEDERAL EMPLOYER IDENTIFICATION NUMBER OR
- 24 THE MICHIGAN DEPARTMENT OF TREASURY NUMBER ASSIGNED TO THE
- 25 TAXPAYER.
- 26 (3) A TAXPAYER THAT CLAIMS A CREDIT UNDER THIS SECTION AND
- 27 SUBSEQUENTLY FAILS TO MEET THE REQUIREMENTS OF THIS SECTION OR ANY

- 1 OTHER CONDITIONS ESTABLISHED BY THE MICHIGAN ECONOMIC GROWTH
- 2 AUTHORITY IN ORDER TO OBTAIN A CERTIFICATE FOR WHICH THE CREDIT WAS
- 3 CLAIMED UNDER THIS SECTION MAY, AS TO BE DETERMINED BY THE MICHIGAN
- 4 ECONOMIC GROWTH AUTHORITY, HAVE ITS CREDIT REDUCED OR TERMINATED OR
- 5 HAVE A PERCENTAGE OF THE CREDIT AMOUNT PREVIOUSLY CLAIMED UNDER
- 6 THIS SECTION ADDED BACK TO THE TAX LIABILITY OF THE TAXPAYER IN THE
- 7 YEAR THAT THE TAXPAYER FAILS TO COMPLY WITH THIS SECTION OR THE
- 8 AGREEMENT.
- 9 (4) IF THE CREDIT ALLOWED UNDER THIS SUBSECTION EXCEEDS THE
- 10 LIABILITY OF THE TAXPAYER FOR THE TAX YEAR, THE TAXPAYER MAY ELECT
- 11 TO HAVE THAT PORTION THAT EXCEEDS THE TAX LIABILITY OF THE TAXPAYER
- 12 REFUNDED OR TO HAVE THE EXCESS CARRIED FORWARD TO OFFSET TAX
- 13 LIABILITY IN SUBSEQUENT YEARS FOR 5 YEARS OR UNTIL IT IS USED UP,
- 14 WHICHEVER OCCURS FIRST.
- 15 (5) AS USED IN THIS SECTION:
- 16 (A) "ANCHOR COMPANY" MEANS A QUALIFIED HIGH-TECHNOLOGY
- 17 BUSINESS THAT IS AN INTEGRAL PART OF A HIGH-TECHNOLOGY ACTIVITY AND
- 18 THAT HAS THE ABILITY OR POTENTIAL ABILITY TO INFLUENCE BUSINESS
- 19 DECISIONS AND SITE LOCATION OF QUALIFIED SUPPLIERS AND CUSTOMERS.
- 20 (B) "BUSINESS", "QUALIFIED HIGH-TECHNOLOGY ACTIVITY", AND
- 21 "QUALIFIED HIGH-TECHNOLOGY BUSINESS" MEAN THOSE TERMS AS DEFINED IN
- 22 THE MICHIGAN ECONOMIC GROWTH AUTHORITY ACT, 1995 PA 24, MCL 207.801
- 23 TO 207.810.
- 24 (C) "FULL-TIME JOB" MEANS A JOB PERFORMED BY AN INDIVIDUAL FOR
- 25 35 HOURS OR MORE EACH WEEK AND WHOSE INCOME AND SOCIAL SECURITY
- 26 TAXES ARE WITHHELD BY 1 OR MORE OF THE FOLLOWING:
- 27 (i) A QUALIFIED SUPPLIER OR CUSTOMER.

- 1 (ii) AN EMPLOYEE LEASING COMPANY ON BEHALF OF A QUALIFIED
- 2 SUPPLIER OR CUSTOMER.
- 3 (iii) A PROFESSIONAL EMPLOYER ORGANIZATION ON BEHALF OF A
- 4 QUALIFIED SUPPLIER OR CUSTOMER.
- 5 (D) "MICHIGAN ECONOMIC GROWTH AUTHORITY" MEANS THE MICHIGAN
- 6 ECONOMIC GROWTH AUTHORITY CREATED IN THE MICHIGAN ECONOMIC GROWTH
- 7 AUTHORITY ACT, 1995 PA 24, MCL 207.801 TO 207.810.
- 8 (E) "QUALIFIED NEW JOB" MEANS A FULL-TIME JOB CREATED BY A
- 9 QUALIFIED SUPPLIER OR CUSTOMER AT A FACILITY OR FACILITIES THAT IS
- 10 IN EXCESS OF THE NUMBER OF FULL-TIME JOBS A QUALIFIED SUPPLIER OR
- 11 CUSTOMER MAINTAINED IN THIS STATE OR FACILITY PRIOR TO THE
- 12 EXPANSION OR LOCATION, AS DETERMINED BY THE AUTHORITY.
- 13 (F) "QUALIFIED SUPPLIER OR CUSTOMER" MEANS A BUSINESS THAT
- 14 OPENS A NEW LOCATION IN THIS STATE, A BUSINESS THAT LOCATES IN THIS
- 15 STATE, OR AN EXISTING BUSINESS LOCATED IN THIS STATE THAT EXPANDS
- 16 ITS BUSINESS WITHIN THE LAST YEAR AS A RESULT OF AN ANCHOR COMPANY
- 17 AND SATISFIES, AS CERTIFIED BY THE MICHIGAN ECONOMIC GROWTH
- 18 AUTHORITY, EACH OF THE FOLLOWING:
- 19 (i) HAS FINANCIAL TRANSACTIONS WITH THE ANCHOR COMPANY.
- 20 (ii) SELLS A CRITICAL OR UNIQUE COMPONENT OR TECHNOLOGY
- 21 NECESSARY FOR THE ANCHOR COMPANY TO MARKET A FINISHED PRODUCT OR
- 22 BUYS A CRITICAL OR UNIQUE COMPONENT FROM THE ANCHOR COMPANY.
- 23 (iii) HAS CREATED MORE THAN 10 QUALIFIED NEW JOBS.
- 24 (iv) HAS MADE AN INVESTMENT OF AT LEAST \$1,000,000.00 AS
- 25 CERTIFIED BY THE MICHIGAN ECONOMIC GROWTH AUTHORITY.
- 26 (G) "OUALIFIED TAXPAYER" MEANS A TAXPAYER THAT WAS DESIGNATED
- 27 BY THE MICHIGAN ECONOMIC GROWTH AUTHORITY AS AN ANCHOR COMPANY

- 1 WITHIN THE LAST 5 YEARS AND THAT HAS INFLUENCED 1 OR MORE QUALIFIED
- 2 SUPPLIERS OR CUSTOMERS TO OPEN, LOCATE, OR EXPAND THEIR BUSINESS
- 3 AND CONDUCT BUSINESS ACTIVITY WITHIN A 10-MILE RADIUS OF THE ANCHOR
- 4 COMPANY.
