A bill to amend 1978 PA 368, entitled

"Public health code,"

(MCL 333.1101 to 333.25211) by adding section 22225a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 22225A. (1) IN ORDER TO BE APPROVED UNDER THIS PART, AN
- 2 APPLICANT FOR A CERTIFICATE OF NEED TO ACQUIRE OR BEGIN OPERATION
- 3 OF A NURSING HOME OR TO MAKE A CHANGE IN BED CAPACITY IN LICENSED
- 4 NURSING HOME BEDS SHALL FURNISH A SURETY BOND TO THE PEOPLE OF THE
- 5 STATE OF MICHIGAN. EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION,
- 6 THE AMOUNT OF THE SURETY BOND SHALL EQUAL OR EXCEED THE TOTAL COST
- 7 TO ACQUIRE OR BEGIN OPERATION OF A NURSING HOME OR TO MAKE THE
- 8 CHANGE IN BED CAPACITY IN LICENSED NURSING HOME BEDS, AS DETERMINED
- BY THE DEPARTMENT. THE AMOUNT OF THE SURETY BOND REQUIRED UNDER

- 1 THIS SUBSECTION SHALL NOT BE LESS THAN \$25,000.00 OR BE GREATER
- 2 THAN \$500,000.00. THE SURETY BOND SHALL BE CONDITIONED UPON THE

- 17 SECURITIES, LETTER OF CREDIT, OR ASSIGNMENT OF COVERAGE OF OTHER
- 18 BONDS, THE DEPARTMENT SHALL RETURN ANY REMAINING ASSETS OF THOSE
- 19 RESOURCES TO THE NURSING HOME.
- 20 (3) THE DEPARTMENT MAY BRING AN ACTION IN A COURT OF COMPETENT
- 21 JURISDICTION AGAINST THE NURSING HOME, ITS ASSETS, OR THE SURETY ON
- 22 THE BOND OR MAY TAKE ANY APPROPRIATE ACTION AGAINST THE ISSUER OF
- 23 THE DEPOSIT OF SECURITIES, LETTER OF CREDIT, OR ASSIGNMENT OF
- 24 COVERAGE OF OTHER BONDS FOR RECOVERY OF MONEY DUE AND OWING TO THE
- 25 DEPARTMENT UNDER THIS ACT.
- 26 (4) THE DEPARTMENT SHALL REQUIRE THAT THE SURETY BOND OR
- 27 DEPOSIT OF CASH OR SECURITIES, LETTER OF CREDIT, OR ASSIGNMENT OF

- 1 COVERAGE OF OTHER BONDS BE AND REMAIN IN EFFECT BEFORE ISSUANCE OR
