

HOUSE BILL No. 6279

June 25, 2008, Introduced by Reps. Moore, Nofs and Sheltroun and referred to the Committee on Government Operations.

A bill to amend 1984 PA 431, entitled
"The management and budget act,"
by amending section 298c (MCL 18.1298c), as added by 1988 PA 306.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 298c. The Michigan capitol park commission shall do all
2 of the following:

3 (a) Develop a master plan for, and manage the development and
4 operation of, the Michigan capitol park.

5 (b) Promulgate rules pursuant to the administrative procedures
6 act of 1969, ~~Act No. 306 of the Public Acts of 1969, being sections~~
7 ~~24.201 to 24.328 of the Michigan Compiled Laws 1969 PA 306, MCL~~
8 **24.201 TO 24.328**, necessary to carry out its powers and duties

1 under this section.

2 (c) Be responsible for the operation of programs, exclusive of
3 physical building management and maintenance, within the
4 jurisdiction of the Michigan capitol park commission as determined
5 under section 298b.

6 (d) Act as an advisory body to the department regarding the
7 development and operation of real property in Lansing not
8 designated as part of the Michigan capitol park under section 298b.

9 (e) Confer and cooperate with the Michigan capitol committee
10 in the execution of its duties under chapter 7 of the legislative
11 council act, ~~Act No. 268 of the Public Acts of 1986, being sections~~
12 ~~4.1701 to 4.1702 of the Michigan Compiled Laws 1986 PA 268, MCL~~
13 **4.1701 TO 4.1702.**

14 (f) Coordinate with the city of Lansing any state activities
15 or developments in and around the Michigan capitol park.

16 (g) Advise the department of state police regarding the
17 provision of police and security services for the Michigan capitol
18 park, and the enforcement of rules for the care and preservation of
19 the Michigan capitol park.

20 **(H) WHEN SUFFICIENT FUNDS ARE RECEIVED TO MEET THE COSTS OF**
21 **PLACEMENT, PLACE THE PLAQUE HONORING THE RIGHT TO BEAR ARMS UNDER**
22 **AMENDMENT II OF THE CONSTITUTION OF THE UNITED STATES AND UNDER**
23 **SECTION 6 OF ARTICLE I OF THE STATE CONSTITUTION OF 1963 THAT IS**
24 **DONATED TO THE MICHIGAN CAPITOL PARK COMMISSION BY BRASSROOTS.**

25 **(I)** ~~(h)~~ Annually report to the governor and the legislature on
26 the activities of the Michigan capitol park commission. The report
27 shall review the progress of, and any changes in, the master plan

1 as well as the development and operation of the Michigan capitol
2 park.
