## **HOUSE BILL No. 6614**

November 6, 2008, Introduced by Reps. Tobocman, Johnson, Jackson, Donigan, Robert Jones, Simpson, Spade, Valentine, Gonzales, Dean, Meadows, Cushingberry, Alma Smith and Leland and referred to the Committee on Banking and Financial Services.

A bill to amend 1961 PA 236, entitled
"Revised judicature act of 1961,"
by amending sections 3101, 3208, and 3216 (MCL 600.3101, 600.3208, and 600.3216), section 3101 as amended by 1981 PA 172.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3101. (1) The circuit court has jurisdiction to foreclose
  mortgages of real estate and land contracts. However, the
  procedures set forth in this chapter shall DOES not apply to
  mortgages of real estate and land contracts held by the Michigan
  state housing development authority.
  - (2) AFTER DECEMBER 14, 2008 AND UNTIL THE MICHIGAN HOME FORECLOSURE PREVENTION PROGRAM DEVELOPED UNDER SECTION 5 OF THE HOME FORECLOSURE PREVENTION ACT IS DISCONTINUED, IF SECTION 8 OF
