HOUSE BILL No. 6672

November 19, 2008, Introduced by Rep. Alma Smith and referred to the Committee on Tax Policy.

A bill to amend 1986 PA 102, entitled

"An act to establish a grant program for certain part-time, independent students in this state; and to prescribe the powers and duties of certain state agencies and institutions of higher education,"

by amending sections 3, 5, and 7 (MCL 390.1283, 390.1285, and 390.1287), section 3 as amended by 2004 PA 180; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3. A person is eligible to participate in the grantprogram if he or she meets all of the following:
 - (a) Is a part-time student.
 - (b) Is an independent student.
 - (c) Has not been enrolled in a high school diploma program

- 1 other than general educational development (GED) or adult education
- 2 for at least the 2 preceding years.
- 3 (d) Is enrolled or accepted for enrollment in an undergraduate
- 4 program of not less than 9 months duration leading to a degree or
- 5 certificate from a Michigan degree granting educational institution
- 6 that is approved by the department of labor and economic growth.
- 7 (e) Has resided continuously in this state for the immediately
- 8 preceding 12 months and is not considered a resident of any other
- 9 state.
- 10 (f) Is not incarcerated in a corrections institution.
- 11 (F) (g)—Has complied with this act and the rules promulgated
- 12 under this act by the authority.
- 13 (G) (h)—Is a United States citizen or permanent resident.
- 14 (H) (i)—Is not enrolled in an institution whose primary
- 15 purpose is to prepare students for ordination or appointment as a
- 16 member of the clergy of a church, denomination, or religious
- 17 association, order, or sect.
- 18 (I) (j)—Is not in default on a loan guaranteed by the
- **19** authority.
- 20 (J) (k)—Is shown by the school to be making satisfactory
- 21 academic progress.
- Sec. 5. (1) Upon application of an eligible student, an
- 23 educational institution shall grant to the student an amount of not
- 24 more than \$600.00 per academic year for not more than 2 12-month
- 25 periods at any given educational institution.
- 26 (2) If the number of eligible applicants exceeds the money
- 27 available, priority shall be given to persons with the greatest

- 1 financial need as determined by each educational institution.
- 2 (3) A student who receives a state competitive scholarship
- 3 award under Act No. 208 of the Public Acts of 1964, being sections
- 4 390.971 to 390.981 of the Michigan Compiled Laws 1964 PA 208, MCL
- 5 390.971 TO 390.981, or who receives other scholarships or grant
- 6 awards, may be eligible for funds under this act if the total
- 7 amount of the student's scholarships and grants is less than the
- 8 student's financial need. A student's scholarship and grant awards
- 9 may be increased with funds from the program under this act up to
- 10 the level of the maximum grant as provided in subsection (1).
- 11 (4) THE AUTHORITY SHALL NOT PROVIDE GRANTS UNDER THIS ACT IN
- 12 THE 2007-2008 ACADEMIC YEAR OR ANY SUBSEQUENT ACADEMIC YEAR.
- 13 (5) IF A STUDENT WAS AWARDED A GRANT UNDER THIS ACT BEFORE THE
- 14 2007-2008 ACADEMIC YEAR, THE AUTHORITY SHALL NOT PAY THE AMOUNT OF
- 15 THE GRANT OR ANY REMAINING UNPAID BALANCE OF THE GRANT TO THE
- 16 STUDENT OR THE APPROVED MICHIGAN DEGREE-GRANTING EDUCATIONAL
- 17 INSTITUTION ON BEHALF OF THE STUDENT AFTER SEPTEMBER 15, 2007.
- 18 (6) BEGINNING ON THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT
- 19 ADDED THIS SUBSECTION, THE AUTHORITY SHALL NOTIFY EACH NEW GRANT
- 20 RECIPIENT, EACH EXISTING GRANT RECIPIENT WHO HAS NOT RECEIVED ALL
- 21 OF HIS OR HER GRANT MONEY, AND EACH APPROVED MICHIGAN DEGREE-
- 22 GRANTING EDUCATIONAL INSTITUTION OF THE PENDING REPEAL OF THIS ACT
- 23 AND THE TIMETABLES DESCRIBED IN SUBSECTIONS (4) AND (5).
- 24 (7) AS USED IN THIS SECTION, "ACADEMIC YEAR" MEANS THE PERIOD
- 25 FROM AUGUST 1 OF A CALENDAR YEAR TO JULY 31 OF THE NEXT CALENDAR
- 26 YEAR.
- 27 Sec. 7. (1) The authority may accept gifts, grants, bequests,

- 1 donations, and devises, from whatever sources, of real, personal,
- 2 or mixed property and money for the purposes described in this act.
- 3 The authority shall prepare an annual report of all gifts, grants,
- 4 bequests, donations, and devises for the governor and the
- 5 legislature.
- 6 (2) ON SEPTEMBER 30, 2007, ANY RESTRICTED FUNDS OR OTHER MONEY
- 7 HELD BY THE AUTHORITY FOR PURPOSES OF THIS ACT SHALL REVERT TO THE
- 8 GENERAL FUND.
- 9 Enacting section 1. 1986 PA 102, MCL 390.1281 to 390.1288, is
- 10 repealed effective October 1, 2007.
- 11 Enacting section 2. This amendatory act does not take effect
- 12 unless Senate Bill No. or House Bill No. 6680 (request no.
- 13 01102'07) of the 94th Legislature is enacted into law.
