## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 88R. (1) THE FUND MAY MAKE LOANS AND ENTER INTO
- 2 AGREEMENTS WITH EMPLOYERS OR ISSUE BONDS UNDER SECTION 23 TO AN
- 3 EMPLOYER THAT HAS ENTERED INTO AN AGREEMENT WITH THE MICHIGAN
- 4 ECONOMIC GROWTH AUTHORITY UNDER THE MICHIGAN ECONOMIC GROWTH
- 5 AUTHORITY ACT, 1995 PA 24, MCL 207.801 TO 207.810, FOR ANY OF THE
  - FOLLOWING PURPOSES:
    - (A) TRAINING OR RETRAINING FOR NEW JOBS.
    - (B) ADULT BASIC EDUCATION AND JOB-RELATED INSTRUCTION.
    - (C) DEVELOPMENTAL, READINESS, AND REMEDIAL EDUCATION.
    - (D) VOCATIONAL AND SKILL-ASSESSMENT SERVICES AND TESTING.

- 2 (F) ADMINISTRATIVE EXPENSES FOR THE NEW JOBS TRAINING PROGRAM.
- 3 (G) SUBCONTRACTED SERVICES WITH PUBLIC UNIVERSITIES AND
