HOUSE BILL No. 6756

November 25, 2008, Introduced by Rep. LaJoy and referred to the Committee on Government Operations.

A bill to amend 1986 PA 268, entitled

"Legislative council act,"

by amending sections 782 and 783 (MCL 4.1782 and 4.1783), section 782 as added by 2007 PA 98 and section 783 as added by 2007 PA 99.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 782. (1) The legislative commission on statutory mandates
 is created within the legislative council.
- 3 (2) The commission shall consist of the following 5 members:
- 4 (a) One member appointed by the speaker of the house of5 representatives.
 - (b) One member appointed by the minority leader of the house of representatives.
 - (c) One member appointed by the majority leader of the senate.
 - (d) One member appointed by the minority leader of the senate.

- 1 (e) One member of the public jointly selected by the speaker
- 2 of the house of representatives and the majority leader of the
- 3 senate, who is an attorney licensed to practice in this state.
- 4 (3) The members first appointed to the commission shall be
- 5 appointed within 60 days after the effective date of the amendatory
- 6 act that added this chapter OCTOBER 1, 2007.
- 7 (4) Members of the commission shall serve for a term of 3
- 8 years. A member of the commission shall discharge the duties of his
- 9 or her position in a nonpartisan manner, with good faith, and with
- 10 that degree of diligence, care, and skill that an ordinarily
- 11 prudent person would exercise under similar circumstances in a like
- 12 position.
- 13 (5) Legislators and other state employees are not eligible to
- 14 be a member of the commission. Members of the commission shall be
- 15 individuals who have knowledge of, education in, or experience with
- 16 the best practices of 1 or more of the following fields:
- 17 (a) Organizational efficiency.
- 18 (b) Government operations.
- 19 (c) Public finance.
- 20 (d) Administrative law.
- 21 (6) If a vacancy occurs on the commission, the member shall be
- 22 replaced in the same manner as the original appointment.
- 23 (7) The first meeting of the commission shall be called by the
- 24 majority leader of the senate not later than 60 days after the
- 25 effective date of the amendatory act that added this chapter
- 26 OCTOBER 1, 2007. The member appointed by the majority leader of the
- 27 senate and the member appointed by the speaker of the house of

- 1 representatives shall be co-chairpersons of the commission. The
- 2 chairperson position shall rotate each month between the co-
- 3 chairpersons. The member appointed by the majority leader of the
- 4 senate shall be the chairperson of the commission for the first
- 5 month. At the first meeting, the commission shall elect from among
- 6 its members other officers as it considers necessary or
- 7 appropriate. After the first meeting, the commission shall meet at
- 8 least monthly, or more frequently at the call of the chairperson
- 9 for that month or if requested by 3 or more members.
- 10 (8) A majority of the members of the commission constitute a
- 11 quorum for the transaction of business at a meeting of the
- 12 commission. A majority of the members are required for official
- 13 action of the commission.
- 14 (9) The business that the commission may perform shall be
- 15 conducted at a public meeting of the commission held in compliance
- 16 with the open meetings act, 1976 PA 267, MCL 15.261 to 15.275.
- 17 (10) A writing prepared, owned, used, in the possession of, or
- 18 retained by the commission in the performance of an official
- 19 function is subject to the freedom of information act, 1976 PA 442,
- 20 MCL 15.231 to 15.246.
- 21 (11) Members of the commission shall serve without
- 22 compensation. However, members of the commission may be reimbursed
- 23 for reasonable and necessary expenses incurred in the performance
- 24 of their official duties as members of the commission subject to
- 25 available appropriations.
- 26 (12) Not later than December 31, 2008 JUNE 30, 2009, the
- 27 commission shall do COMPILE all of the following IN AN INTERIM

- 1 REPORT TO EACH HOUSE OF THE LEGISLATURE AND THE GOVERNOR:
- 2 (a) Review and investigate all THE MOST SIGNIFICANT funded and
- 3 unfunded mandates imposed on local units of government in state law
- 4 AS IDENTIFIED BY THOSE LOCAL UNITS OF GOVERNMENT.
- 5 (b) Review and investigate all THE MOST SIGNIFICANT reporting
- 6 requirements imposed on local units of government in state law AS
- 7 IDENTIFIED BY THOSE LOCAL UNITS OF GOVERNMENT.
- 8 (c) Determine the complete THE RANGE OF cost TO LOCAL UNITS OF
- 9 GOVERNMENT of COMPLYING WITH each funded and unfunded mandate
- 10 imposed on a local unit of government in state law IDENTIFIED IN
- 11 SUBDIVISION (A).
- 12 (d) Determine the complete THE RANGE OF cost TO LOCAL UNITS OF
- 13 GOVERNMENT of COMPLYING WITH each reporting requirement imposed on
- 14 a local unit of government in state law IDENTIFIED IN SUBDIVISION
- 15 (B).
- 16 (13) Not later than October 1, 2009 DECEMBER 31, 2009, the
- 17 commission shall make specific determinations of the items
- 18 described in subsection (12) and report those determinations to
- 19 each house of the legislature and the governor. The commission
- 20 shall also make an interim report to each house of the legislature
- 21 and the governor on the status of its determinations of the items
- 22 described in subsection (12) not later than June 1, 2009.
- 23 (14) The governor may direct that state agencies subject to
- 24 the supervision of the governor under section 8 of article V of the
- 25 state constitution of 1963 provide information to the commission to
- 26 assist the commission in fulfilling its duties under this section.
- 27 Upon request of the commission, the commission shall be given

- 1 access to all information, records, and documents in the possession
- 2 of a state agency that the commission considers necessary to
- 3 fulfill its duties under this section. The commission may hold
- 4 hearings and may request that any person appear before the
- 5 commission, or at a hearing, and give testimony or produce
- 6 documentary or other evidence that the commission considers
- 7 relevant to its duties under this section.
- 8 (15) In connection with its duties under this section, the
- 9 commission may request the legislative council to issue a subpoena
- 10 to compel the attendance and testimony of witnesses before the
- 11 commission or to compel the production of a book, account, paper,
- 12 document, or record related to the duties of the commission under
- 13 this section. The legislative council may issue the subpoena only
- 14 upon the concurrence of a majority of the house members and a
- 15 majority of the senate members of the legislative council. A person
- 16 who refuses to comply with a subpoena issued by the legislative
- 17 council under this subsection may be punished as for contempt of
- 18 the legislature.
- 19 (16) AS USED IN THIS SECTION, "LOCAL UNIT OF GOVERNMENT"
- 20 INCLUDES CITIES, TOWNSHIPS, VILLAGES, COUNTIES, SCHOOL DISTRICTS,
- 21 INTERMEDIATE SCHOOL DISTRICTS, COMMUNITY COLLEGES, AND COUNTY ROAD
- 22 COMMISSIONS.
- 23 Sec. 783. In addition to the report required under section
- 24 782, not later than December 1, 2009, the commission shall report
- 25 to each house of the legislature THE COMMISSION SHALL INCLUDE IN
- 26 THE REPORT REQUIRED UNDER SECTION 782(13) recommendations on how to
- 27 consolidate, streamline, or eliminate funded and unfunded mandates

- 1 and reporting requirements imposed on local units of government in
- 2 state law.
