SENATE BILL No. 112

January 30, 2007, Introduced by Senators BIRKHOLZ, ALLEN, HARDIMAN and GILBERT and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by adding part 364; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 PART 364. LAND USE LEADERSHIP COUNCIL

2 SEC. 36401. AS USED IN THIS PART:

- 3 (A) "COUNCIL" MEANS THE LAND USE LEADERSHIP COUNCIL CREATED IN 4 SECTION 36403.
 - (B) "DEPARTMENT" MEANS THE DEPARTMENT OF LABOR AND ECONOMIC GROWTH.
- 7 (C) "DIRECTOR" MEANS THE DIRECTOR OF THE DEPARTMENT OR HIS OR

HER DESIGNEE TO WHOM THE DIRECTOR DELEGATES A POWER OR DUTY BY

WRITTEN INSTRUMENT.

- 1 SEC. 36403. (1) THE LAND USE LEADERSHIP COUNCIL IS CREATED
- 2 WITHIN THE DEPARTMENT.
- 3 (2) THE COUNCIL SHALL HAVE 26 REGULAR MEMBERS, APPOINTED AS
- 4 FOLLOWS:
- 5 (A) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE HOUSE
- 6 MINORITY LEADER, THE SENATE MAJORITY LEADER, AND THE SENATE
- 7 MINORITY LEADER EACH MAY DESIGNATE 1 MEMBER OF THE LEGISLATURE TO
- 8 PARTICIPATE AS A MEMBER OF THE COUNCIL.
- 9 (B) FROM A LIST OF CANDIDATES RECOMMENDED BY THE SPEAKER OF
- 10 THE HOUSE OF REPRESENTATIVES AND THE SENATE MAJORITY LEADER, THE
- 11 GOVERNOR SHALL APPOINT 11 MEMBERS OF THE COUNCIL.
- 12 (C) AFTER CONSULTATION WITH THE HOUSE MINORITY LEADER AND THE
- 13 SENATE MINORITY LEADER, THE GOVERNOR SHALL APPOINT 11 ADDITIONAL
- 14 MEMBERS OF THE COUNCIL.
- 15 (3) THE DIRECTORS OF THE DEPARTMENTS OF AGRICULTURE, LABOR AND
- 16 ECONOMIC GROWTH, ENVIRONMENTAL QUALITY, HISTORY, ARTS, AND
- 17 LIBRARIES, NATURAL RESOURCES, AND TRANSPORTATION, OR THEIR
- 18 DESIGNEES, SHALL SERVE AS EX OFFICIO, NONVOTING PARTICIPANTS AT
- 19 MEETINGS OF THE COUNCIL.
- 20 (4) THE MEMBERS FIRST APPOINTED TO THE COUNCIL SHALL BE
- 21 APPOINTED WITHIN 30 DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION.
- 22 (5) A MEMBER OF THE COUNCIL SHALL SERVE AT THE PLEASURE OF THE
- 23 OFFICER WHO APPOINTED THE MEMBER.
- 24 (6) A VACANCY ON THE COUNCIL SHALL BE FILLED IN THE SAME
- 25 MANNER AS THE ORIGINAL APPOINTMENT.
- 26 SEC. 36405. (1) THE GOVERNOR SHALL DESIGNATE 2 MEMBERS OF THE
- 27 COUNCIL APPOINTED BY THE GOVERNOR AS COCHAIRPERSONS WHO SHALL SHARE

- 1 EQUALLY THE POWERS OF DIRECTING THE COUNCIL. THE COCHAIRPERSONS
- 2 SHALL SERVE AS COCHAIRPERSONS AT THE PLEASURE OF THE GOVERNOR.
- 3 (2) THE COUNCIL SHALL MEET AT THE CALL OF THE COCHAIRPERSONS
- 4 AND AS MAY BE PROVIDED IN PROCEDURES ADOPTED BY THE COUNCIL. AT THE
- 5 FIRST MEETING, THE COUNCIL SHALL ELECT FROM AMONG ITS MEMBERS OTHER
- 6 OFFICERS AS IT CONSIDERS APPROPRIATE. AFTER THE FIRST MEETING, THE
- 7 COUNCIL SHALL MEET AT LEAST QUARTERLY, OR MORE FREQUENTLY AT THE
- 8 CALL OF A CHAIRPERSON OR IF REQUESTED BY 3 OR MORE MEMBERS.
- 9 (3) A MAJORITY OF THE MEMBERS OF THE COUNCIL CONSTITUTE A
- 10 OUORUM FOR THE TRANSACTION OF BUSINESS AT A MEETING OF THE COUNCIL.
- 11 A MAJORITY OF THE MEMBERS SERVING ARE REQUIRED FOR OFFICIAL ACTION
- 12 OF THE COUNCIL.
- 13 (4) THE BUSINESS THAT THE COUNCIL MAY PERFORM SHALL BE
- 14 CONDUCTED AT A PUBLIC MEETING OF THE COUNCIL HELD IN COMPLIANCE
- 15 WITH THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 16 (5) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 17 RETAINED BY THE COUNCIL IN THE PERFORMANCE OF AN OFFICIAL FUNCTION
- 18 IS SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL
- 19 15.231 TO 15.246.
- 20 (6) THE COUNCIL MAY ADOPT PROCEDURES GOVERNING ITS
- 21 ORGANIZATION AND OPERATIONS.
- 22 (7) MEMBERS OF THE COUNCIL SHALL SERVE WITHOUT COMPENSATION.
- 23 HOWEVER, MEMBERS OF THE COUNCIL MAY BE REIMBURSED FOR THEIR ACTUAL
- 24 AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR
- 25 OFFICIAL DUTIES AS MEMBERS OF THE COUNCIL.
- 26 SEC. 36407. (1) THE COUNCIL IS AN ADVISORY BODY. THE COUNCIL
- 27 SHALL DO ALL OF THE FOLLOWING:

- 1 (A) IDENTIFY THE TRENDS, CAUSES, AND CONSEQUENCES OF UNMANAGED
- 2 GROWTH AND DEVELOPMENT.
- 3 (B) PROVIDE RECOMMENDATIONS TO THE GOVERNOR AND THE
- 4 LEGISLATURE DESIGNED TO MINIMIZE THE NEGATIVE ECONOMIC,
- 5 ENVIRONMENTAL, AND SOCIAL IMPACTS OF CURRENT LAND USE TRENDS;
- 6 PROMOTE URBAN REVITALIZATION AND REINVESTMENT; FOSTER
- 7 INTERGOVERNMENTAL AND PUBLIC-PRIVATE LAND USE PARTNERSHIPS;
- 8 IDENTIFY NEW GROWTH AND DEVELOPMENT OPPORTUNITIES; PROTECT THE
- 9 NATURAL RESOURCES OF THIS STATE, INCLUDING FARMLAND AND OPEN SPACE;
- 10 AND BETTER MANAGE THE COST OF PUBLIC INVESTMENTS IN INFRASTRUCTURE
- 11 TO SUPPORT GROWTH.
- 12 (2) IN EXERCISING ITS DUTIES, THE COUNCIL MAY DO ANY OF THE
- 13 FOLLOWING:
- 14 (A) EVALUATE THE EFFECTIVENESS OF CURRENT STATE, REGIONAL, AND
- 15 LOCAL LAND USE LAWS, INCLUDING, BUT NOT LIMITED TO, ZONING AND
- 16 PLANNING LAWS, HOUSING LAWS, BUILDING CODES, AND ANNEXATION LAWS.
- 17 (B) SURVEY DEVELOPERS, BUILDERS, CONTRACTORS, FARMERS,
- 18 PLANNERS, ENGINEERS, SURVEYORS, ENVIRONMENTALISTS, HISTORIC
- 19 PRESERVATIONISTS, ATTORNEYS, ACADEMICS, CITIZEN GROUPS, AND OTHERS
- 20 IN THE PRIVATE SECTOR; STATE AGENCIES; AND LOCAL GOVERNMENTAL
- 21 AGENCIES ABOUT PROBLEMS ASSOCIATED WITH CURRENT LAND USE TRENDS AND
- 22 CURRENT POLICIES AND SUGGESTED POLICY CHANGES.
- 23 (C) STIMULATE STATEWIDE DISCUSSION ON PROBLEMS RELATED TO
- 24 CURRENT LAND USE TRENDS, IDENTIFYING BEST DEVELOPMENT PRACTICES AND
- 25 ALTERNATIVE LAND USE AND CAPITAL INVESTMENT SOLUTIONS.
- 26 (D) REVIEW MODEL LEGISLATION AND STUDIES ON LAND USE
- 27 TECHNIQUES AND COLLECT INFORMATION ON STATES THAT HAVE DEVELOPED

- 1 INNOVATIVE SOLUTIONS TO SIMILAR LAND USE CHALLENGES.
- 2 (E) IDENTIFY ANY STATE PROGRAMS OR REGULATIONS THAT DIRECTLY
- 3 OR INDIRECTLY ENCOURAGE OR SUBSIDIZE LOW-DENSITY DEVELOPMENT AND
- 4 OUTWARD MIGRATION FROM URBAN AREAS.
- 5 (F) IDENTIFY PUBLIC INFORMATION, TRAINING, AND TECHNICAL
- 6 ASSISTANCE RELATED TO LAND USE NEEDED BY STATE, REGIONAL, AND LOCAL
- 7 AGENCIES.
- 8 (G) IDENTIFY INCENTIVES OR TECHNIQUES FOR SHARING THE BENEFITS
- 9 OF ECONOMIC GROWTH AND ELIMINATING OR REDUCING FISCAL COMPETITION
- 10 AMONG LOCAL UNITS OF GOVERNMENT AND FOR FOSTERING INTERGOVERNMENTAL
- 11 COOPERATION.
- 12 (H) PROPOSE INNOVATIVE AND COOPERATIVE LAND USE APPROACHES
- 13 THAT WILL DO 1 OR MORE OF THE FOLLOWING:
- 14 (i) ACCOMMODATE AND GUIDE GROWTH AND DEVELOPMENT THROUGH
- 15 COOPERATION AND PARTNERSHIPS ON A LOCAL AND REGIONAL BASIS.
- 16 (ii) ENSURE THE CONSTRUCTION OF ADEQUATE SUPPORTING SERVICES
- 17 AND INFRASTRUCTURE, INCLUDING UTILITIES, STORM WATER MANAGEMENT
- 18 SYSTEMS, AND TRANSPORTATION.
- 19 (iii) PROVIDE OPPORTUNITIES FOR OR ELIMINATE BARRIERS TO
- 20 AFFORDABLE HOUSING.
- 21 (iv) PROTECT THE ENVIRONMENT AND HISTORIC AND SCENIC RESOURCES.
- 22 (v) ENHANCE COMMUNITY LIVABILITY.
- 23 (vi) PRESERVE FARMLAND.
- 24 (vii) MINIMIZE NEGATIVE IMPACTS ON NATURAL RESOURCES.
- 25 (I) MAKE INQUIRIES, STUDIES, AND INVESTIGATIONS, HOLD
- 26 HEARINGS, RECEIVE COMMENTS FROM THE PUBLIC, AND CONSULT WITH
- 27 OUTSIDE EXPERTS.

- 1 (3) THE COUNCIL SHALL ISSUE AN ANNUAL REPORT AND
- 2 RECOMMENDATIONS, INCLUDING ANY PROPOSED LEGISLATION, TO THE
- 3 GOVERNOR, THE CLERK OF THE HOUSE OF REPRESENTATIVES, AND THE
- 4 SECRETARY OF THE SENATE.
- 5 SEC. 36409. (1) THE COUNCIL SHALL BE STAFFED BY PERSONNEL
- 6 WITHIN THE DEPARTMENT, AS DESIGNATED BY THE DIRECTOR. THE DIRECTORS
- 7 OF THE DEPARTMENTS OF AGRICULTURE, ENVIRONMENTAL QUALITY, HISTORY,
- 8 ARTS, AND LIBRARIES, NATURAL RESOURCES, AND TRANSPORTATION SHALL
- 9 PROVIDE PERSONNEL ASSISTANCE TO THE COUNCIL AT THE REQUEST OF THE
- 10 DIRECTOR.
- 11 (2) THE COCHAIRPERSONS SHALL APPOINT AN EXECUTIVE COORDINATOR
- 12 FOR THE COUNCIL.
- 13 (3) THE COUNCIL MAY HIRE OR RETAIN SUCH CONTRACTORS,
- 14 SUBCONTRACTORS, ADVISORS, CONSULTANTS, AND AGENTS AND MAY ENTER
- 15 INTO CONTRACTS NECESSARY OR INCIDENTAL TO THE EXERCISE OF THE
- 16 POWERS OF THE COUNCIL AND THE PERFORMANCE OF ITS DUTIES AS THE
- 17 DIRECTOR CONSIDERS ADVISABLE, IN ACCORDANCE WITH THE RELEVANT
- 18 STATUTES, RULES, AND PROCEDURES OF THE CIVIL SERVICE COMMISSION AND
- 19 THE DEPARTMENT OF MANAGEMENT AND BUDGET.
- 20 (4) THE COUNCIL MAY ACCEPT DONATIONS OF LABOR, SERVICES, OR
- 21 OTHER THINGS OF VALUE FROM ANY PUBLIC OR PRIVATE AGENCY OR PERSON.
- 22 (5) MEMBERS OF THE COUNCIL APPOINTED BY THE GOVERNOR SHALL
- 23 REFER ALL LEGAL, LEGISLATIVE, AND MEDIA CONTACTS TO THE DEPARTMENT.
- 24 SEC. 36411. IF REQUESTED, ANY OFFICER OR AGENCY OF THIS STATE
- 25 OR OF ANY POLITICAL SUBDIVISION OF THIS STATE SHALL GIVE TO THE
- 26 COUNCIL, OR ANY MEMBER OR REPRESENTATIVE OF THE COUNCIL, BOTH OF
- 27 THE FOLLOWING:

- 1 (A) ANY NECESSARY ASSISTANCE REQUIRED BY THE COUNCIL, OR ANY
- 2 MEMBER OR REPRESENTATIVE OF THE COUNCIL, IN THE PERFORMANCE OF THE
- 3 DUTIES OF THE COUNCIL SO FAR AS IS COMPATIBLE WITH THE DUTIES OF
- 4 THE OFFICER OR AGENCY.
- 5 (B) FREE ACCESS TO ANY BOOKS, RECORDS, OR DOCUMENTS IN THE
- 6 CUSTODY OF THE OFFICER OR AGENCY, RELATING TO MATTERS WITHIN THE
- 7 SCOPE OF POWERS OR DUTIES OF THE COUNCIL.
- 8 SEC. 36413. THIS PART IS REPEALED EFFECTIVE 5 YEARS AFTER THE
- 9 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS PART.
