A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 136b (MCL 750.136b), as amended by 1999 PA 273.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 136b. (1) As used in this section:

- 15 capacity to recognize reality, or ability to cope with the ordinary

- 17 (2) A person is guilty of child abuse in the first degree if

- 24 serious mental harm to a child or if the person's reckless act

- 15 (7) (6) A person is guilty of child abuse in the fourth degree
- 16 if the EITHER OF THE FOLLOWING APPLIES:
- 17 (A) THE person's omission or reckless act causes physical harm
- 18 to a child.
- 19 (B) THE PERSON KNOWINGLY OR INTENTIONALLY COMMITS AN ACT
- 20 LIKELY TO CAUSE PHYSICAL HARM TO A CHILD, REGARDLESS OF WHETHER
- 21 PHYSICAL HARM RESULTS.
- 22 (8) Child abuse in the fourth degree is a misdemeanor
- 23 punishable by imprisonment for not more than 1 year.
- 24 (9) (7) This section does not prohibit a parent or guardian,
- 25 or other person permitted by law or authorized by the parent or
- 26 guardian, from taking steps to reasonably discipline a child,
- 27 including the use of reasonable force.
