A bill to amend 1998 PA 386, entitled "Estates and protected individuals code," by amending section 3805 (MCL 700.3805), as amended by 2000 PA 177.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3805. (1) If the applicable estate property is 2 insufficient to pay all claims and allowances in full, the personal 3 representative shall make payment in the following order of 4 priority: 5
  - (a) Costs and expenses of administration.
  - (b) Reasonable funeral and burial expenses.
  - (c) Homestead allowance.
  - (d) Family allowance.
  - (e) Exempt property.

- 19 nonprobate transfers that may be liable for claims and allowances,
- 20 then, unless the will provides otherwise, the personal
- 21 representative shall proceed to collect the deficiency in a manner
- 22 reasonable under the circumstances so that each nonprobate
- 23 transfer, including those made under a trust described in section
- 24 7501(1), bears a proportionate share or equitable share of the
