## **SENATE BILL No. 592**

June 19, 2007, Introduced by Senators OLSHOVE, BARCIA, JANSEN, JACOBS, PAPPAGEORGE, HARDIMAN and BIRKHOLZ and referred to the Committee on Families and Human Services.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 2832 (MCL 333.2832), as amended by 1996 PA 307, and by adding section 2832a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2832. (1) When a new certificate of live birth is
- 2 established, the actual place and date of birth shall be shown. The
- 3 new certificate shall be substituted for the original certificate
- 4 of live birth. Thereafter, the original certificate and the
- 5 evidence of adoption or sex designation are not subject to
- 6 inspection except as otherwise provided in section 2832A OR 2882(2)
- 7 or (3) or upon a court order. Evidence in support of other birth
- record changes is subject to inspection as provided in sections
- 9 2882 and 2883.

- 1 (2) Upon receipt of notice of annulment of adoption or a copy
- 2 of an order of rescission, the original certificate of live birth
- 3 shall be restored to its place in the files. The certificate

- 13 FILE UNTIL ISSUED AS PROVIDED IN THIS SUBSECTION. IF A CERTIFIED
- 14 COPY OF AN ADOPTED INDIVIDUAL'S ORIGINAL CERTIFICATE OF LIVE BIRTH
- 15 IS ISSUED UNDER SUBSECTION (1), THE STATE REGISTRAR SHALL ALSO

- 17 FORMS IN THE FILE AT THE TIME OF ISSUANCE. THE DEPARTMENT SHALL

- 25 (C) I PREFER NOT TO BE CONTACTED AT THIS TIME. IF I DECIDE
- 26 LATER THAT I WOULD LIKE TO BE CONTACTED, I WILL REGISTER WITH THE
- 27 CENTRAL ADOPTION REGISTRY ESTABLISHED UNDER SECTION 27B OF CHAPTER
