## **SENATE BILL No. 667**

August 1, 2007, Introduced by Senators BROWN, JANSEN and McMANUS and referred to the Committee on Judiciary.

A bill to amend 1846 RS 83, entitled "Of marriage and the solemnization thereof," by amending section 7 (MCL 551.7), as amended by 2006 PA 613.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) Marriages may be solemnized by any of the
- 2 following:
- 3 (a) A judge of the district court, in the district in which4 the judge is serving.
  - (b) A district court magistrate, in the district in which the magistrate serves.
- (c) A municipal judge, in the city in which the judge is serving or in a township over which a municipal court has

- 3 (d) A judge of probate, in the county or probate court

- 9 or, in a county having more than 2,000,000 inhabitants, an employee

- 27 (3) If a mayor of a city solemnizes a marriage, the mayor

- 4 (4) If the county clerk or, in a county having more than

- 6 by the county clerk solemnizes a marriage, the county clerk shall
- 7 charge and collect a fee to be determined by the commissioners of
- 8 that county, which shall be paid to the county treasurer and
- 9 deposited in the general fund of the county at the end of the
- 10 month.
