November 6, 2007, Introduced by Senators McMANUS, ALLEN, VAN WOERKOM, PRUSI, BARCIA and GLEASON and referred to the Committee on Finance.

A bill to amend 1933 PA 167, entitled "General sales tax act,"

by amending section 4u (MCL 205.54u), as amended by 2004 PA 173.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 4u. (1) A sale of tangible personal property to an
 extractive operator for use or consumption in extractive operations
 is exempt from the tax under this act.
 - (2) The property under subsection (1) is exempt only to the extent that the property is used for the exempt purposes stated in this section. The exemption is limited to the percentage of exempt use to total use determined by a reasonable formula or method approved by the department.
 - (3) Extractive operations include the actual production of oil, gas, brine, or other natural resources. Property eligible for the exemption includes the following:
 - (a) Casing pipe or drive pipe.

- 3 VEHICLE OR OTHER EQUIPMENT THAT WILL REMOVE THE TIMBER FROM THE
- 4 EXTRACTION SITE.
- 5 (b) An extractive operator is a person who, either directly or
- 6 by contract, performs extractive operations.
