- 1 SEC. 7NN. (1) THE GOVERNING BODY OF A LOCAL TAX COLLECTING
- 2 UNIT MAY ADOPT A RESOLUTION TO EXEMPT FROM THE COLLECTION OF TAXES
- 3 UNDER THIS ACT ALL PROPERTY OF A QUALIFIED DISABLED VETERAN.

- 5 (A) "FEDERAL POVERTY LEVEL" MEANS THE POVERTY GUIDELINES
- 6 PUBLISHED ANNUALLY IN THE FEDERAL REGISTER BY THE UNITED STATES
- 7 DEPARTMENT OF HEALTH AND HUMAN SERVICES UNDER ITS AUTHORITY TO

- 12 DISCHARGED OR RELEASED FROM HIS OR HER SERVICE WITH AN HONORABLE OR
