SENATE BILL No. 1162

March 4, 2008, Introduced by Senators GARCIA, PAPPAGEORGE, CROPSEY, HARDIMAN and OLSHOVE and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 811e (MCL 257.811e), as amended by 2006 PA 562 and by adding section 811r.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 811e. (1) Beginning January 1, 2007, the THE secretary of state may develop a fund-raising plate as provided in this section.

(2) A start-up fee of \$15,000.00 shall be paid for any new fund-raising plate authorized under this section, which fee shall be deposited in the transportation administration collection fund to be used for the cost of creating, producing, and issuing fund-raising plates. If the fee described in this subsection is not paid within 18 months of—AFTER the effective date of the public act that authorizes the development and issuance of a fund-raising plate,

- 27 EXPENDITURES DURING THE PRECEDING YEAR OF THE MONEY RECEIVED UNDER
