THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 125. (1) THE DIRECTOR MAY AUTHORIZE A PERSON ENGAGED IN
- 2 THE PRODUCTION OF A FILM IN THIS STATE TO USE WITHOUT CHARGE
- 3 PROPERTY OWNED OR UNDER THE CONTROL OF THE DEPARTMENT OR A STATE
- 4 AGENCY FOR THE PURPOSE OF PRODUCING A FILM UNDER TERMS AND
- 5 CONDITIONS ESTABLISHED BY THE DIRECTOR. THE ECONOMIC AND OTHER
- 6 BENEFITS TO THIS STATE OF FILM PRODUCTION LOCATED IN THIS STATE
- 7 SHALL BE CONSIDERED TO BE THE VALUE RECEIVED BY THE DEPARTMENT IN
- 8 EXCHANGE FOR THE USE OF PROPERTY UNDER THIS SECTION.
 - (2) THE DIRECTOR SHALL NOT AUTHORIZE THE USE OF PROPERTY OWNED
