SENATE BILL No. 1357

May 28, 2008, Introduced by Senators CHERRY, SCHAUER, JACOBS, SWITALSKI, CLARKE, CLARK-COLEMAN, WHITMER, PRUSI, BRATER, SCOTT and THOMAS and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code," by amending sections 17751 and 17763 (MCL 333.17751 and 333.17763), as amended by 2006 PA 672.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 17751. (1) A pharmacist shall not dispense a drug requiring a prescription under the federal act or a law of this state except under authority of an original prescription or an equivalent record of an original prescription approved by the board.

(2) A pharmacist may dispense a prescription written and signed or transmitted by facsimile, electronic transmission, or other means of communication by a physician prescriber in a state other than Michigan, but not including a prescription for a
