## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 703. (1) THE CAPITOL PUBLIC IMPROVEMENT FUND IS CREATED
- 2 WITHIN THE LEGISLATIVE COUNCIL.
- 3 (2) THE STATE TREASURER MAY RECEIVE MONEY FROM ANY SOURCE FOR
- 4 DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL CREDIT TO THE FUND
- 5 ALL MONEY RECEIVED UNDER SECTION 442(2) OF THE MANAGEMENT AND
- 6 BUDGET ACT, 1984 PA 431, MCL 18.1442. THE STATE TREASURER SHALL
- 7 DIRECT THE INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT
- 8 TO THE FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS.
- 9 (3) MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR SHALL
- 0 REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.

- 1 (4) THE MICHIGAN CAPITOL COMMITTEE SHALL EXPEND MONEY FROM THE
