THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7457. Sections 7451 to 7455 do not apply to any of the following:
 - (a) An object sold or offered for sale to a person licensed under article 15 or under the occupational code, 1980 PA 299, MCL 339.101 to 339.2721—339.2919, or any intern, trainee, apprentice, or assistant in a profession licensed under article 15 or under the occupational code, 1980 PA 299, MCL 339.101 to 339.2721—339.2919,

- 1 for use in that profession.
- 2 (b) An object sold or offered for sale to any hospital,
- 3 sanitarium, clinical laboratory, or other health care institution
- 4 including a penal, correctional, or juvenile detention facility for

- 12 SERVICE AUTHORIZED, PROVIDED, OR ASSISTED UNDER ARTICLE 6 AND WHO
- 13 IS ACTING IN THE NORMAL LEGAL COURSE OF PROVIDING THOSE SERVICES.
