OVERVIEW

As passed by the House on November 4, 2009, House Bill 5394 contained adjustments to the initial FY 2009-10 budget for the Department of Community Health. Those adjustments were later rolled into House Bill 4311, which was signed into law as Public Act 140 of 2009, and are not reflected in this document.

As passed by the Senate, House Bill 5394 contained FY 2009-10 supplemental appropriation for the Department of Education totaling \$492,800 GF/GP, as described below. Note that the Part 1 totals in the bill of \$16.9 million Gross and \$11.3 million GF/GP were largely offset by the repeal of the existing FY 2009-10 Library of Michigan appropriations unit contained in section 1001. Additionally, a boilerplate section for the Department of Transportation budget was included.

The Senate-passed version of the bill was concurred to by the House and sent to the Governor. The Governor vetoed the line items, boilerplate language, and the repealer related to the Library of Michigan, meaning that the enacted version of the bill has no effective impact on Library of Michigan funding or operations.

The current year appropriation of \$29.8 million for Comprehensive Transportation Fund debt service was based on anticipated debt service. Subsequent to budget development, the department refinanced CTF bonds resulting in a \$12.8 million debt service savings. Rather than reducing the debt service appropriation, the debt service savings would be transferred to a bond proceeds account for subsequent expenditure on public transportation capital projects as authorized by the State Transportation Commission. This treatment is required by IRS regulations governing tax-free bonds, and would be authorized by the proposed boilerplate section. (2/11/10 SBO letter)
