SUBSTITUTE FOR HOUSE BILL NO. 4556

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 675d (MCL 257.675d), as amended by 2008 PA 171.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 675d. (1) Except as provided in subsection (2), a law
- 2 enforcement agency or a local unit of government may implement and
- 3 administer a program to authorize and utilize persons other than
- 4 police officers as volunteers to issue citations for the following
- 5 violations:
- 6 (a) Parking on a sidewalk in violation of section 674(1)(a) or
- 7 a local ordinance substantially corresponding to section 674(1)(a).
- 8 (b) Parking in front of a public or private driveway in
- 9 violation of section 674(1)(b) or a local ordinance substantially

- 1 corresponding to section 674(1)(b).
- 2 (c) Parking within 15 feet of a fire hydrant in violation of
- 3 section 674(1)(d) or a local ordinance substantially corresponding
- 4 to section 674(1)(d).
- 5 (d) Parking on a crosswalk in violation of section 674(1)(e)
- 6 or a local ordinance substantially corresponding to section
- **7** 674(1)(e).
- 8 (e) Parking within 20 feet of a crosswalk or, if there is not
- 9 a crosswalk, within 15 feet of the intersection of property lines
- 10 at an intersection of highways, in violation of section 674(1)(f)
- 11 or a local ordinance substantially corresponding to section
- **12** 674(1)(f).
- 13 (f) Parking at a place where an official sign prohibits
- 14 stopping or parking in violation of section 674(1)(n) or a local
- ordinance substantially corresponding to section 674(1)(n). This
- 16 subdivision does not authorize a volunteer to issue a citation for
- 17 any other violation set forth in section 674 or a local ordinance
- 18 substantially corresponding to section 674.
- 19 (g) Parking in a space reserved for use by disabled persons in
- 20 violation of section 674(1)(s) or a local ordinance substantially
- 21 corresponding to section 674(1)(s).
- 22 (h) Parking in an access aisle or access lane immediately
- 23 adjacent to a space designated for parking by persons with
- 24 disabilities in violation of section 674(1)(t) or a local ordinance
- 25 substantially corresponding to section 674(1)(t).
- 26 (i) Parking in violation of an official sign restricting the
- 27 period of time for or manner of parking in violation of section

- 1 674(1)(w) or a local ordinance substantially corresponding to
- 2 section 674(1)(w). This subdivision does not authorize a volunteer
- 3 to issue a citation for any other violation set forth in section
- 4 674 or a local ordinance substantially corresponding to section
- **5** 674.
- 6 (j) Parking in a space or in a manner that blocks access to a
- 7 fire lane in violation of section 674(1)(aa) or a local ordinance
- 8 substantially corresponding to section 674(1)(aa).
- 9 (2) Before authorizing and utilizing persons other than police
- 10 officers to issue citations, the law enforcement agency or local
- 11 unit of government shall implement a program to train the persons
- 12 to properly issue citations as provided in this section, . The
- 13 program shall contain at least 40 hours of instruction OF WHICH NOT
- 14 LESS THAN 8 HOURS SHALL BE in parking enforcement, conducted by
- 15 that law enforcement agency or the law enforcement agency for that
- 16 local unit of government or, if the local unit of government does
- 17 not have a law enforcement agency, by the county sheriff. A person
- 18 who successfully completes a program of training implemented
- 19 pursuant to UNDER this section may issue citations as provided in
- 20 this section as authorized by the law enforcement agency or local
- 21 unit of government. A law enforcement agency of a local unit of
- 22 government shall not implement or administer a program under this
- 23 section without the specific authorization of the governing body of
- 24 that local unit of government. A law enforcement agency shall not
- 25 implement or administer a program under this section that would
- 26 allow volunteers to issue citations under subsection (1)(a), (b),
- 27 (c), (d), (e), (f), or (i) for any violations for which the use of

- 1 volunteers is prohibited under a collective bargaining agreement
- 2 between that local unit of government and any law enforcement
- 3 officers of that local unit of government.
- 4 (3) As used in this section:
- 5 (a) "Law enforcement agency" means any of the following:
- 6 (i) A police agency of a city, village, or township.
- 7 (ii) A sheriff's department.
- 8 (iii) The department of state police.
- 9 (iv) Any other governmental law enforcement agency in this
- 10 state.
- 11 (b) "Local unit of government" means a state university or
- 12 college or a county, city, village, or township.
