THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH:
- 6 (A) INSTALLS OR PLACES A TRACKING DEVICE, OR CAUSES A TRACKING

- 12 (E) THE INSTALLATION OR USE OF ANY DEVICE OR SERVICE THAT
- 13 PROVIDES THE LESSEE OF THE VEHICLE WITH CLEAR NOTICE THAT THE
- 14 VEHICLE MAY BE TRACKED. FOR A LESSOR WHO INSTALLS A TRACKING DEVICE
- 15 SUBSEQUENT TO THE ORIGINAL VEHICLE MANUFACTURE, THE NOTICE SHALL BE
- 16 PROVIDED IN WRITING WITH AN ACKNOWLEDGMENT SIGNED BY THE LESSEE,
- 17 REGARDLESS OF WHETHER THE TRACKING DEVICE IS ORIGINAL EQUIPMENT, A
- 18 RETROFIT, OR AN AFTERMARKET PRODUCT. THE REQUIREMENT FOR WRITTEN
